On or about January 11, 1995, the Board attempted to serve a Notice stating that the board intended to suspend the professional counselor license of Andrea D. Thompson by certified mail addressed to the last known address filed by the licensee with the Board. The notice alleged that licensee failed to present a corrected, updated professional disclosure statement to the Board for approval. The Notice further granted the licensee an opportunity for hearing, setting the time and place as 10:45 am, February 24, 1995 in the first floor conference room of the Morrow Crane Building, 3218 Pringle Road SE in Salem, Oregon. Neither the licensee nor an attorney representing the licensee appeared before the board at the scheduled time and place.

NOW THEREFORE, after consideration of the records and files of the board relating to this matter, the board enters the following Order.

FINDINGS OF FACT

1. Andrea D. Thompson holds professional counselor license number C0358.
2. On or about July 1, 1994, the board mailed a notice to all licensees of the new address of the board and instructing all licensees to update their professional disclosure statements to correct the board's address and submit a copy for approval and filing.
3. On or about October 10, 1994, the board mailed a second notice addressed to licensee notifying licensee that a form had not been filed and granting 15 days to take corrective action to avoid violating state regulations.
4. An updated professional disclosure statement was not received by the board.

ULTIMATE FINDINGS OF FACT


Andrea D. Thompson did not make a necessary change to her professional disclosure statement and present it to the board for approval.

CONCLUSIONS OF LAW

Andrea D. Thompson's failure to correct her disclosure statement to include true address of the board is a violation of ORS 675.755(5), OAR 833-50-010, and 833-50-020 and is punishable by suspension under ORS 675.745(1)(e).

ORDER

The professional counselor license of Andrea D. Thompson is suspended and no longer considered valid under ORS 675.825. She may no longer purport to practice under the title "licensed professional counselor".
