1.

The Board of Naturopathic Examiners (Board) is the state agency responsible for licensing, regulating and disciplining naturopathic physicians in the State of Oregon. At all relevant times, Shandor Weiss, N.D., (Weiss) has been a licensed naturopathic physician subject to the jurisdiction of the Board.

2.

The Board conducted an investigation based on a complaint received in regards to Licensee. Based on the results of the investigation, the Board issued to Weiss a Notice of Intent to Discipline, which was subsequently amended, and an Emergency Suspension Order. The Second Amended Notice of Intent to Discipline (Notice), issued June 24, 2009, is incorporated herein by reference.

3.

The Board considers Weiss's conduct with respect to Patient A to be grounds for license revocation under ORS 685.110(8) or ORS 685.110(13). Weiss acknowledges this and stipulates that if the case were to proceed to hearing the Board would present evidence that his care and treatment of patients as set forth in the Notice constitutes violations of: ORS 685.110(8) ORS 685.110(10), ORS 685.110(13), ORS 685.110(14), ORS 685.110(15), ORS 685.110(22), OAR 850-050-0010(1)(c)(B), OAR 850-050-

0010(1)(c)(C), OAR 850-050-0010(1)(c)(D), OAR 850-050-0190(3), OAR 850-050-0190(7), OAR 850-050-0190(10) and OAR 850-060-0215(3).

4.

The parties desire to settle this matter by entering into this Stipulation for Voluntary Surrender of License in Lieu of Revocation, pursuant to ORS 183.417(3).

5.

Weiss acknowledges, understands, and agrees to the following:

- a. Weiss surrenders his license as a naturopathic physician. This voluntary surrender in lieu of revocation is subject to and conditioned upon acceptance by the Board. The surrender will be effective as of the date the Board signs the order below.
- b. In the event that Weiss applies for licensure with the Board in the future, the Board may as part of any review, consideration, or decision on the application, consider his conduct in this matter in addition to any other information obtained as part of the application process. This Stipulation does not in any way restrict or limit the Board as part of its review, consideration, and decision on any application submitted by Weiss.
- c. Upon the date the Board signs the order below, as provided in ORS 685.020(2), Weiss shall be prohibited from using the title of, or purporting to be, a naturopathic physician, N.D., naturopath, or Doctor of Naturopathy, or using any other title that includes those words.
- d. Upon the date the Board signs the order below, Weiss shall not engage in the practice of "naturopathic medicine", as defined in ORS 685.010, in the State of Oregon without being appropriately licensed with the Board.
- e. This Stipulation is a public document.

f. Any violation of this Stipulation is grounds for further action against Weiss. The Board has the right to take action against Weiss to enforce this Stipulation, or for other violations of ORS Chapter 685 or OAR Chapter 850 that are not referenced in the Second Amended Notice of Intent to Discipline.

6.

Weiss has fully read and understands this Stipulation. Weiss has consulted with an attorney and has been fully advised in regards thereto.

7.

Weiss enters into this Stipulation and consents to issuance of the order below voluntarily and without any force or duress. Weiss acknowledges that no promises or representation not stated herein have been made to induce Weiss to sign this Stipulation.

8.

Weiss understands that he has the right to a contested case hearing under the Administrative Procedures Act (ORS Chapter 183), and fully and finally waives any and all right to a hearing and any rights to appeal or otherwise challenge this Stipulation.

It is so Stipulated.

It is hereby ORDERED that:


1. The Stipulation for Voluntary Surrender of License in Lieu of Revocation is accepted by the Board;
