The general purpose of Board Meetings is to discuss and adopt Board policies and procedures, discuss possible administrative rule changes, adopt administrative rules, discuss other administrative matters, and take action on complaints and other investigatory matters.

**Note:** Upon opening the Public Meeting, the Board will immediately close the Public Session for an Executive Session for the purpose of considering information that is exempt by law from public inspection and for consulting with counsel concerning the legal rights and duties of the agency. During Executive Session, the Board will consider consumer and board-initiated complaints and investigations as authorized by ORS 192.660(2)(f) and (l); and consult with legal counsel as authorized by ORS 192.660(2)(l). No official Board action will be taken in Executive Session. All Board actions will be made in Public Session, as outlined in ORS 192.610 - 192.630. At the end of the Executive Session the Board will return to the Public Session and welcome the public back into the room. Public Session is estimated to begin at 12:30 pm.
