## XIV. STATISTICS

### 1) Licensure

22 new applications have been received and 15 licenses have been issued in 2015. There are currently 163 active applicants (including 76 practicing residents), and 1786 licensees: 1409 active, 203 semi-active, 172 inactive, and 2 suspended.

### 2) Consumer Protection

18 complaints have been filed in 2015. There are currently 39 open cases under investigation (including the investigation files scheduled for Board consideration): 28 licensees, 4 applicants, and 7 unlicensed practice cases. There are 4 contested cases in process, and 2 cases on appeal.
