Wednesday, June 14, 2023

Agenda Item 01 – Welcome and Introductions

Approval of minutes

Draft minutes from the February 21-23, 2023, board meeting was presented for review and approval.

Acting Director's report

Acting Director Henderson reported the ODA continues to monitor the status of the agency budget as it gets close to the end of session. If necessary, the Legislature has the option to approve a continuing resolution to keep agencies operating after June 30. Recruitment is underway to fill the agency Chief Information Manager position, previously held by Steve Poland who retired last month, and other vacant positions in the agency. We continue to work on succession planning in the agency as we have limited back-up in some key positions. An all ODA-staff meeting will be held later this month and include a tour of the seed industry in the Silverton Hills. The ODA has been allocated approximately \$5.9 million from USDA in support the Resilient Food Systems Infrastructure Program (RFSI). This program is intended to build resilience in the middle-of-the-supply chain for local and regional produced food products. Each state will plan, propose, and make subawards in the form of infrastructure grants. More to come on this new grant program at future meetings. The ODA Director recruitment is moving forward, and the recruitment firm is currently scheduling first round interviews. The hope is to have a selection and confirmation during the September Legislative Days.

Agenda Item 02 - ODA's Budget and Legislative Update

Assistant Director Jonathan Sandau reported the Legislature is on track for a June 25 Sine Die end of session. We continue to monitor the agency budget bill and other policy bills including SB 85 related to CAFO's, HB 2010 drought package and HB 3409 related to energy and climate. We are also monitoring for end of session spending bills and any impacts on ODA. He also reported

the June revenue forecast looks strong. Sandau distributed and highlighted some of the items in the ODA 2023-25 Legislative Fiscal (LFO) budget summary. Acting Director Henderson reported we will need to go to the Emergency Board to request limitation to spend the \$5.9 million in USDA, RFSI funding allocated to ODA. We continue to move forward with planning to move ODA labs to the Wilsonville North Valley Complex later this year and have plans in place to limit any disruption of services.

Agenda Item 05 – Organic Industry Update

Oregon Tilth Executive Director Chris Schreiner provided information to the board on the organic industry. He gave an overview of Oregon Tilth's mission and size and scope of the certification services they provide. Currently they have about 100+ team members and are working with approximately 3000 operations. He gave a snapshot of the US organic food sales and the food market categories for organic food products. Statistics show that 45% of the organic customer base are under 40 years of age. 2021 statistics showed Oregon has 893 organic businesses with organic commodity sales totaling \$368 million. reported 490,355 certified organic acres and milk, blueberries, and hay are the top organic commodities in Oregon. Mr. Schreiner also spoke about the innovative partnerships in organic agriculture and the collaboration with the Oregon Department of Agriculture.

The project included building an on-farm program in local school, designing farm field trips, providing technical assistance for farmers about farm to school programs, increase market opportunities for local farms, and increase capacity of the Umpqua Valley Farm to School program to sustain future programming.

Agenda Item 07 - Cow Creek Band of Umpqua Tribe of Indians and the Umpqua Indian Development Corporation

Kelly Coates, Tribes Director of Natural Resources and Nathan Jackson, Senior Director Corporate Services presented to the board and shared the history and background of the Cow Creek Band of Umpqua Tribe of Indians, information on the work done in the natural resources department and the land management work.

The Cow Creek Band of the Umpqua Tribe of Indians is one of nine federally recognized Sovereign Indian Tribal Governments in the state of Oregon. The Ancestral Territory/Interest Area is approximately 6.5 million acres. Tribal Managed Acres totals 37,215.6 acres. The Natural Resources Department was formed in 2011 and is one of three Departments along with Forestry and Real-estate services. They also manage all lands in partnership with other departments and Tribal businesses. Consultation is used to communicate about natural resources, science, and culture and maintain Government to Government relationships with federal and state agencies.

Agenda Item 08 – Oregon Meat Initiative

Jess Paulson, ODA Market Access and Certification Program Area Director and Rusty Rock, ODA Food Safety and Animal Health Program Area Director provided an update to the board on the Oregon Meat Initiative. The presentation provided information on the Meat Processing Infrastructure and Capacity Building Grant Program. The grant program applications identified access to processing as one of the greatest business challenges to growing your business, other hurdles included access to financing, slaughter, value-added processing, refrigeration, new markets, and waste disposal. Grants were awarded to six firms located across the state for a total of \$2 million dollars. All projects are on track for completion and final reports will be compiled. The 2023 Oregon Legislature is considering additional fund for the Oregon Meat Initiative with House Bill 3410. Rusty Rock updated the board on the State Meat Inspection Program and shared the program has two facilities under active inspection and 11 operations in various phases of coming under state inspection.
