#### **2024 Commodity Commission Recruitment**

The Oregon Department of Agriculture (ODA) is seeking volunteers to fill 66 openings on 22 of the state's agricultural and commercial fisheries commodity commissions. The deadline to apply is March 15<sup>th</sup>, 2024.

The ODA Director appoints commissioners whose duties include making decisions about funding for promotion, education, and research projects. The ODA is looking for applicants representing the diversity of Oregon's farmers, ranchers, processors, and commercial fisheries; and public members with interest and the time to serve.

#### **HOW TO APPLY**

- Complete an application and email it to <u>commissions@oda.oregon.gov</u> by March 15<sup>th</sup>, 2024.
- Application forms and additional information are available at <u>oda.direct/commissions</u>.
- For producer and handler positions, enter the position number or numbers of interest and eligibility on your application. Refer to the tables below for additional qualifications.
- Respond to all applicable fields, and sign and date the form before submitting it.
- Please be careful not to lock the form.
- We cannot accept applications that are not readable, do not have a producer or handler position number, or do not have a signature. Please do not send photos of an application.

#### **QUALIFICATIONS**

Applicants must meet specific criteria to qualify for consideration. Four general qualifications apply to each commodity commission:

- US citizenship,
- Oregon residency,
- Paid or collected the assessment for the preceding three years, and
- Have an active interest in the positive development and economic growth of the commodity industry in Oregon.

Several commissions require applicants from a specific geographic region. This requirement is noted in the commission listing next to the position.

#### **PUBLIC MEMBERS**

Public member applicants cannot be solely associated with producing or handling the commodity. Like other applicants, they must be U.S. citizens, Oregon residents, and have an active interest in the positive economic development of the commodity. (Each commission has one public member.)
