Re: Registration to the Water Pollution Control Facilities (WPCF) General Permit No. 01-2015 for ATR#995343.

Dear Mr. Simon:

The Oregon Department of Agriculture (department) has completed the public noticing and Hearing for your proposed permit registration for your poultry operation located at 37225 Jefferson-Scio Dr. in Scio, Oregon to the WPCF, CAFO General Permit No. 01-2015. The public participation period ended at 5 PM on October 25, 2021, with a total of 130 comments.

AWMP Status: Conditionally approved.

The AWMP you provided for J-S Ranch was logged into our files as #21002. To ensure that wastes are disposed in a manner that does not cause pollution of the surface and ground waters of the state, ORS 468B.215, the department has issued an order on Notice of Permit Registration Modification #2231032 on May 26, 2022. This AWMP is hereby approved subject to the following conditions:

- Follow ODA approved AWMP#21002 and the additional monitoring, reporting and recordkeeping listed in order on Notice of Permit Registration Modification #2231032.
- Prior to starting construction, permittee must obtain a DEQ 1200-C Construction Stormwater Permit and provide a copy to ODA.
- Prior to starting construction, permittee must obtain a Linn County Road Access Permit and provided a copy to ODA.

• Prior to starting construction permittee must submit a copy of the site plan that was submitted to DEQ for the 1200-C Construction Stormwater Permit. ODA will include that site plan in the AWMP # 21002. Permittee must update his copy of the AWMP #21002 with the DEQ approved site plan.

Permit Status: New registration pending receipt of fees.

This Large, Tier II, poultry facility is permitted for a total of 580,000 broiler chickens. Your facility is designated as a Large, Tier II Confined CAFO with an Annual Compliance fee of \$400. A fee letter is attached. Once ODA receives your CAFO fees, a Notice of Registration WPCF Permit Summary will be sent to you.
