# 10:30 Drinking Water Source Areas

Drinking Water Source areas are designations made by the state and local water drinking providers. Questions have been raised by some groups such as "Beyond Toxics" regarding how these designations related to herbicide spraying, and what is the regulatory significance of them. Lisa Arkin will be joining the WQPMT in the afternoon to discuss some concerns regarding pesticide and drinking water. Prior to that, Josh Seeds from DEQ Water Quality, will be discussing the purpose, function and delineation of Drinking Water Source Areas. We also hope to have a representative from OHA participate in that discussion. This discussion will help ensure the Team is well-versed on the nature of Drinking Water Source Areas in Oregon in advance of the discussion with Lisa Arkin.
