### **Audio Transcript Tool**

Please note that the Audio Transcript tool, available beginning in 2017-2018 for ELA CAT Listening Passages, should ONLY be turned on for students who will also be using Closed Captioning. Audio Transcripts are only available for Listening items that are tagged for Closed Captioning, and is not available for all ELA Listening items. Turning it on for students who are not also using Closed Captioning may cause confusion since it will not be available for all items they encounter on the test. Audio Transcripts provide a written transcript of the audio stimuli that can be read by refreshable Braille displays or screen readers at the speed/volume/pitch most comfortable for the student, or functions a static document for students who cannot keep up with closed captioning.

# Oregon Extended Assessment: 1% Participation Cap Reporting Requirement Deadline REPEAT

In 2015, Congress reauthorized ESEA as the Every Student Succeeds Act (ESSA). With this reauthorization, ESSA requires that "local educational agencies projected to exceed the 1% cap shall submit information to the State educational agency justifying the need to exceed such cap." The 2017-18 Statewide Kindergarten Assessment Results are available on **Thursday, February 8, 2018**. The Oregon Department of Education will provide an interpretive guidance for both Early Literacy and Approaches to Learning. These documents outline the goals of the Kindergarten Assessment and provide benchmark level descriptors for groups of

# **QUESTIONS AND ANSWERS**

### **Answers to Common Questions from the Field**

**QUESTION:** I heard that the ELA PT Assessment is different this year; what will students see when logging in to the ELA PT Assessment?

**ANSWER:** The ELA PT Assessment will be comprised of two segments. In Segment 1, students will see *either* one machine scored item (Matching Item, Multiple Select, etc.), *or* one Short Answer ("Brief Write") item. In Segment 2, students will complete a Writing Extended Response ("Full Write"). Please refer to <u>Oregon's ELA Test Specifications and Blueprints</u> for more information.

QUESTION: I have heard that Short Answer responses will now be scored by a machine. Is this true?

**ANSWER:** No. If a student receives a Short Answer "Brief Write" item during the ELA PT Assessment, it will continue to be hand scored using the Smarter Balanced Scoring Rules.

**QUESTION** Regarding the Staff Position audits, I just accidentally confirmed them all. How do I get them back to review them?

**ANSWER:** Contact the Staff Position Data Owner, <u>Beth Blumenstein</u> at 503-947-5767 with as much information as possible regarding which audits were accidentally confirmed, and she can restore them.
