Future K ELPA Screener and Remote ELPA Testing Window

The test window for the 2024-25 Future K English Language Proficiency Assessment (ELPA) Screener opens 3/1/24 and extends through the remainder of the 2024 calendar year. As a reminder, this test should be administered to students for whom a Language Use Survey has indicated the ELPA Screener needs to be administered, and who will enter Kindergarten in the 2024-25 school year. Students who need screening and are enrolling in Kindergarten in the final months of the 2023-24 school year test using the Grade K form instead.

The remote ELPA Summative test window opens 3/5/24 and closes 4/12/25. Participation in the remote ELPA Summative is
