# Oregon Extended Assessment: Administration and Data Entry Windows

The Oregon Extended Assessment administration window closes for all grade levels on **April 26, 2018**. The data entry for grade 12 students closes on that same date (April 26) in order to have scores available to districts by May 11. The data entry window for grades 3-8, and 11 closes on **May 11**, with scores available to districts on **May 25**.

# **OAKS (SMARTER BALANCED)**

#### **ELA and Mathematics Results Now Available**

Results for students who have completed the ELA and Mathematics assessments (both CAT and Performance Task) are now available in the Online Reporting System (ORS). Scores will be released in real time as students complete both components of the assessment. If you have any questions about the results or viewing reports in ORS, please access the ORS User Guide, available on the OAKS Portal, or contact the OAKS Helpdesk.

Scores for Smarter Balanced tests are available in Student Centered Staging, Secure Assessment Reports, and the Accountability Warehouse Extract (AWE) application as of April 24. Smarter Balanced assessments are reported only after a student has completed both parts (the Computer Adaptive Test and the Performance Task) and all questions have been scored. It takes up to two weeks after a test is completed for all questions to be scored and for the two parts of the test to be combined and reported. This year, the Staff FTE validation includes a new column for Counselors, and the Staff Ethnicity validation includes several new columns for Ethnically and/or Linguistically Diverse Staff. Data changed in the Staff Position collection up to the end of the day on Monday, April 30 will be refreshed in the validations on Thursday, May 3 after 1 PM. # **QUESTIONS AND ANSWERS**

#### **Answers to Common Questions from the Field**

QUESTION: I found information that is incorrect in my Staff Ethnicity and FTE validations. How do I fix it?

ANSWER: These validations pull data directly from the Staff Position collection. Contact your Regional ESD Partner or Beth Blumenstein at 503-947-5767 to request to open your Staff Position collection. Once it has been opened, you can make the edits directly in your collection. To add staff, use either File Upload or Web Submission under the Data Submission menu. To edit records that have already been added to your collection, go to the Record Management menu and select Record Maintenance.
