# **TEST ADMINISTRATION**

## **Using Student Last Names to Log into OSAS**

Beginning August 1, 2023, students must log in to the Oregon Statewide Assessment System (OSAS) Secure Browser or student testing site using their last name and Secure Student Identifier (SSID), rather than first name and SSID. The "last name" entered by the student must *exactly match* information recorded in the student's Legal Last Name field in the Test Information Distribution Engine (TIDE). This includes spaces, hyphens, and special characters such as diacritical marks. The system will not recognize shortened versions; use all information present in the field, including names separated by spaces or information that is technically not part of the student's last name (such as "Jr." or "III").

If the student's legal last name is incorrect, change it in the local student information system first, then in the ODE SSID System. The update should load in TIDE within two business days (after August 21, 2023). Please contact your Regional ESD Partner for further information or assistance.

## **ELPA Screener Training Materials Updated for 2023-24**

Training materials for the ELPA Screener have been updated for 2023-24. The most notable change from 2022-23 is that students now log in to the testing platform using their last name rather than their first name. This login must be an *exact match* to the last name information found in TIDE.

- <u>ELPA Screener Administration Module</u>: Updated screenshots and scripts. The posted version has no audio; an audio version with the same information will be added when available.
- <u>ELPA Screener Speaking Scoring Document</u>: No changes.
- <u>ELPA Screener Administration Manual</u>: Minor changes regarding Future K Screener and updated screenshots. See Summary of Changes.

As a reminder, Test Administrators (TAs) must renew ELPA Screener training yearly. TAs who completed ELPA Screener training within the last year, and who have scheduled a renewal of their training for 2023-24, may continue to administer the Screener in the interim.

# School and District Accountability Appeals Due to ODE on August 9, 2023

The Oregon Department of Education <u>will consider appeals</u> regarding accountability data displayed on the 2022-23 Accountability Detail sheets and the At-A-Glance School and District Profiles. On behalf of their respective schools, districts may submit the following to ODE:

- A written request from the school district superintendent or the superintendent's designee, received at ODE by **5:00 PM PDT on August 9, 2023**.
- Appeals must be accompanied by appropriate documentation.

Districts that wish to submit an appeal must return the appropriate materials to <u>Elyse Bean</u> by email. Please use the <u>secure file transfer</u> to submit student level data (if applicable).
