2022-23 At-A-Glance Narrative Data Collection Closes September 15, 2023

The At-A-Glance Narrative Data Collection will close on **September 15, 2023**. The At-A-Glance Narrative Data Collection is located within the Achievement Data Insight (ADI) application.

At-A-Glance Narratives must be submitted, not just saved, before ODE will publish them. You will see a row of green checkmarks on the maintenance page when the narrative sections for your institution(s) are successfully submitted.
