Oregon Department of Education, Early Learning Division Title IV-B2 Family Preservation and Family Support Services Fiscal Year 2022 Annual Report

Title IV-B2 Family Preservation and Family Support Services funds are received by the Oregon Department of Education, Early Learning Division from the Oregon Department of Human Services. Title IV-B2 funds support the provision of community-based family support services in four goal areas: Early Childhood Development/Early Learning; Child Abuse and Neglect Prevention; Adolescent Risk Factors; and Child Poverty.

## **Healthy Families Oregon:**

In Fiscal Year 2022, funding to Healthy Families Oregon was used to support parents in cultivating and strengthening a nurturing, positive relationship with their baby and to promote healthy child growth and development. Through home visits, parents were educated and offered tools, resources, and supports that promote stable, attached families. HFO reduces risk factors and builds protective factors to prevent child abuse and neglect.

# Early Learning Hubs:

All Hubs assess the needs of their region on an on-going basis, and provide services, programming and supports that are essential. During the 2022 year, the Early Learning Hubs utilized Title IV-B2 funds to support children and families in various programs depending on the needs in their region. Supports included:

- Providing culturally specific and responsive child development services to identify and enroll in early learning opportunities
- Development of early literacy programs and book distributions to children
- Preschool recruitment efforts and application support
- Parent educators who engaged children and families by providing personalized coaching, support, and resource referrals,
- Family resource coordinators who connected families to vital services, including increased access to health care through vaccine clinics, well-child visits, and social-emotional supports
- Programming to meet basic needs of families such as food, transportation, housing, financial services, health, and other essentials
- Migrant Education family support with basic needs,

- Home visitors modeling and offering families development activities,
- Resources and opportunities to connect and build relationship to other families while building their own skills via parent cafes, parent education online, and a pregnant mom's support group. Family events also promoted family voice in the community.
- Welcome Baby bags to promote early health and safety, we well as family financial stability.

The Early Learning Division will continue to use these funds to support services designed to improve parenting skills; provide structured activities to parents and children to strengthen the parent-child relationship; transportation, information and referral services; and early developmental screening of children.
