The Office of Developmental Disabilities Services (ODDS) is hosting an American Rescue Plan Act (ARPA) meeting on Friday, Sept. 15 at 11 a.m. on Zoom. ODDS also has updates on several other ARPA funding opportunities.

Home modification grant: This funding is for home modifications to ODDS-licensed 24-hour residential home agencies, adult and child foster homes. These are not for home modifications that are covered under K-Plan or waiver services. The provider must own the home they are submitting an application for, and ODDS may request proof of ownership. These grant awards are to be used to improve accessibility of homes that people with intellectual and developmental disabilities (I/DD) currently reside in or might in the future. The goal of these grants is to improve the lives of people with I/DD and increase their independence. Grant application information can be found on the ARPA webpage.

Mentorship and Training reimbursement grant: This grant creates a mentoring program that will pay qualified provider agencies to mentor other ODDS provider agencies. In addition, ODDS has designated funds for a training reimbursement project for providers. Providers will complete ODDS-approved training and provide proof of completion to qualify for reimbursement. ODDS is preparing this grant internally, and it will be available soon.
