Subject: Self-Advocacy Innovative Projects American Rescue Plan Act (ARPA) opportunities are now available

The Office of Developmental Disabilities (ODDS) is pleased to share that a new American Rescue Plan Act (ARPA) funded Request for Proposals (RFP) to support self-advocacy is now open. Self-advocacy among people with intellectual and developmental disabilities (I/DD) is essential to a strong service system. One of ODDS' top priorities is supporting self-advocacy, and this funding will make a significant impact in that effort.

The Self-Advocacy Innovative Projects is one opportunity for a maximum of \$250,000 and several smaller opportunities not to exceed \$75,000 each. This funding is meant to strengthen self-advocacy for people with I/DD receiving ODDS services. Part of the funding is for a self-advocacy reimbursement program for qualifying self-advocacy activities and events.

The proposals must meet one of these six categories or areas of need:

- Start-up funding for the creation of new self-advocacy entities in Oregon
- Expansion of current self-advocacy entities in Oregon
- Expansion of access to self-advocacy activities, including written materials, digital access, and website development
- Increasing languages other than English, and including additional cultures into self-advocacy activities and projects
- Self-advocacy trainings
- Peer-to-peer mentoring

All details, requirements, qualifications, and funding amounts <u>are available</u> <u>in the solicitation</u>. You must be logged into Oregon Buys to view the RFP document.

There will be two pre-proposal conferences. The first is Dec. 5 at 11 a.m. and will be held <u>using Zoom</u>. The second is Dec. 12 at 2 p.m. and will also be <u>on Zoom</u>. This is a great opportunity to ask questions about the project and RFP process.

These are other important dates for the RFP process:

- Questions or requests for clarification are due Jan. 11, 2024
- Proposals are due Jan. 26 by 3 p.m.

Proposals must be submitted through <u>OregonBuys</u>, which is the state's e-Procurement system. All details and documents for the Self-Advocacy Innovative Projects funding opportunity can be found on OregonBuys through bid solicitation number <u>S-10000-00006610</u>. Please make sure you're registered with OregonBuys and logged in to view the RFP documentation.
