PHYSICALLY OR ELECTRONICALLY DELIVERED)

Hello Jerry,

I noted your name tied to the website link for form FHWA 1273.

As the Oregon DOT (ODOT) and other DOT's move into e-Construction (paperless) I am wondering if there any avenues or movement to allow FHWA 1273 to be delivered to Subcontractors and Contractors electronically versus the required physically as I note in Section 1 of the FHWA 1273. So a few questions.

1. Is ODOT over-interpreting physically delivered to mean hard copy only?

Yes, electronic copies are acceptable.

2. Can ODOT or Prime Contractors reference FHWA 1273 and provide a website linking <http://www.fhwa.dot.gov/programadmin/contracts/> in either ODOT's Contract or a Prime contractor to a Subcontractor, respectively, in lieu of the physical requirement?

No, referencing is not acceptable.

3. I believe FHWA 1273 was implemented in at least 1994, perhaps earlier. My generous interpretation would be that the FHWA 1273 is physically incorporated into the construction contracts albeit in the form of electrons. Knowing this and with the nearly universal nature of the internet, can an electronic version be provided in an electronic document in today's technological environment?

Yes, if the contract is in electronic form, the 1273 may be in electronic form.

4. It seems as though providing the FHWA 1273 in an electronic format could achieve many things such as:

- a. Conform the FHWA 1273 with e-Construction technologies being adopted and promoted by FHWA in the EDC-3 Initiatives, see <http://www.fhwa.dot.gov/everydaycounts/edc-3/econstruction.cfm>;
- b. Reduce cost of paper, postage, delivery, etc... i.e. Reduction of Paperwork Act; and
- c. Via electronic delivery the sender can verify the recipient received the FHWA 1273 along with the Contract.
