OTC & Region Updates - Craig Sipp:

- OTC met on September 13, 2022, this was Vice Chair Simpson's last meeting
- Lee Byers was nominated and approved for the vacant position
- ODOT Director Strickler gave a report on ODOT
 - ✓ Interstate bridge, Columbia River Crossing, is moving forward. Both ODOT and WSDOT have pledged funds
 - ✓ ODOT is updating their Social Equity office, foundational training in each region
 - ✓ On-going conversation around setting up a pilot program for agreements with contractors who provide diversity with their employees
 - ✓ Region 5 is in the forefront in meeting the ADA requirements. ODOT has secured funding for the ongoing ADA projects. \$1.4B in Federal Bonds. An ADA division is being set up to overseer these projects
 - ✓ New program, Innovative Urban Mobility Program has received \$20M in funds to focus on underserved communities
 - ✓ Ongoing discussion around the fuel tax falling behind the inflation rate and what future revenue sources can be found

Small Cities Allotment/Local Projects - ODOT

 SCA application deadline was extended to August 31st and funding increased to \$250,000

Regional Solutions - Courtney Warner-Powell, RST:

- E-Board Significant investments were provided
 - Additional \$3M for the Treasure Valley Reload facility
 - ❖ Additional \$2M for Wallowa County to assist with hail damage
 - ❖ Additional \$2M for the City of Echo for their flood mitigation
 - ❖ Additional \$850k for OHA to address the high level of Nitrate in wells in Morrow, Umatilla counties
- The Prairie Wood Products is up and running in Prairie City
- Discussions going on around infrastructure improvements in Hines, housing developments in John Day and Burns, the wildlife crossing summit in Burns
- Dawn Hurt is the new member of DLCD
- Randy Jones, DEQ Representative will be retiring the end of the year
