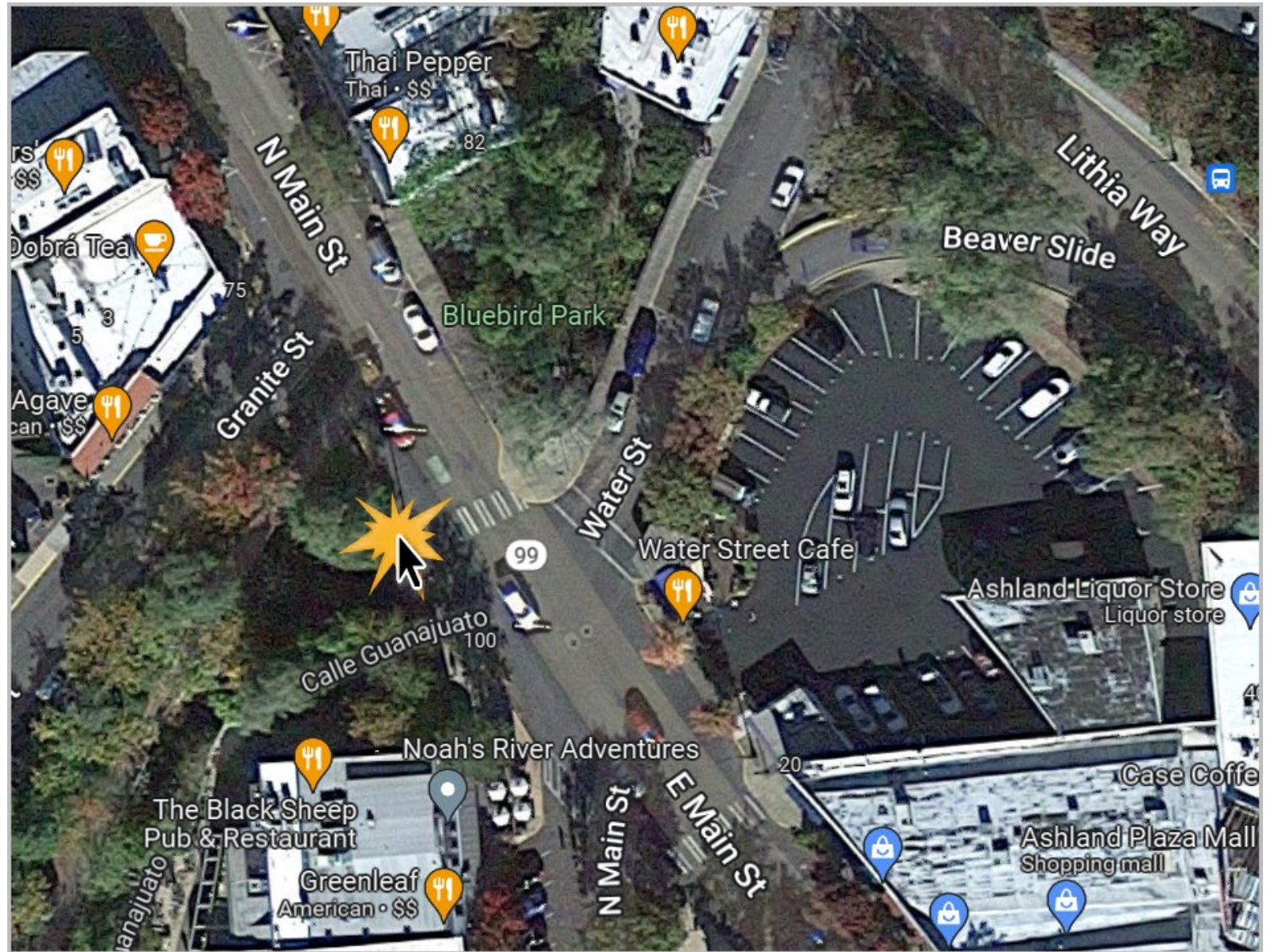
Crew will continue to pour:

Thursday -Friday- asphalt pave roadway in front of recently completed ramps.

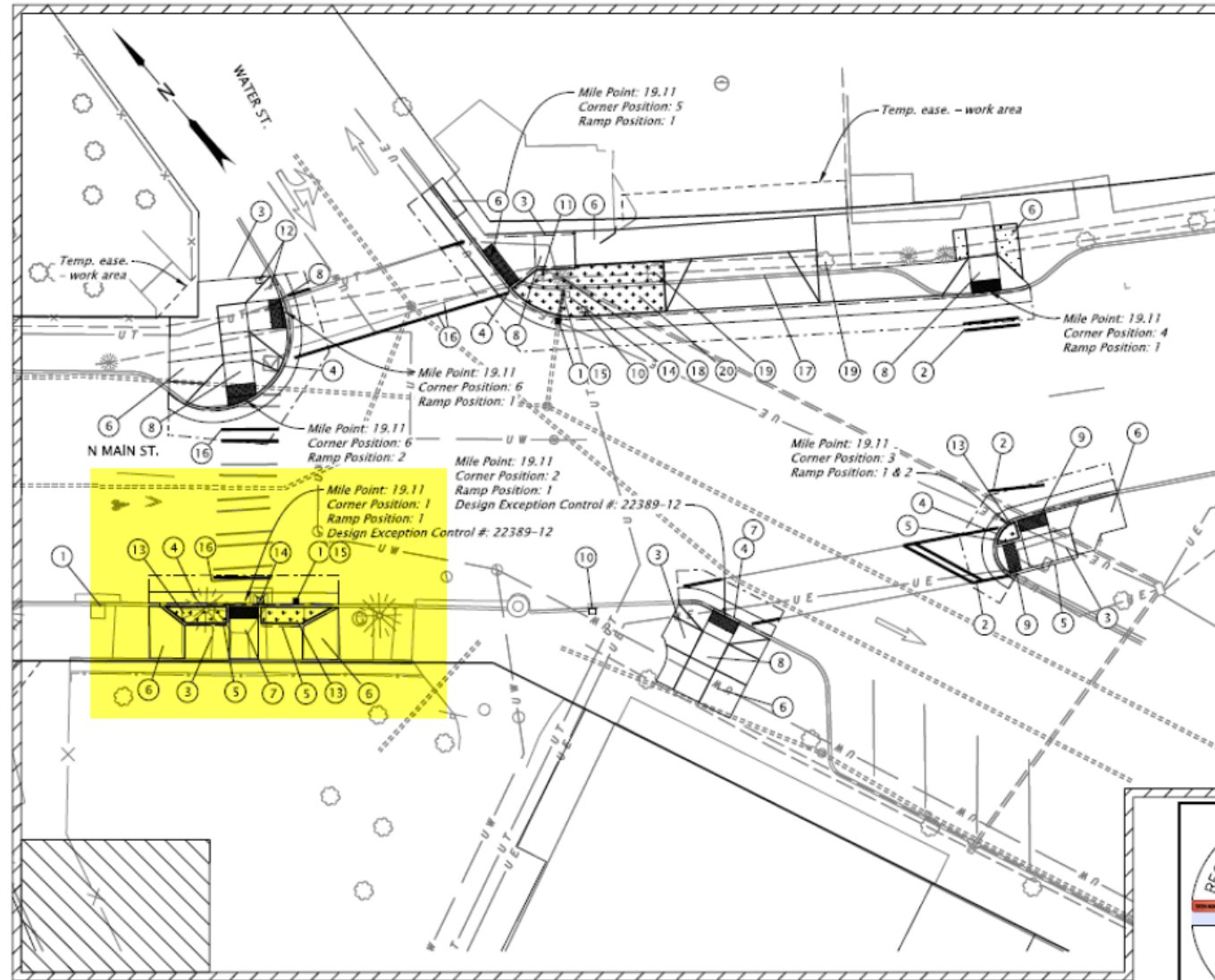

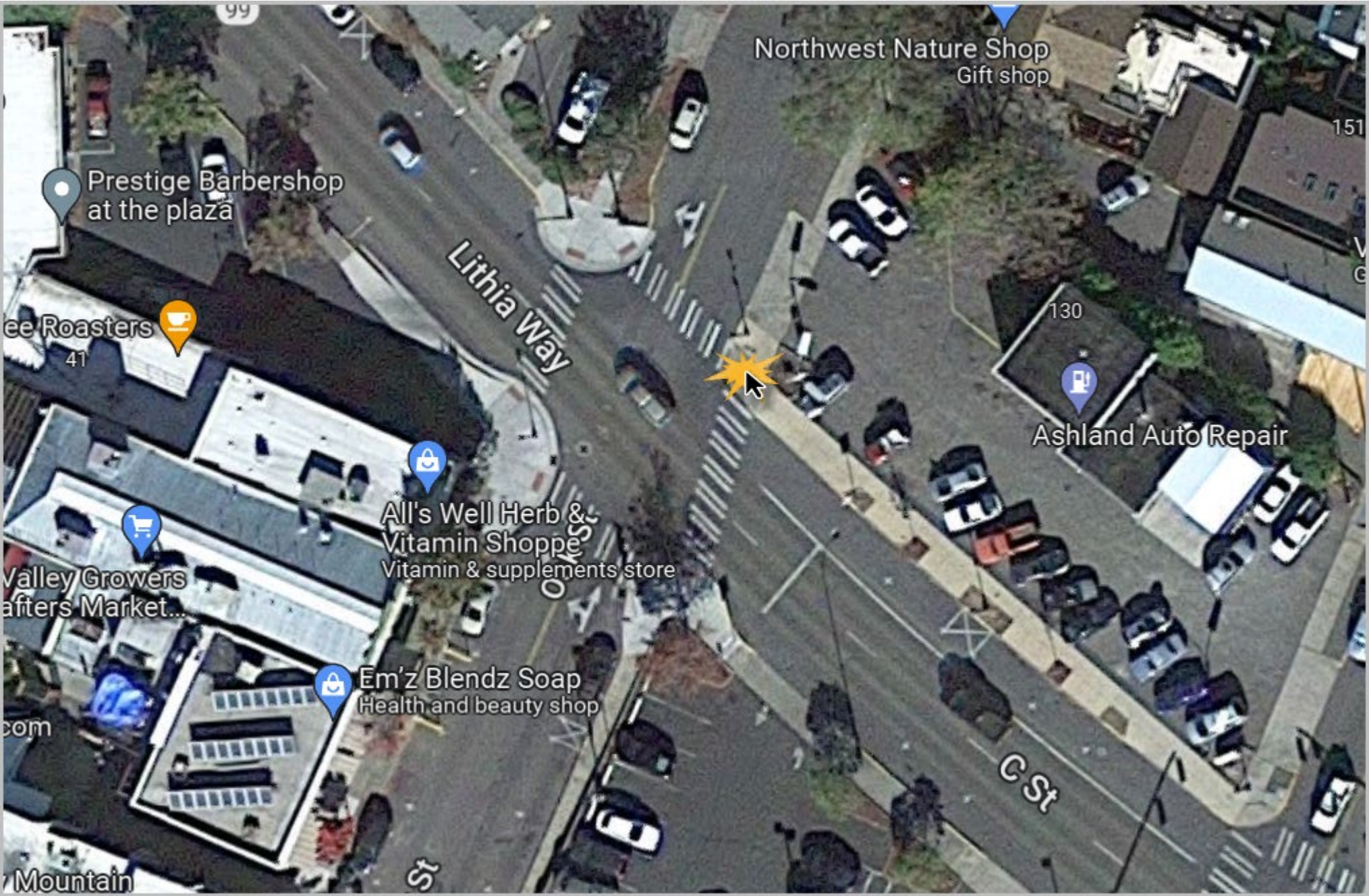

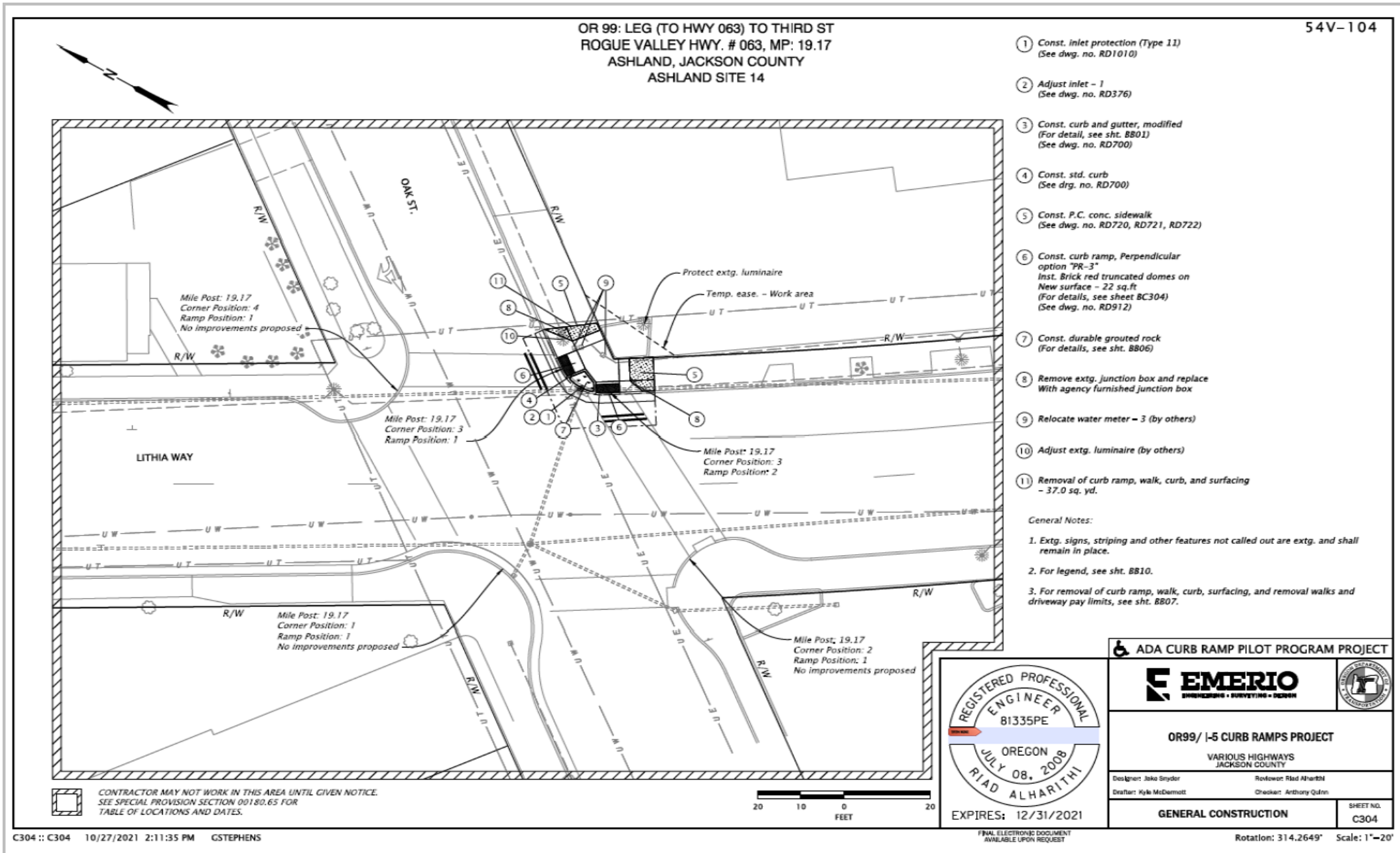
Center island

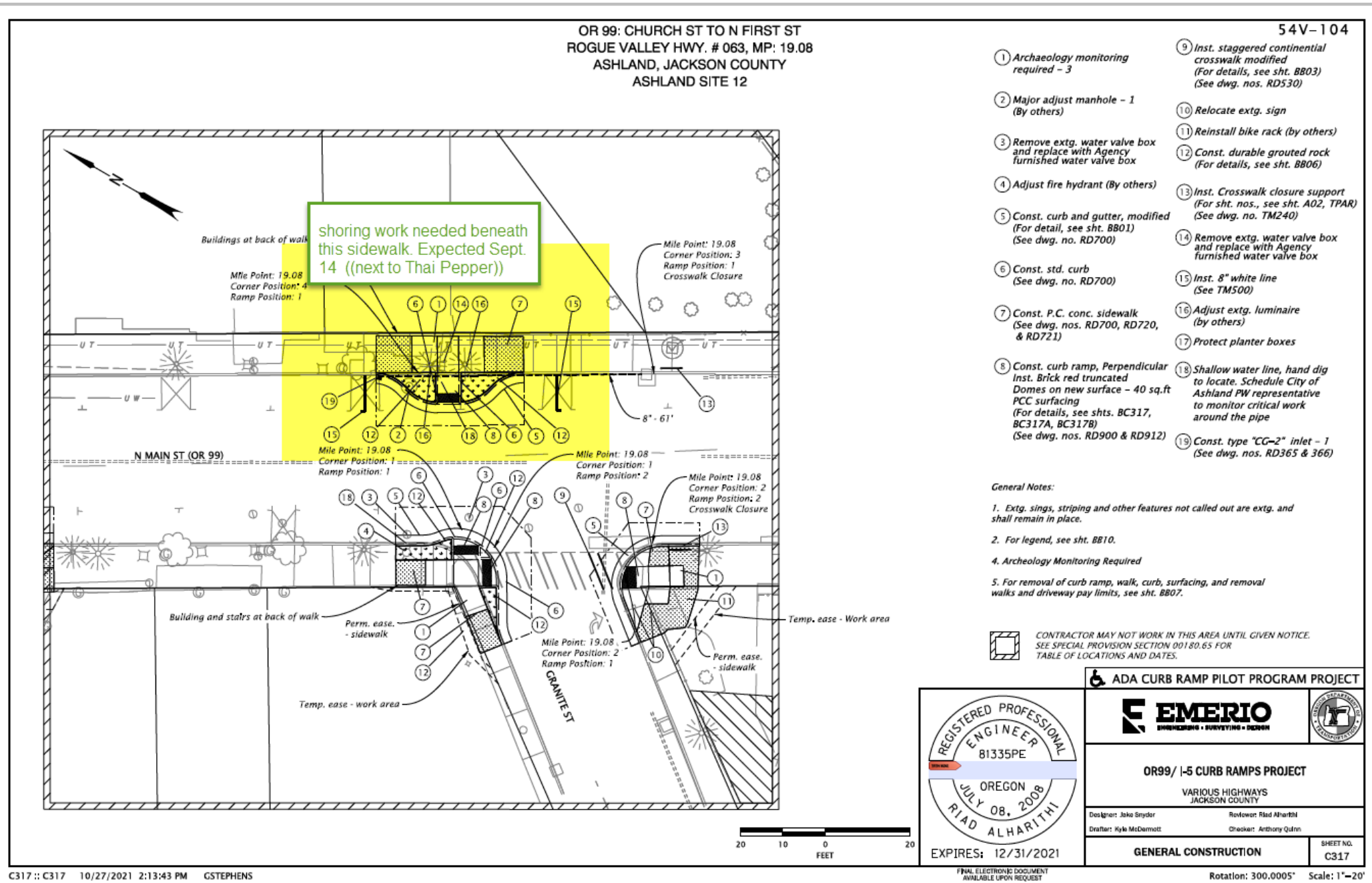
