FEMA-4499-DR-OREGON Declared: March 28, 2020

Oregon's Office of Emergency Management is conducting virtual Applicant Briefings to help agencies navigate the application process for FEMA Public Assistance funding for emergency protective measures taken to respond to the COVID-19 pandemic.

Briefings include an overview of 4499-DR-OR process and documentation requirements, followed by a question and answer session. The briefing and Q&A is approximately 90 minutes.

All briefings will be conducted on Adobe Connect.
