# **Purpose**

The Integrated Preparedness Plan (IPP) documents the planning, organizational, equipment, training and exercise (POETE) priorities for a multi-year period. It is a living document updated and refined annually. These priorities are identified by core capabilities and are derived from analysis of existing strategic guidance, threat assessments, corrective actions from previous exercises and incidents and other associated factors. A progressive, multi-year program enables organizations and jurisdictions to develop plans, train personnel and exercise the plans in a series of increasingly complex activities. There is no one set of preparedness priorities that will support the needs of every community in Oregon. The statewide priorities are broad enough to allow all jurisdictions and state agencies to plan activities that align with their individual priorities and requirements as well as support the priorities of the state.

The IPP combines POETE activities that maintain or develop the core capability in support of the priorities. These activities were identified and confirmed in regional, Oregon Emergency Response System Council and statewide Integrated Preparedness Planning Workshops (IPPW)s. Local and tribal emergency management agencies, as well as all state agencies identified in the state's Comprehensive Emergency Management Plan (CEMP), were invited to participate in and provide their perspective and inputs during regional or state agency IPPWs.

Included in this IPP is a schedule, which provides a graphic illustration of the proposed activities for the identified priorities, scheduled for July 1, 2023, through June 30, 2026.

# Preparedness Activity Considerations

# **Threats, Hazards and Risks**

Oregon faces several threats, hazards and risks, as listed in the table below. The primary threats, hazards and risks that informed the preparedness priorities were the capabilities compared to either a Cascadia Subduction Zone earthquake and tsunami, cyber-attack or explosive devices incident.

# **Capability Assessments**

The State of the State Capability Assessment is an annual assessment of Oregon counties, select cities, tribal partners and state agencies. Information collected in this assessment is used to complete the annual FEMA Threat Hazard Identification Risk Analysis (THIRA) and Stakeholder Preparedness Report (SPR). The results from this assessment identify the progress of emergency management initiatives and support prioritization of future Planning, Organization, Equipment, Training and Exercise (POETE) efforts.

The capabilities were assessed through five categories: Planning, Organization, Equipment, Training and Exercise (POETE) for capability lost, sustained or built, and to determine if an overall gap remained in the core capability. Overall gaps indicate that despite efforts and resources, there's still a challenge in fully performing the core capability as needed based on Oregon's potential threats and hazards. Following the identification of gaps, strategies to address those gaps were identified. Core capabilities were further broken down into their component functional areas and ranked within the POETE to highlight which areas had the highest and lowest capacity. Functional area rankings were based on a 0-5 scale rubric, with 0 indicating no capacity and 5 indicating the highest capacity. Lastly, respondents were asked to rank the priority of each core capability. As it's not possible to focus on all areas at all times, capabilities were ranked as low, medium and high priority. Core capabilities rated as high by a majority of respondents were selected as the high priorities overall for Oregon. Medium- and low-priority capabilities were similarly selected.

The compiled and analyzed data from the Capability Assessment was then used to create the annual State of the State Report. Based on the State of the State Report, THIRA/SPR and the National Exercise Program Priorities, the top eight priorities with gaps were chosen to focus on during this IPP cycle.

# **PREPAREDNESS PRIORITIES**

# **PROGRAM REPORTING**

The Oregon Department of Emergency Management submits annual reports to FEMA as a recipient of federal preparedness grant funds. The THIRA/SPR and Integrated Preparedness Plan are all required. Through these processes, OEM confirms if capability gaps are closing by completing preparedness activities and therefore improving Oregon's overall preparedness and resilience in support of the National Preparedness Goal. To support these reporting requirements and goal, grant-funded jurisdictions report planning, training and exercise activities that occur.

In 2022, House Bill 4068 passed in Oregon Legislature amending ORS 401 to including additional exercise conduct and reporting requirements for OEM and state agencies. In accordance with this, OEM will coordinate a multidisciplinary, all-hazards emergency response exercise involving at least 10 percent of the public or private safety agencies in the state. Each state agency will conduct an internal exercise that tests at least one element of the state agency's emergency preparedness and submit a written report to OEM. These reports provide a snapshot of work

accomplished but may not indicate the ultimate closing of a gap. All the reports are collected and aggregated in the State of the State capability assessment to highlight trends statewide and identify gaps and opportunities for future improvement.

# Multi-year Schedule of Preparedness Activities

The multi-year schedule of preparedness activities is listed by core capability, then by planning, training and exercise activity. The schedule indicates when an activity is planned or requested. The first 12 months of the schedule are broken down by month, then by quarter as further out activities are still in the planning stages. For activities without either a color or letter coding on the schedule, the jurisdiction or agency is interested in conducting this activity but does not yet have a specific timeframe.

Activities listed below are for the identified priorities and are projected during the multi-year cycle. There are many more activities that agencies and jurisdictions conduct to increase their capabilities during the multi-year cycle that may not be captured below.
