#### **Overview**

The SHARE Initiative (Supporting Health for All through Reinvestment) was created through Enrolled Oregon House Bill 4018 (2018) and requires CCOs to invest a portion of profits back into communities to address health inequities and the social determinants of health and equity (SDOH-E). For details, see OHA's <a href="SHARE">SHARE</a> Initiative guidance document. SHARE Initiative guidance is posted to the SHARE Initiative webpage.

In accordance with the requirements stated in ORS 414.572(1)(b)(C) and OAR 410-141-3735, CCOs must designate a portion of annual net income or reserves that exceed the financial requirements for SHARE Initiative spending. Starting in 2023, CCOs are subject to a formula that determines their required minimum SHARE obligation. CCOs will follow the instructions in the Exhibit L6.7 financial reporting template to apply this formula to their 2022 financials and report their 2023 SHARE designation.

According to contract requirements, a CCO's annual SHARE Initiative designation must be spent down within three years of OHA's approval of the same year's SHARE Initiative spending plan; a one-year extension may be requested (four years total).

As described in OHA's SHARE Initiative guidance document, SHARE Initiative spending must meet the following four requirements:

- 1. Spending must fall within SDOH-E domains and include spending toward a statewide housing priority;
- 2. Spending priorities must align with community priorities from community health improvement plans;
- 3. A portion of funds must go to SDOH-E partners; and
- 4. CCOs must designate a role for the community advisory council(s) related to its SHARE Initiative funds.

It is important to note that SHARE Initiative reinvestments must go toward upstream, non-health care factors that impact health (for example, housing, food, transportation, educational attainment or civic engagement).

By December 31 of each contract year, the CCO shall submit a SHARE Initiative Spending Plan to OHA for review and approval. The spending plan will identify how the CCO intends to direct its SDOH-E spending based on net income or reserves from the prior year for the SHARE Initiative. This annual SHARE Initiative spending plan will capture from CCOs how they are meeting these contractual requirements.

#### Spending plan summary

2. Summarize the work your CCO is funding through this year's SHARE Initiative. At a high level, briefly describe 1) project titles; 2) what activities are being funded; and 3) what populations will be served.

**Clackamas County**; 23-hour Stabilization Center; fund capital improvements to the facility including enabling access by members with disabilities. The Center will provide a safe, supportive environment and compassionate care to provide stabilization to medium- and long-term social determinants of health resources to support community members in their recovery journeys; Populations served will be those primarily in Clackamas County.

IRCO (The Immigrant and Refugee Community Organization); CHW Training and Workforce Development; funding will be used to provide the required 90-hour Community Health Worker training to 15 participants. After the training, CHWs will be qualified to provide health navigation and health education, which will support health equity and decrease health disparities for immigrant and refugee communities; The CHWs will serve Trillium's service areas in Tri-County and Southwest regions. Participants will be recruited from IRCO, and the community at large, recruiting and outreaching to diverse immigrant and refugee communities.

**Samoa Pacific Development Corporation;** Pacific Islander Housing Assistance; staff will be hired because of these funds and will implement community education initiatives, workshops, and outreach campaigns; address fears of accessing social services and provide accurate information to encourage more families to seek housing support; provide direct housing assistance, including rental

support and homebuyer assistance. Activities will be primarily focused on addressing housing needs of Pacific Islander families, particularly Samoans, in Oregon.

Washington County; Center for Addictions Triage and Treatment (CATT); funding for capital improvements for the facility, which supports social determinants of health needs of members served, such as transition services, peer drop-in center, crisis services, co-located supports, care coordination, and preventative services to the Washington County community. To address inequal access to care, a culturally specific outpatient program supporting Latino/a community members will be co-located onsite. It will include access to the supportive housing system of care and integrated peer supports.

#### **CHP/statewide priorities**

3. Describe how your SHARE Initiative spending aligns with your CCO's shared community health improvement plan.

The Tri-County CHP includes focus areas of improving integration between behavioral health and other types of care. Trillium's SHARE plan aligns with this CHP priority through funding the Clackamas County 23-hour stabilization center and the Washington County CATT (Center for Addictions Triage and Treatment).

Increasing CHP priorities of access to care and language access are addressed by funding CHW certifications through IRCO. This also aligns with the THW strategy initiatives in the CHP. Finally, Trillium's SHARE plan aligns with CHP areas of equity and justice, and healthy families. The Tri- County CHP includes focus areas of "Building upon and creating BIPOC community solutions for housing". Funding Samoa Pacific Development Corporation's Pacific Islander Housing Assistance program will build family resiliency through trainings and other interventions.

Trillium's SHARE spending addresses housing-related services and supports through the partnership with the Samoa Pacific Corporation. The Pacific Islander Housing Assistance program will serve 250 community members with housing service navigation, education, outreach, rental assistance, and homebuyer supports, primarily serving Pacific Islander families, particularly Samoans, in Oregon.
