RULE TITLE: Prioritized List of Health Services

NOTICE FILED DATE: 05/11/2018

RULE SUMMARY: The OHP program administrative rules govern the Division's payments for services provided to clients. The Authority is permanently amending temporary changes made to 410-141-0520 on March 21, 2018. This change references the approved Health Evidence Review Commission (HERC) Prioritized List of Health Services, effective January 1, 2018– December 31, 2019, and incorporates interim modifications made on January 5, 2018, and modifications made under the temporary rule filing. The permanent changes will be effective June 29, 2018.

RULE TEXT:

(1) The Health Evidence Review Commission (HERC) Prioritized List of Health Services (Prioritized List) is the listing of physical and mental health services with "expanded definitions" of practice guidelines and statements of intent as presented to the Oregon Legislative Assembly. The Prioritized List is generated and maintained by HERC. The HERC maintains the most current list on their website: <http://www.oregon.gov/OHA/HPA/CSI-HERC/Pages/Prioritized-List.aspx>. For a hard copy, contact the Division within the Oregon Health Authority (Authority).

(2) This rule, effective April 1, 2018, incorporates by reference new interim modifications to the Centers for Medicare and Medicaid Services' (CMS) approved biennial January 1, 2018–December 31, 2019, Prioritized List funded through line 469. This amended Prioritized List includes revised line items and new/revised guideline notes, statements of intent, and coding specifications that supersede those found in the January 1, 2018, Prioritized List as amended by the HERC on January 5, 2018.
