NEED FOR THE RULE(S):

The OHP program administrative rules govern the Division's payments for services provided to clients. The Authority needs to temporarily amend 410-141-0520. This change will reference the approved Health Evidence Review Commission (HERC) Prioritized List of Health Services, effective January 1, 2018– December 31, 2019, and incorporating interim modifications and annotations published on July 3, 2018, and modifications made under this rule filing. The changes will be effective July 6, 2018.

JUSTIFICATION OF TEMPORARY FILING:

The Authority finds that failure to act promptly will result in serious prejudice to the public interest, the Authority, providers, and clients receiving services. This rule needs to be adopted promptly so that the Authority is in compliance with CMS regulations. This temporary rulemaking action will avoid or mitigate the risks mentioned above by incorporating in rule the technical changes and interim modifications as specified in the Prioritized List of Health Services.

Prioritized List of Health Services ¶¶

(1) The Health Evidence Review Commission (HERC) Prioritized List of Health Services (Prioritized List) is the listing of physical and mental health services with "expanded definitions" of practice guidelines and statements of intent as presented to the Oregon Legislative Assembly. (2) This rule, effective April 1, 2018, incorporates by reference new interim modifications to the Centers for Medicare and Medicaid Services' (CMS) approved biennial January 1, 2018-December 31, 2019, Prioritized List funded through line 469. This amended Prioritized List includes revised line items and new/revised guideline notes, statements of intent, ~~and coding specifications, and annotations~~ that supersede those found in the January 1, 2018, Prioritized List as amended ~~by the HERC on January 5, 2018.~~ on July 5, 2018.
