## 1) Moda Medical Plans

Did you enroll in a Moda Health medical plan? If so, be sure to choose and use a PCP 360 to receive the enhanced coordinated care benefit. **If you already chose a PCP 360 for the 2021-22 plan year, you do NOT need to choose one again.** Your current PCP 360 election will carry forward for 2022-23.

## 2) Dental Plans with Exclusive Networks

Did you enroll in one of these dental plans?

- Delta Dental Exclusive PPO Dental Plan,
- Delta Dental Exclusive PPO Incentive Dental Plan,
- Kaiser Permanente Dental Plan, or
- Willamette Dental Group Dental Plan

If so, you must use their specific limited network providers.

**There is no benefit if you use an out-of-network provider on these plans** (except for emergencies).

## 3) OEBB/PEBB Double-Coverage

If you are a full-time active employee and you cover a dependent on your OEBB medical coverage who is also a full-time active employee and enrolled in their own OEBB or PEBB medical plan through their own employment, you will pay a \$5 per month surcharge for this double-coverage. This surcharge is a state law that has been in effect since October 1, 2020.

## 4) Required Notices
