- HB 2949 was passed by the 2021 Legislature; the bill allocates an additional \$80 of Federal Rescue Plan Act (ARPA) funds to support the diversification and expansion of the behavioral health workforce. The HCWF Committee will be prepared to discuss this with the Board in October.
- Committee members will engage in panel discussions around provider resilience and expanding student clinical practice opportunities at its July 7 meeting.

Committee Work (2021 - Quarter 2):

- Provided feedback to the Healthcare Workforce (HCWF) Committee's community engagement plans to advance its work to develop a health equity framework and action plan.
- Established an ad-hoc workgroup to fulfill OHPB's request for HEC to assist on OHA's 1115 Waiver Renewal:
 - o Interpret community feedback and review OHA's summaries of public and community input that has informed the direction of the waiver.
 - Review policies across the waiver and any health equity assessments done by OHA to provide feedback, additional guidance, and support.
 - o Advise OHPB on the HEC's support for the general direction of the application in terms of its progress towards eliminating health inequities overall.

Upcoming work and decisions (2021 – Quarter 3)?

- The HEC will dedicate its Q3 meetings to support the work of the Health Equity Committee ad-hoc workgroup working on the 1115 waiver. The workgroup will bring the following areas to HEC for review and endorsement:
 - How community feedback informed the concept areas and policy strategies both the 2-3 years
 of cumulative, historical community input as well as current input provided.
 - Overall OHA work on a Health Equity Impact Assessment (HEIA) of the waiver process (macro-level how we've done so far and what we're going to change going forward).
 - o Findings of OHA HEIA of policy options.
 - Accountability of how OHA is reporting back/has incorporated community feedback into policy concepts that become part of the waiver.
- HEC will continue to provide feedback to the Cost Growth Target Implementation Committee.
- Anticipating update on measure 110 or Drug Addiction and Recovery Act work. The measure's goal is to
 establish a more health-based, equitable and effective approach to drug addiction in Oregon by shifting
 the response to drug possession from criminalization to treatment and recovery.

Committee Work (2021 - Quarter 2):

Over the past quarter the Committee has reviewed current and proposed measures as part of its statutory requirement to choose the 2022 CCO incentive measures. The Committee has also taken a step back to evaluate how it and the incentive program can best meet Oregon's goals for health system transformation and eliminating health inequities. This has included:

Identifying a working definition of transformation for use in reviewing individual measures as well as the measure set (below).

Given the definition of health equity adopted by the Oregon Health Policy Board, the Metrics and Scoring Committee survey done to align the Committee's views/definition on transformation, discussions at the April and May Committee meetings, and the strategic goal to eliminate health inequities by 2030, the Committee's draft working definition of transformation is:

Measures, a measure set, and an incentive program which advance health equity by recognizing, reconciling, and rectifying historical and contemporary injustices.

- This includes, but is not limited to, focusing on priority populations as identified in the health equity definition; addressing inequities in health care delivery, directly at the patient-provider level, as well as structural and systemic bias in the healthcare system itself; addressing the full spectrum of the healthcare delivery system, including physical, behavioral, social, and oral health; and, addressing inequities outside the healthcare system that impact health outcomes, including the social determinants of health and equity.
- Furthermore, this means understanding the measure selection process is not singularly focused
 and acknowledges the dynamic, orchestrated effort needed to achieve transformation, both for
 individual measures, as well as the intersectionality of measures across the measure set.

Working with staff from OHA's Equity & Inclusion Division and Health Policy & Analytics Division's Office of Health Analytics on a Health Equity Impact Assessment of the Committee's work. The Impact Assessment is the necessary first step to ensure the Committee's work and the Quality Incentive Program advances health equity. The findings of this report, coupled with the foundation of the health equity definition, provide a path by which the Committee can check its assumptions moving forward, and ensure that health equity principles are included in measure selection and retirement and that the incentive program can be leveraged to meet the goal of eliminating health inequities by 2030.

Upcoming work and decisions (2021 – Quarter 3)?

- TBD Over the next quarter the Committee will focus on its statutory requirement to choose the benchmarks for the 2022 incentive measures by October 1, 2021.
- In addition, the Committee will continue to discuss learnings from the Equity Impact Assessment. The Committee will also discuss the vision for the incentive program included in the new Medicaid Demonstration waiver agreement with CMS.
- As above, the Committee may shift decisions on any pandemic-related factors outside the control of CCOs from its November 2021 meeting to September 2021.

• Decisions on any relaxation of 2021 benchmarks due to exogenous, pandemic-related factors outside the control of CCOs may shift from November 2021 to September 2021.
