

1	 Hepatitis A post exposure prophylaxis PEP update – Tasha ACIP has voted to change the post exposure prophylaxis recommendation for hepatitis A. The new recommendation is to offer vaccine to anyone ≥12 months of age, so there is no longer the >40 years of age cut off. IG can be given to those who are considered high risk, which we could discuss on a case by case basis. But, in general, we're going to be giving vaccine for post exposure prophylaxis. We will be presenting to CLHO CD tomorrow to get County buy in; we will also send out a HAN Alert around next week.




