SUBJECT: WIC Policy Update 2020-04

**MAJOR REVISIONS:** Policies with content changes that impact local agency functions. Please review all policies with major revisions.

### **Policy 410 – Administrative Appeals for Local Programs**

- Addition of relevant regulation ORS 183
- Addition of definition "Denial" and "Request for hearing"
- Section 1.0 through 4.0 substantial revisions to clarify the different appeal steps, responsibilities, and effective dates when a review of a State WIC Office decision is requested by either an applying local agency or a currently authorized local agency.
- Action needed: No action required.

### Policy 460 - Program Incentive Items

- Clarified if logo is needed on the promotional/ incentive items or not;
- deleted sippy cup as WIC discourage use it putting in water bottle instead.
- Action needed: Review policy before planning outreach purchases.

#### **Policy 616 – Unavailable Proofs**

- Clarified that completing the No Proof form is required in 2 situations eligibility pending or special situations where providing proofs is not possible.
- Added a definition of special situation.
- Action needed: Review policy.

# **Policy 621 – Providing WIC Services During Home Visits**

- Updated policy references and clarified that only CPAs can provide quarterly nutrition education contacts in the home.
- Action needed: Review policy

## Policy 713 - Breastfeeding: Use of Supplemental Formula

- Updated to inclusive language.
- Added definitions for Breastfeeding Self Efficacy and Yield. Used these terms in background and counseling sections.
- Strengthened language about importance of counseling and follow up for continued breastfeeding.
- Added a resource for Risks of Not Breastfeeding and updated resources to newer editions.
- Action needed: Review policy.

**MINOR REVISIONS:** *Minor edits, grammatical updates, clarifications, and/or formatting changes have occurred in these policies* 

# **Policy 316 – Quarterly Breakout of Staff Time**

- Minor updates.
- Stressed that all staff paid by WIC funds need to do time study.
