Student Satisfaction Survey Data

Each year, all certified SBHCs are required to survey a sample of clients aged 12 – 19 years who share their experience of healthcare services they receive during their visit at their SBHC. Surveys are completed by either iPad or paper form and are anonymous and confidential.

The number of SBHCs participating and student satisfaction surveys collected during the 2021-2022 school year was substantially fewer than usual. Thirteen SBHCs administered the survey to a total of 192 students between the ages of 12 and 19. Therefore, SPO is unable to provide student satisfaction survey data this year.
