## CLINICAL LABORATORY DIRECTOR RESPONSIBILITIES FOR MODERATE AND HIGH COMPLEXITY TESTING

The laboratory Director is responsible for the overall operation and administration of the laboratory, including the employment of competent personnel, equipment, safety, laboratory policies, quality assurance, all testing (including proficiency testing) and test reports. (42 CFR 493.1407 and 493.1445) The Director may, if qualified, perform the duties of the technical consultant, technical supervisor, clinical consultant, general supervisor and testing personnel. Some duties may be delegated in writing to other qualified individuals. The Director must ensure that delegated duties are properly performed and must be accessible to provide on site, telephone, or electronic consultation.

The following Director responsibili	ities may NOT be delegated:

Ensure quality services for all aspects of service

Ensure safe environmental conditions

Ensure Director approved procedures are available to staff

Employ sufficient number of employees with appropriate education/training

Write duties of CC, TC, TS, GS, TP (position descriptions)

Ensure all delegated Director duties are properly performed

Ensure general supervisor provides on site supervision as required for high complexity testing personnel qualified under 493.1489(4)

Ensure test performance only within the limitations of the clinical laboratory license
