#### **Original Message:**

Thank you to all our members who have been working tirelessly for over two years to protect the health and safety of Oregonians against COVID-19. Thank you to all the volunteers who have answered the call and thank you to every single one of you who may not have been able to deploy due to circumstances outside of your control.

As we enter a new phase of pandemic response, marked by the Governor's lifting of the COVID-19 Emergency Declaration on April 1, we want to collect feedback from SERV-OR members about your experiences from January 2021 to today.

#### SERV-OR FAQs: SB1529 Becomes ORS 431A.015 NEW

On Friday, March 18, 2022, **Senate Bill 1529-B Enrolled** was signed into law. On, Friday, March 25, 2022, Governor Brown signed a letter of authorization for the Public Health Division (**PHD**) to continue the activation of SERV-OR's State Managed Volunteer Pool (**SMVP**) for COVID response and recovery. While there is no specified end date to this authorization, OHA will continue to monitor the operational capacity of partners who are receiving volunteers.

#### Who does this affect?

Everyone affiliated with and partnered with SERV-OR but in different ways. ORS 431A.015 is not a blanket authorization for SERV-OR volunteers to continue responding to COVID







#### Why? And who is it for?

The Oregon Health Authority manages a pool of volunteers in SERV-OR known as the SMVP. OHA does not manage other organizations in SERV-OR such as Medical Reserve Corps Units (MRCs). MRCs are managed by sponsors, most often Local Public Health Authorities or local Emergency Management programs.

This authorization strictly permits OHA-PHD to obtain the Governor's authorization to activate volunteers deployed directly by the agency. MRC Units activate and direct volunteers locally and may do so without the authorization of OHA or the Governor.

ORS 431A.015 allows the state to ensure workers' compensation and tort liability protections are in place when there is an urgent need for healthcare volunteer support during an incident that does not rise to a Governor's declaration of emergency. Most often, these needs are seen in rural communities or in parts of our state that do not have a local or regional MRC for healthcare response.

## Example 1: You've been deployed with SMVP for COVID on and off for 2 years! Will this statutory update change any of this?

- If you have been deployed on an official mission assignment by the Oregon Health Authority, supporting COVID response and recovery, you may continue with no interruption to your current liability protections
- If you have been notified by OHA to stand down, you might see renewed requests to re-activate to those missions. You have no obligation to reactivate.
- Not all missions will re-activate. Many sites have stabilized and will not be requesting additional assistance

#### **Example 2: Medical Reserve Corps Members**

- Some Oregon MRC Units will continue deployments and can ensure you are covered. We advise that you do not deploy under an MRC without *first* confirming the presence of a waiver of liability. This Governor authorization, which ensures tort and workers' compensation protections for volunteers, *does not* extend to all SERV-OR organizations.
- Many people are dual-enrolled in the SMVP and a local/regional MRC. Only SMVP deployments directed by OHA are authorized for workers' compensation and liability coverage.
- Not an SMVP member? You can get registered with the State Managed Volunteer Pool by emailing the SERV-OR team. We'll provide technical assistance to get you queued for onboarding



## Where are volunteers distributed in Oregon, what are they? NEW

Members and partners often ask about the geographical distribution of SERV-OR in Oregon. The following chart shows the distribution of health occupations in our program. Not surprisingly, nurse occupations (CNA, RN, NP, LPN, and more) represent the bulk of our membership! On the map below, we've quantified the membership of Nurse, Physician, and EMS occupations in each of the Oregon counties. Much like the population of our state, Multnomah County has the largest concentration of SERV-OR volunteers!

#### **Healthcare Occupations in SERV-OR**





# Stories of Service: Father Bernie Lindley: Stepping in to make a difference! NEW

"Our community was suffering, and I could not sit still and watch," stated Father Bernie Lindley. Father Bernie, as he is called, has made a difference in the Brookings community. His church and volunteers, who have taken on some of the roles that might have been done by the local public health authority were transferred by the Curry County Board of Commissioners to Oregon Health Authority last summer. The Brookings MRC unit was disbanded a few years ago when the leader moved away. Until that point, it had been active with many pieces of

training and a focus on emergency preparedness. With this gap in both public health services and the

MRC organization, Father Bernie, stepped in to help. Flu shots and other



services, through the church, have been available to vulnerable populations of homeless or those on the verge of homelessness, so providing COVID vaccinations and testing was a natural next step. With grant support from the OHA and collaboration with community agencies, Father Bernie, his congregation, three Registered Nurses, and two retired Physician Assistants gave over 3000 vaccinations and provided over 7000 COVID tests since April

2021. At the height of the pandemic, they often saw more than 100 people a day for vaccinations or testing. In addition, they provided









vaccinations to those who are homebound and in nursing care settings, sometimes traveling 30 miles each way. They have offered several vaccines and testing clinics a week during the pandemic and recently went to one clinic on Saturday, but they are ready to do more if there is a need.

According to Father Bernie, "We have taken over this aspect of public health for the COVID response in our area to increase access to these services. We did this because there is a need for people to get vaccines and tests."
