Online data base for pediatric patients. It allows providers to increase the delivery of care to the pediatric population across the state.







Establishes Emergency Behavioral Health Services for Children program in Oregon Health Authority to promote timely delivery of behavioral health services to children who present to hospital emergency departments in behavioral health crisis.




A upward trend in prehospital weight documentation for all patients continues; 2022 Quarter 4 (October-December 2022) data were sent to all transport agencies.


In 2023 Quarter 1, the EMSC Program reached out to agencies that had opportunities for improvement, with the hopes of supporting agency-level efforts.

The EMSC Program Manager and EMSC Advisory Committee will continue to monitor this project and determine next steps.

#### HRSA: Health Resources and Services Administration

Annual EMS Survey took place January - March 31, 2023





#### Notice of Award

2023-24 grant year was awarded, but was allocated less money than requested. The grant will cover 78% of the EMSC program personnel and activities, and EMSC general funds will cover the remaining 22%.

### Oregon EMS Information System (OR-EMSIS) Oregon Trauma Registry (OTR)

#### **Quality Improvement**

The License Management System Quality Improvement (LMS REVAMP) project has been paused to prioritize the upcoming renewal cycle. This project is intended to update and modernize the licensing process. Of the 28 applications and forms designated for updates, 11 are currently completed, 10 are in progress and 7 have not been started. All applications related to renewal and initial licensure have been completed. Work on this project is expected to resume in the 3rd quarter of 2023.

#### **NEMSIS 3.5 Implementation**

Oregon was the 7th State in the nation to go live submitting NEMSIS 3.5 compliant data to the national database. As of the end of the 1st quarter of 2023, 21 agencies are live on NEMSIS 3.5. A schedule for agency transition is in place, onboarding additional agencies and vendors through the rest of the year. #### **Data Quality Assurance**

EMS and Trauma Data Quality tool development is ongoing. An application for exploring trauma band distribution in OREMSIS and OTR was developed and demonstrated for proof of concept. The data team also continued to build documentation for Data Quality tools and reports.

#### **Oregon Trauma Registry RFP**

The Oregon Trauma Registry Request for Proposal (RFP) process is required by the Department of Administrative Services (DAS). The RFP has been drafted and is currently under review by Department of Justice. Planned publishing is for April 2023.

#### Reporting

The Oregon EMS & Trauma Data Team has been engaged in reporting work including the following:

- An updated EMS for Children Program dashboard has been developed and will be available through the web site
- Trauma biennial report is under review, anticipated publication in Q2 2023
- EMS Annual report dashboard's anticipated publication is 2023 Q2

#### **Data Requests and Partnerships**

In the first quarter of 2023, the Oregon EMS & Trauma Data Team have supported several projects from other OHA programs, state agencies, and outside research organizations including:

- OHSU Using Machine Learning, to find a life-saving needle in a haystack of children's emergencies
- OHSU Emergency Medical Services for Children, Evaluation of Readiness and Outcomes (EMSC-HERO)
- NEMSIS Multistate EMS and Medicaid Dataset (MEMD): A Linked Dataset for Patient-Centered Outcomes Research
- A Multi-Center Prospective Evaluation of Prehospital Ketamine Administration and ED Disposition in the Trauma Patient (Western Trauma Association)

#### Data Integration projects

- Work to implement the linkage between the License Management System and OR-EMSIS has been placed on pause, due to the discovery of a data quality issue that the project was producing in OR-EMSIS. Contractors are working to resolve the issue, and the project is expected to resume in the 2nd quarter of 2023. Since the beginning of the linkage, 288 agencies have been completed.
- The Oregon EMS & Trauma Systems Program has initiated a project with Oregon-Idaho High Intensity Drug Trafficking Area (HIDTA) to integrate EMS data into the Overdose Detection Mapping Application Program (ODMAP). This will provide a resource for monitoring trends and spatial patterns in drug overdose events.

### **Ambulance Service Area (ASA) Review**



In accordance with <u>OAR 333-260-0020(7</u>), the OHA EMS & Trauma Systems Program reviews county Ambulance Service Area (ASA) plans for compliance with state regulations at least once every five years. The OHA EMS & Trauma Systems Program is working with counties to ensure all ASA plans have been determined to be compliant with state rules within the past five years. Counties with outdated approvals are being prioritized for review.

The OHA EMS/TS office is excited to announce the data integration project of OR-EMSIS and CARES, scheduled to start summer 2023. This integration will allow the <u>ePCRs to automatically upload the data</u> <u>sets into the agency CARES form</u>. The state will work with the agencies on the transition timeline. Until this work is completed, agencies will still need to manually input the CARES data.



Ground Emergency Medical Transportation coordinated care organization (GEMT CCO) funding continues to positively impact Oregon's public transporting agencies. The 82nd Oregon Legislative Assembly convened the 2023 Legislative Session on January 17, 2023. As of March 1, 2023, more than 2,400 bills have been introduced and the Health Care Regulation and Quality Improvement section is tracking more than 250 of those bills.

<u>HB 3126A</u>	1	Emergency Behavioral Services for Children	
Establishes Emergency Behavioral Health Services for Children program in Oregon Health Authority to promote timely delivery of behavioral health services to children who present to hospital emergency departments in behavioral health crises. Directs authority to implement up to three pilot programs in three regions with one hospital per region willing to be Regional Child Psychiatric Center. Allows center to also open Child Psychiatric Emergency unit within pilot region with funding provided by authority. Adds to State Trauma Advisory Board and area trauma advisory boards representation from designated regions that participate in Emergency Behavioral Health Services for Children program. Prohibits insurance policies or certificates that reimburse costs of medical care from requiring prior authorization of treatment provided to individual presenting to Regional Child Psychiatric Center with behavioral health crisis or from denying coverage because health professional providing treatment is not credentialed with insurer offering policy or certificate. <b>Referred to House Behavioral Health and Health Care Committee with subsequent referral to Ways and Means.
