DMAP began reimbursing DRG hospitals using MS-Diagnosis Related Grouper Version 25 on October 29. RA's dated Nov. 2 will reflect the new rate.

The new rate should have been used for dates of service starting October 1, 2007, so DMAP will initiate a System Mass Adjustment Process (SMAP) on claims for dates of service Oct. 1 through Oct. 28, 2007, that originally processed using the old DRG Version 24 rate. The SMAPs begin Nov. 13 and should be done by Dec. 14, 2007.

Reassure callers that they don't need to do anything to get the adjusted rate. The providers received the attached letter.

Subject: MS-Diagnostic Related Grouper implemented October 29, 2007

DMAP implemented the MS-DRG Grouper Version 25 on October 29, 2007, for reimbursements to DRG hospitals for inpatient claims with a date of service on or after October 1, 2007. DRG reimbursed hospitals will see MS-DRG Version 25 groupings reflected on their claim remittance advice dated November 2, 2007.

Claims processed using Version 24 with October 1st thru 28th dates of service will be reprocessed by DMAP's System Mass Adjustment Process (SMAP) starting November 13, 2007. December 14, 2007, is the target date for completing the SMAPing of these inpatient hospital claims.

The Oregon unique DRG codes for rehabilitation and neonatal grouping have been reassigned to Version 25 numbers:

Rehabilitation DRGs: 601 to 268; 602 to 269; and 603 to 270.

Neonatal DRGs: 801 to 272; 802 to 273; 803 to 274; 804 to 275; 805 to 276; and 810 to 277.
