Important Information **Health care coverage information for some pregnant clients**

DMAP recently sent you an announcement regarding the pilot for CAWEM prenatal benefits that began April 1, 2008 for Deschutes and Multnomah counties.

Due to confusion about the benefits available under this program, we want to clarify that the benefits are those available to all OHP Plus clients, with a few exceptions (see below). This is a portion of the information we sent to CAWEM clients explaining what the OHP Plus benefit package covers, and the exceptions under the CAWEM prenatal program:

What does the OHP Plus benefit package cover?

OHP Plus coverage includes medical, dental, mental health and chemical dependency services, such as:

- Services to keep you healthy (preventive care)
- Exams or tests (lab or x-ray) to find out what is wrong
- Treatment for most major diseases
- 24-hour emergency care, x-ray and lab services
- Chemical dependency (alcohol and drug) treatment
- Eye care, including vision testing and eyeglasses
- Some surgeries
- Labor and delivery services, including your hospital stay
- Most prescription drugs
- Specialist care and referrals
- Stop-smoking programs
- Diabetic supplies and education
- Medical equipment and supplies
- Emergency ambulance services

Exceptions (not covered):

- Sterilizations
 - Therapeutic abortions
 - Hospice services
 - Death with dignity services
