Get paid faster with EFT and electronic billing

Have your payments electronically deposited using EFT

You can receive payments up to three days sooner by signing up for electronic funds transfer (EFT).

It may take more than a week to receive payments through the mail. With EFT, payments are deposited every Wednesday.

Enroll in EFT today

EFT takes two payment cycles to begin.
