A mailing is planned to all households on the FHIAP reservation list that include children. The mailing will let families know their children may be eligible for Healthy Kids coverage and encourage them to apply for Healthy Kids. A copy of the letter is attached.

- To minimize the impact on workload, the mailing will be divided into two mailings distributed two weeks apart.
- The first mailing will be sent on March 1. The second mailing will be sent on March 15. There are around 2500 letters in each mailing.
- We are not distributing applications with this mailing. We are sending the letter and a brochure only.

NOTE: Healthy Kids medical programs include SSP and SPD medical programs for children under age 19. For example, children under age 19 receiving CHP, EXT, HKC, MAA, MAF, OPC, OP6, OSIPM and SAC medical are in Healthy Kids.

Good news! Your child may qualify for comprehensive health coverage. Healthy Kids is Oregon's new health coverage program for uninsured Oregon kids and teens. No child will be put on a waiting list or be turned down due to preexisting conditions.

We are contacting your family because you are currently on the Family Health Insurance Assistance Program (FHIAP) reservation list. We want to make sure you know that your children and teens, under the age of 19, may qualify for no-cost or low-cost health coverage right now through the Healthy Kids program.

Healthy Kids covers all the care your kids need: doctor visits, dental, vision, prescriptions, mental health services and more.

Don't worry, contacting or enrolling in Healthy Kids won't change your place on the FHIAP reservation list. You will still receive a FHIAP application when your name reaches the top of the list and your application will be reviewed just like everybody else's.
