The Health Evidence Review Commission (HERC) has modified the 2012-2013 Prioritized List of Health Services for the Oregon Health Plan, effective **Oct. 1, 2012**.

Changes include:

- Code changes to condition-treatment pairs
- Code changes affecting more than 20 lines
- New and deleted coding specifications
- New guidelines and revisions to existing guidelines
- Changes to prevention tables
