Paper copies of the previous green application will not be mailed to DHS/AAA branch offices due to time constraints, unless requested. See the following information to learn how the previous green application can be accessed.

Please note: The PDF is currently labeled as “draft” but that is being fixed shortly.
- **Print:** The print version now includes a four-page insert and is available on the [forms server](#). The insert is needed for all green print application to ensure OHA has updated SSN and tax information. English, Russian, Spanish, and Vietnamese translations are all currently available on the forms server.
