To our partners:

Last week, a [Director's Message](#) updated you on the implementation of new resources for affordable housing. This message will provide additional information regarding meetings this week, as well as announce a website which will provide information about the State Housing Council subcommittees and their progress.

You may recall from last week's message that the State Housing Council is convening two subcommittees that will advise the Council and the Department on ways to efficiently deploy the new funds to maximize the impact on the housing crisis currently facing families with low incomes. The subcommittees will consider policy and financial structuring questions, and include subject matter experts. Recommendations will be made to the Council in February 2015.
