## OLCC Commissioners issue nine sanctions

**PORTLAND, Ore.** - At their monthly meeting March 15 the Commissioners of the Oregon Liquor Control Commission ratified the following sanctions based on stipulated settlements:

**Crystal Ballroom & Brewery**, 1332 W. Burnside, Portland; will pay a fine of \$5,280 or serve a 32-day license suspension, and four restrictions will be placed on the liquor license for two violations. The first violation is for a history of serious and persistent problems. The second violation is for permitting unlawful activity when two employees provided private security services without being certified to do so. Licensee will also be removed from the Responsible Vendor Program. The licensee is McMenamin's, Inc., Michael McMenamin and Brian McMenamin, Corporate Principals.

**Eclectic Restaurant/Envy Lounge Bar**, 204 SW Yamhill Street, Portland; will serve a 59-day suspension beginning March 30 for two violations. The first violation was for allowing a person to obtain an interest in the business without prior commission approval. The second violation was for unlawful activity when an employee provided private security services without being certified to do so. The licensee is Restaurant Management Group, LLC, Sirivanh Vorachith and Raoul Calderon, Members.

**Pelican Bay**, 6815 NE Killingsworth #B; Portland; will serve a 30-day suspension beginning March 30 for violating a restriction on the liquor license that limited patrons to one drink at a time. Licensee is Briny Deep Ltd., Gilbert Desmarais, Corporate Principal.

For an employee(s) failing to verify the age of a minor before allowing him/her to buy or be served an alcoholic beverage when he/she reasonably appeared to be under 26:

**7-Eleven Store #2362-16572F**, 19175 SW Tualatin Valley Highway, Aloha; will pay a civil penalty of \$330 or serve a two-day suspension. Licensee will install age verification equipment and will begin utilizing the equipment to verify the age of every customer purchasing alcohol who reasonably appears under 26 years old. Licensee is Akum Corporation, Mohanbir S. Grewal and Narinder K. Grewal, Corporate Principals.

**4 Daughters Irish Pub**, 126 W. Main Street, Medford; will pay a \$3,795 fine or serve a 23-day suspension. Licensee is ROMICO, Inc., George Michael Sidon and Collin Lindsey, Corporate Principals.

**Clancy's**, 16066 NW 1<sup>st</sup>, Sherwood; will pay a \$3,795 civil penalty or serve a 23-day suspension. Licensee is Bower & Clancy, Inc., Robert Bower, Corporate Principal.

For permitting an employee(s) to sell, mix, or serve alcohol or supervise those who do without a service permit:

**Cha! Cha! Cha! Mexican Taqueria**, 1208 NW Glisan, Portland; will pay a \$1,485 fine or serve a nine-day suspension. Licensee is Cha Cha Cha Taqueria, Inc., Francisco J. Diaz Hurtado, Corporate Principal.

**Black Bear Diner**, 13435 Tualatin Valley Hwy, Beaverton; will pay a \$2,145 civil penalty or serve a 13-day suspension. Licensee is Deli Concepts, Inc., Terry L. Farnham, Denise L. Farnham, John E. Ferris and Robert G. Hunter, Corporate Principals.

**The Know Microtheater**, 2026 NE Alberta Street, Portland; will pay a civil penalty of \$1,485 or serve a nine-day suspension. Licensee is Space Development Kit, LLC, Daniel J. Bovinette, Jessica A. Vogelín, Daniel V. Bortfeld and Ryan D. Stowe, Members.

The five citizen commissioners are the policy-making body of the OLCC. They meet monthly for one or two days to make decisions on liquor licenses, rules, contested case hearings and appointments of liquor store agents. Commission meetings are held every other month at OLCC's main office, 9079 SE McLoughlin Blvd., Room 103A in Portland. Subsequent months, the meetings are held via phone.
