

9	The Oregon Medical Board (Board) is the state agency responsible for licensing,
10	regulating and disciplining certain healthcare providers, including physicians, in the State of
11	Oregon. George Solomon Allen, MD (Licensee) is a licensed physician in the State of Oregon.

13	The Board received information regarding Licensee that resulted in the Board initiating
14	an investigation. The results of the Board's investigation to date have raised concerns to the
15	extent that the Board believes it necessary that Licensee agree to cease the practice of medicine
16	until the investigation is completed.

18	In order to address the concerns of the Board, Licensee and the Board agree to enter into
19	this Interim Stipulated Order, which is not an admission of any wrongdoing on the part of the
20	Licensee, and provides that Licensee shall comply with the following conditions effective the
21	date this Order is signed by Licensee:
22	3.1 Licensee voluntarily withdraws from the practice of medicine and his license is
23	placed in Inactive status pending the completion of the Board's investigation.
24	3.2 Licensee understands that violating any term of this Order will be grounds for
25	disciplinary action under ORS 677.190(17).
