The mission of the Oregon Medical Board is to protect the health, safety, and well-being of Oregon citizens by regulating the practice of medicine in a manner that promotes access to quality care. Before being granted a license, an acupuncture applicant must be familiar with the laws and rules governing acupuncture in Oregon as well as the Board's Statements of Philosophy. This open book exam serves as an introduction to the Oregon laws and guidelines. Familiarizing yourself with these regulations will help you avoid problems in your practice that must be addressed by the Board.

There is only ONE correct answer to each question. This is an open book examination and is meant to be educational. However, you will be required to repeat the exam if you miss four (4) or more questions. Three failures to pass the examination will require an interview with a Board member or Board staff.

1. In Oregon, acupuncture may be practiced by:

10. T F Licensees must inform the OMB of a change in their practice or mailing address within 30 days.
11. T F An acupuncturist with an inactive license must reactivate their license before returning to Oregon to resume practice.
12. T F The Board may require an applicant or a licensee to undergo a physical, mental, or substance abuse evaluation by a Board-approved evaluator.
13. T F If a patient has not paid a bill, the licensee does not have to provide requested medical records until the bill is paid.
