Anonymous Analysis Program







The Program

The Anonymous Analysis Program was established to assist parents/guardians who find suspected drugs in the possession of their minor children. Parents/guardians may submit suspected drugs by delivering the item(s) directly to their local OSP Forensic Lab or OSP Office. The item(s) will be tested for the presence of controlled substances and then destroyed.

Testing is free and confidential, and the results will not be used for enforcement purposes. The findings will be reported verbally to the submitting OSP representative or directly to the parent/guardian who made the request.

Though the status of drug possession has changed in Oregon, OSP remains committed to assisting parents in helping minors make healthy decisions and to get assistance as needed.

WHAT SHOULD YOU DO?

- Collect suspected drugs using gloves.
 Package the item in a clear plastic bag when possible.
- Call your local OSP Lab or office to coordinate a drop off time.

WHAT WILL THE LAB DO?

- Assign a lab number to the submission that the parent/guardian can reference.
- Assign the item to an analyst, who will perform the analysis as soon as possible.
- Release the findings verbally to the parent/guardian or OSP representative and destroy the item.

Pharmaceutical and/or novelty pills

Powders, crystals, black tar-like substances





Hallucinogenic substances in the form of gel or paper





Additional Information

SAFETY

- Use caution when handling substances—use gloves whenever possible. Treat all substances as TOXIC
- Pill imprints can be misleading, many are counterfeit and contain dangerous designer drugs

PACKAGING

- Use a clear plastic bag, when possible
- Secure zip locks and loose substances to prevent spilling
- Do not include extraneous items
