The GENERAL FINDINGS OF FACT of the FINAL ORDER OF DETERMINATION is incorporated as if set forth fully herein.

A. FINDINGS OF FACT

1. On April 30, 1997, the UNITED STATES DEPARTMENT OF THE INTERIOR, BUREAU OF LAND MANAGEMENT (BLM) timely submitted a Statement and Proof of Claim (Claim 373) to the Oregon Water Resources Department (OWRD) pursuant to ORS Chapter 539 in the Klamath Basin Adjudication claiming a federal reserved water right under an Executive Order entitled Public Water Resource (PWR) No. 107, authorized by President Coolidge.
2. On October 4, 1999, following investigation of the evidence submitted, the Adjudicator issued a Summary and Preliminary Evaluation of Claims (Preliminary Evaluation), stating the claim was approved.
3. On May 8, 2000, BLM timely filed Contest 3988 to the Preliminary Evaluation of Claim 373 to address a typographical error.
4. On May 8, 2000, the following parties, hereinafter collectively referred to as the "Klamath Project Water Users", filed Contest 3620: Klamath Irrigation District, Klamath Drainage District, Tulelake Irrigation District, Klamath Basin Improvement District, Ady District Improvement Company, Enterprise Irrigation District, Klamath Hills District Improvement Co., Malin Irrigation District, Midland District Improvement Company, Pine Grove Irrigation District, Pioneer District Improvement Company, Poe Valley Improvement District, Shasta View Irrigation District, Sunnyside Irrigation District, Don

Johnston & Son, Modoc Lumber Co., Bradley S. Luscombe, Berlva Pritchard¹, Don Vincent², Randy Walthall, Inter-County Title Co., Winema Hunting Lodge, Inc., Van Brimmer Ditch Co., Plevna District Improvement Co., and Collins Products, LLC.

5. On May 8, 2000, the following parties filed Contest 3241: Horsefly Irrigation District, Langell Irrigation District, Rogue River Valley Irrigation District, and Medford Irrigation District, as trustees for their affected water right patrons.
6. These matters were referred to the Office of Administrative Hearings for a contested case hearing. The Office of Administrative Hearings designated these matters as Case 278.
7. On November 14, 2003, Klamath Project Water Users voluntarily withdrew Contest 3620. *See* NOTICE OF WITHDRAWAL OF CERTAIN CONTESTS (Nov. 14, 2003).
8. On November 12, 2003, Medford Irrigation District and Rogue River Valley Irrigation District voluntarily withdrew Contest 3241. *See* VOLUNTARY WITHDRAWAL OF CONTEST BY MEDFORD IRRIGATION DISTRICT AND ROGUE RIVER VALLEY IRRIGATION DISTRICT (Nov. 12, 2003).
9. On November 17, 2003, Langell Valley and Horsefly Irrigation Districts voluntarily withdrew Contests 3241. *See* VOLUNTARY WITHDRAWAL OF CONTEST BY LANGELL VALLEY AND HORSEFLY IRRIGATION DISTRICTS (Nov. 17, 2003).
10. On August 2, 2004, the OWRD and BLM executed SETTLEMENT AGREEMENT BETWEEN THE OREGON WATER RESOURCES DEPARTMENT AND THE UNITED STATES BUREAU OF LAND MANAGEMENT ON CLAIM NOS. 325-375 (Settlement Agreement) which resolved the remaining contest (Contest 3988).
11. On August 2, 2004, the Adjudicator withdrew Case 278 from the Office of Administrative Hearings.

B. DETERMINATION

1. The Settlement Agreement executed between OWRD and BLM is adopted and incorporated as if set forth fully herein, with the exception that gallons per minute have been converted to cubic feet per second and rounded to the nearest thousandth for administrative convenience.
2. The Executive Order entitled PWR No. 107 for a federal reserved water right is a valid basis for this claim. The GENERAL CONCLUSIONS OF LAW CONCERNING CLAIMS BASED ON PUBLIC WATER RESERVE NO. 107 is incorporated as if set forth fully herein.
