

This rule amends the Class II Wholesaler definition to include Oxygen USP. The amendment is needed prior to the wholesaler renewal cycle to ensure the appropriate classification of registration for wholesalers. The renewal cycle begins in July.

Justification of Temporary Rule(s):

Without the temporary rule, wholesalers of Oxygen USP will be required to renew as a Class I Wholesaler which may require a \$100,000 surety bond or irrevocable letter of credit.
