The Oregon Physical Therapist Licensing Board (Board) is the state agency responsible for licensing and disciplining physical therapists and physical therapist assistants pursuant to ORS 688.140 and 688.160. Kathy Roberge, PT (Licensee) is licensed by the Board to practice as a physical therapist in Oregon. The Board is prepared to file a Notice of Proposed Disciplinary Action for the Licensee's action of failing to comply with the statutes and rules requiring completion of continuing education. The Board voted to assess a civil penalty of \$800. The Board and Licensee agree to resolve the issues through this Stipulated Agreement and Final Order.

**STIPULATIONS**

1. Licensee stipulates that she failed to timely complete nine of the twelve hours of continuing education required for license renewal within the specified timeframe of January 1, 2006 through March 31, 2008 in violation of OAR 848-035-0020(10) which is grounds for discipline pursuant to ORS 688.140(2)(a).
2. Licensee agrees to voluntarily relinquish her license to practice pursuant to ORS 688., in lieu of paying a civil penalty for the untimely completion of the continuing education.
3. If Licensee decides to reapply for licensure, she must pay the \$800 civil penalty and associated licensing fees prior to reinstatement of her license.
4. If Licensee decides to reapply for licensure, in accordance with Board statutes and rules, Licensee may be required to provide proof of competency to practice physical therapy and/or re-take the National Physical Therapy Examination.
5. Licensee is aware of her right to notice, to be represented by counsel, to a hearing where she could call witnesses and cross-examine witnesses called by the Board, and the Licensee hereby waives these rights and agrees to entry of this Stipulated Agreement and Final Order.
