**10800 Licensed Professional Counselors and Therapists, Board of**

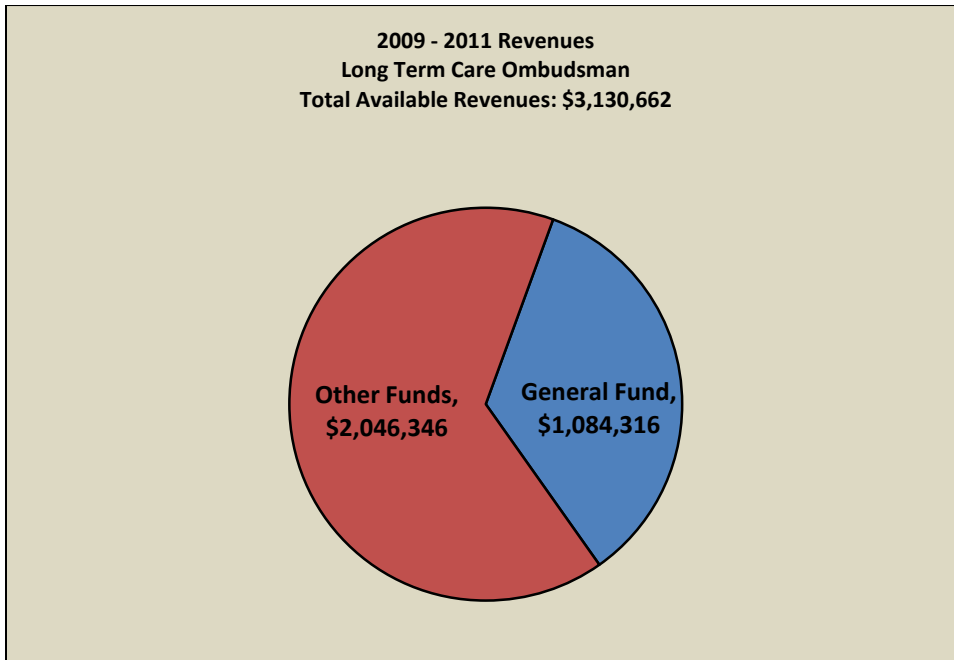

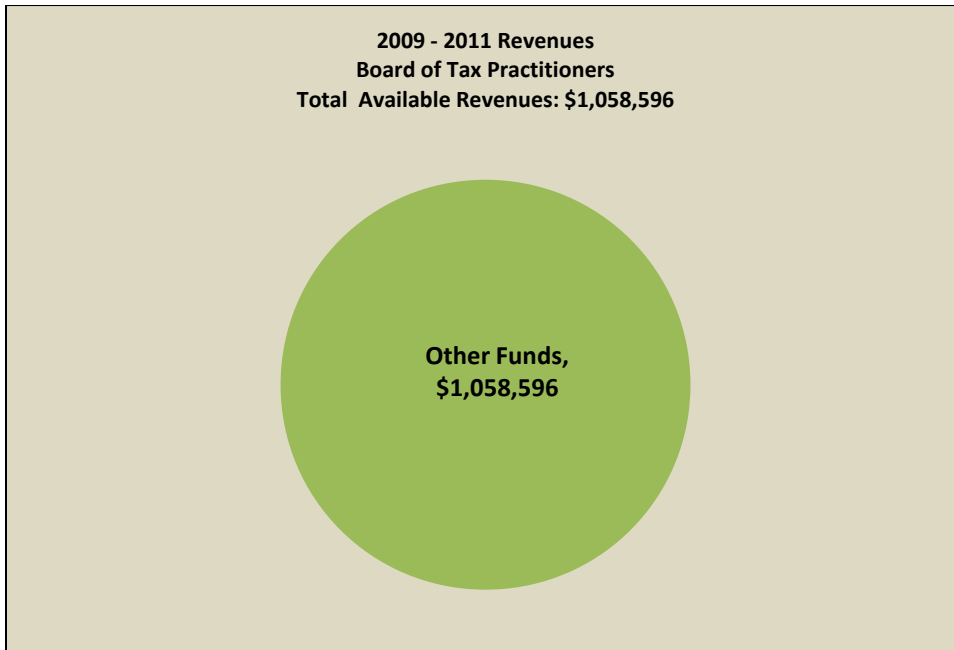

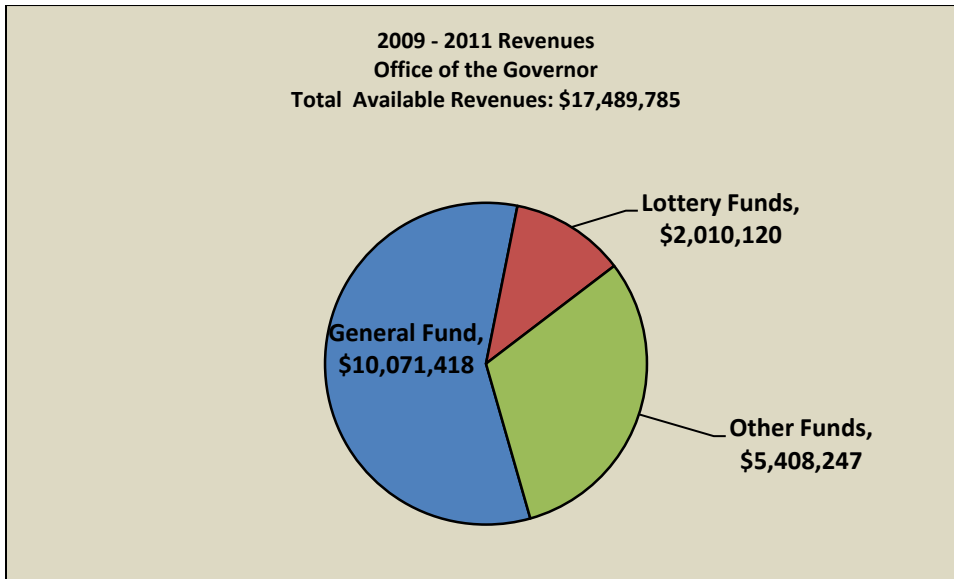

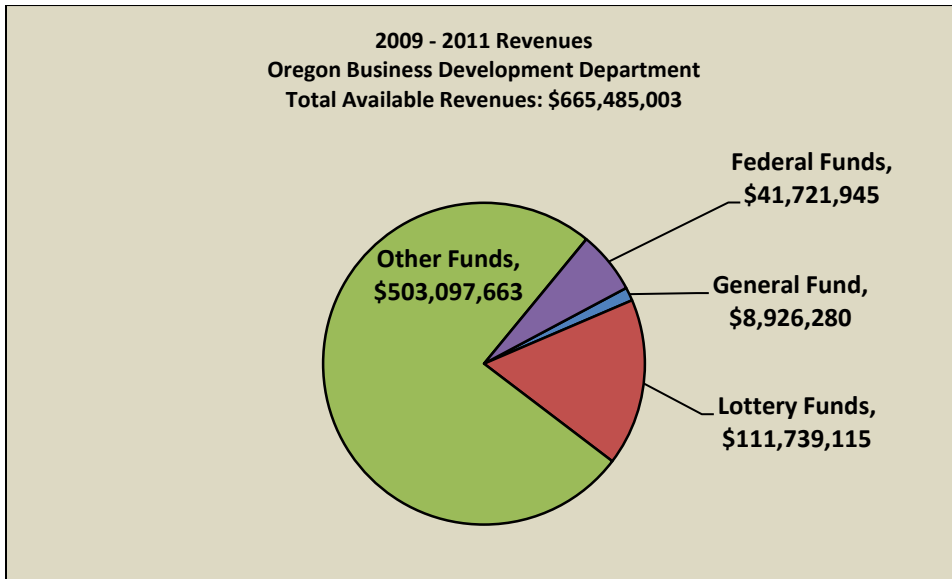

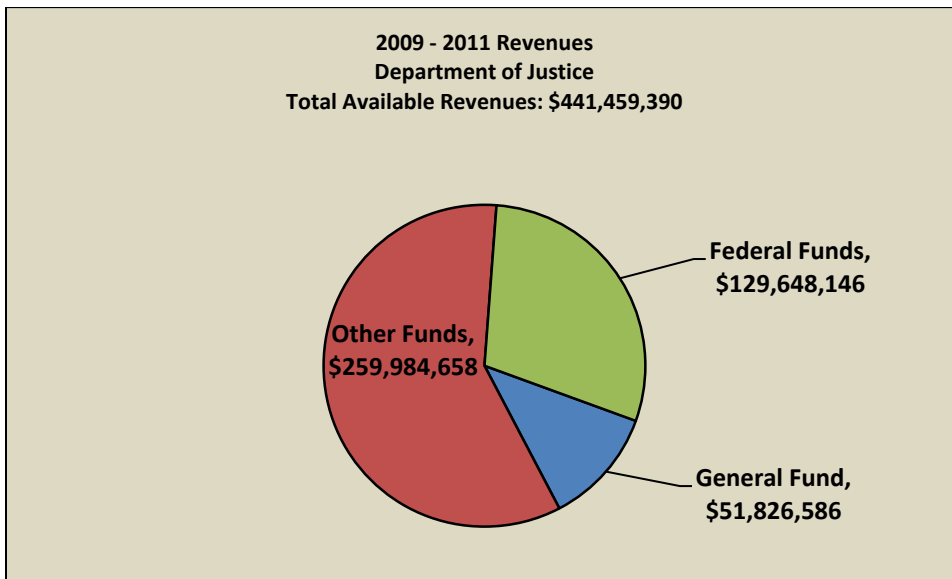

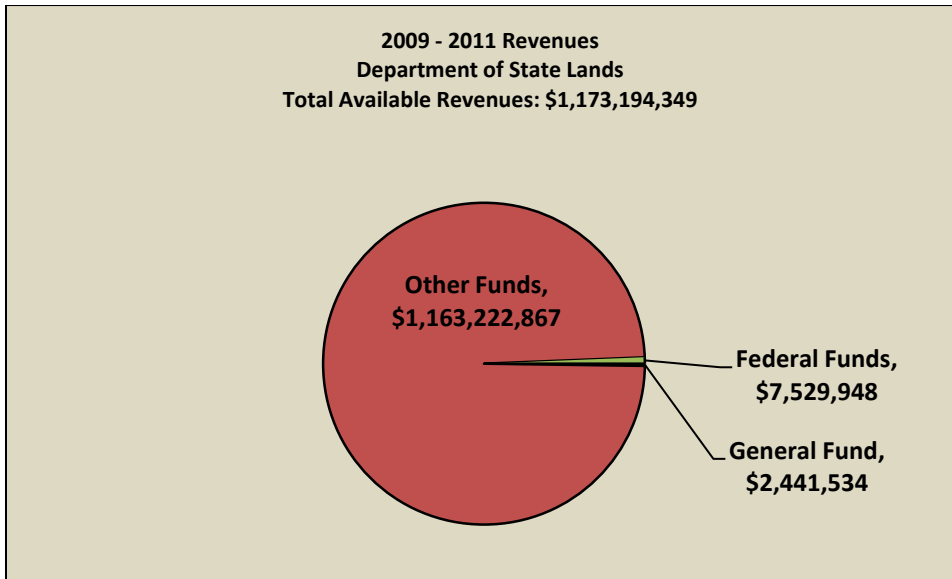

**14100 Lands, Dept of State**

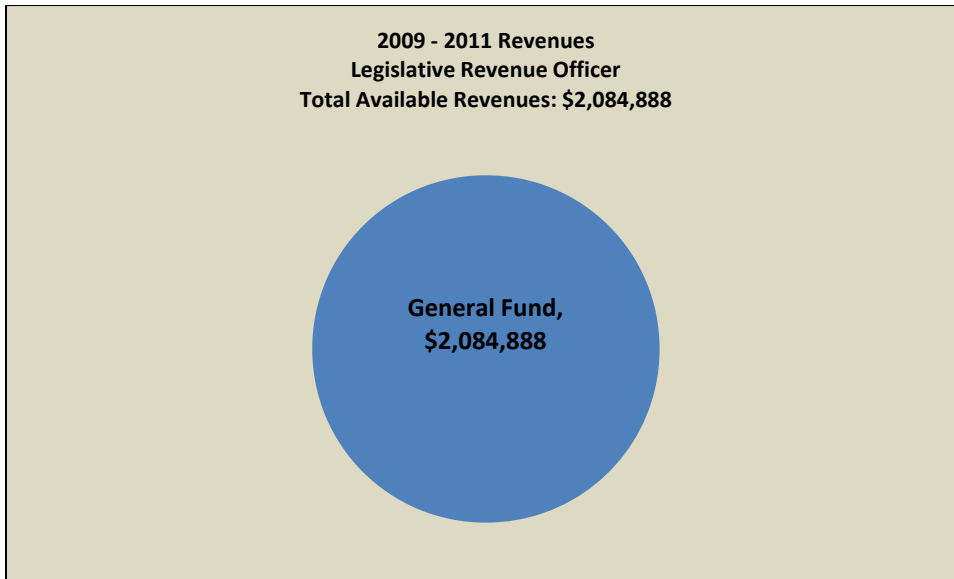


**14200 Legislative Counsel Committee**

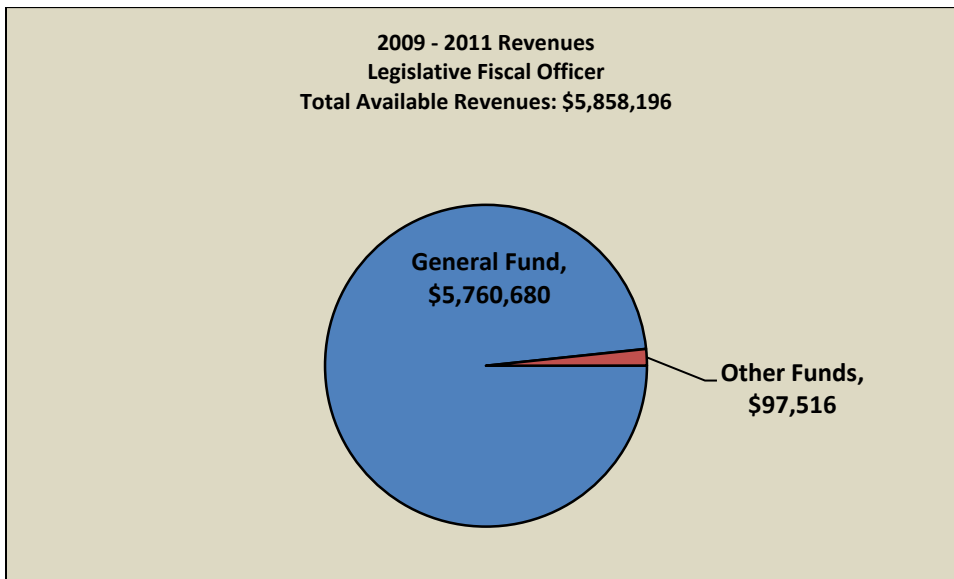

**14400 Legislative Revenue Officer**

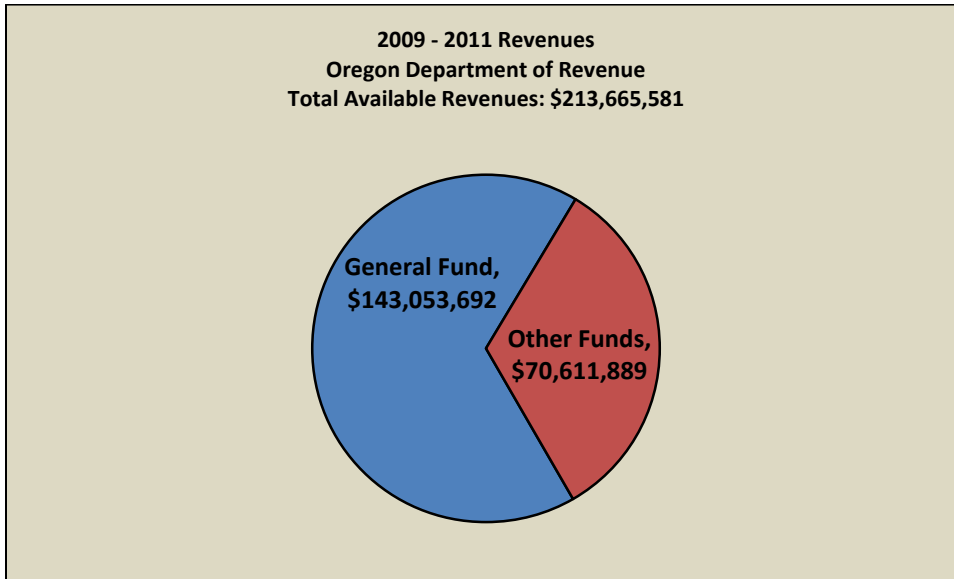


**14500 Legislative Fiscal Officer**

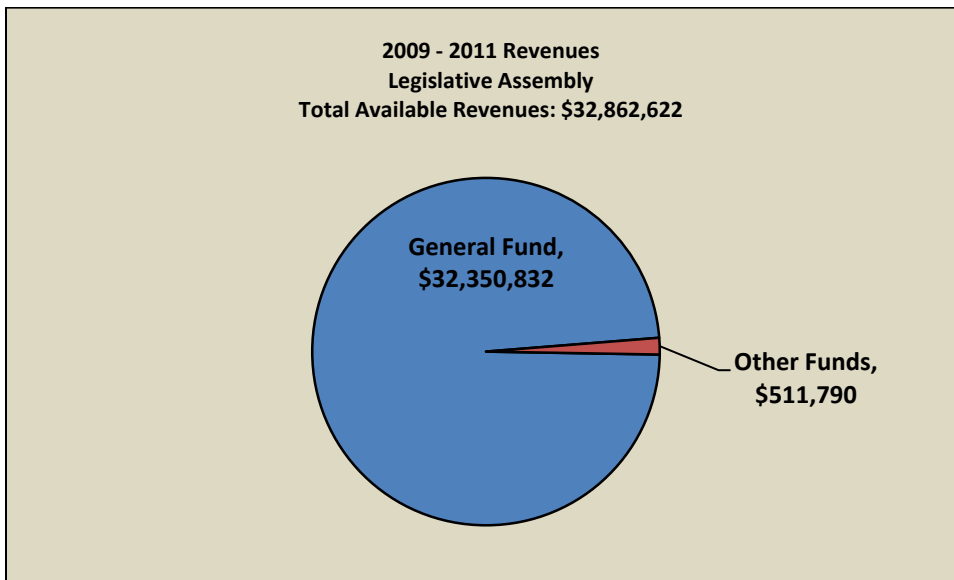

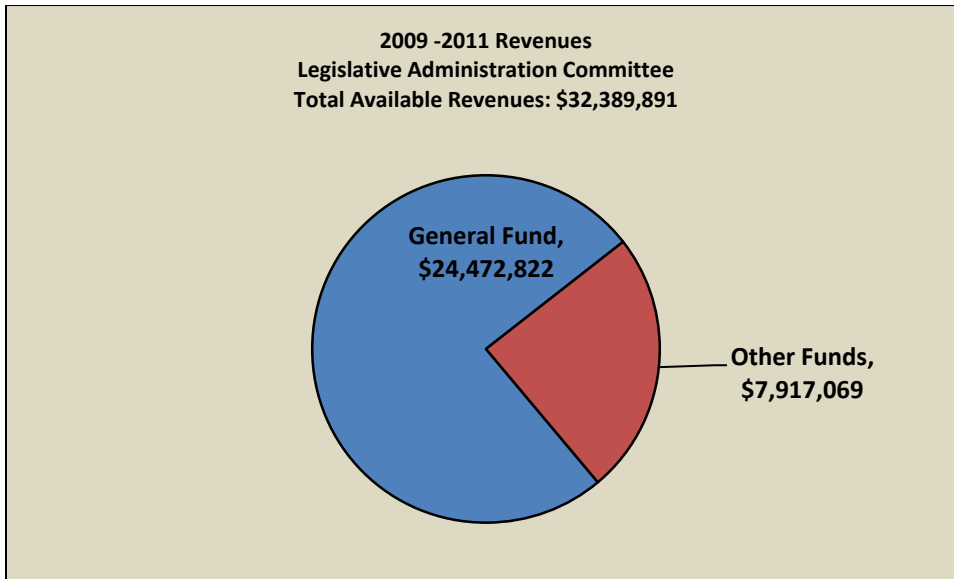

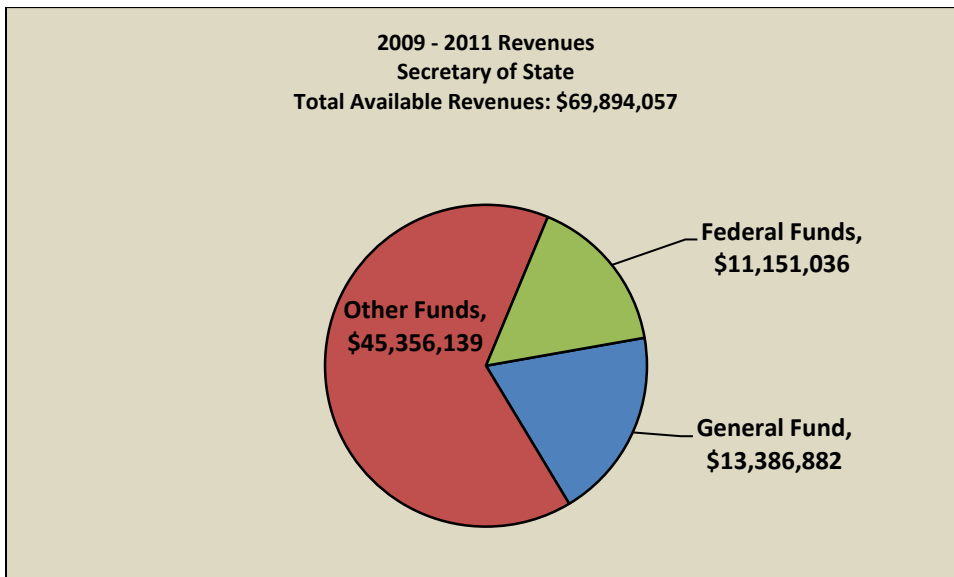

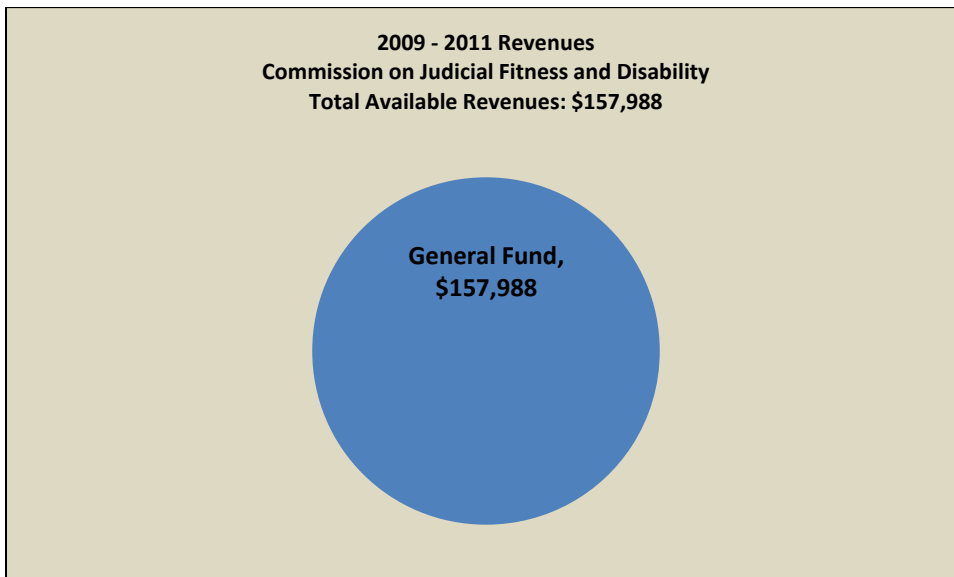

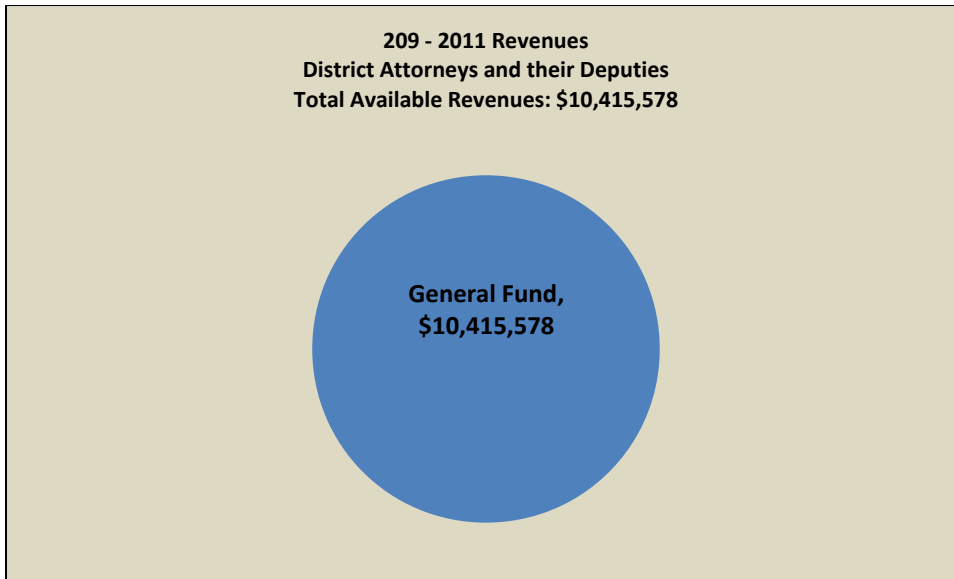


**17500 Judicial Fitness and Disability, Commission on**

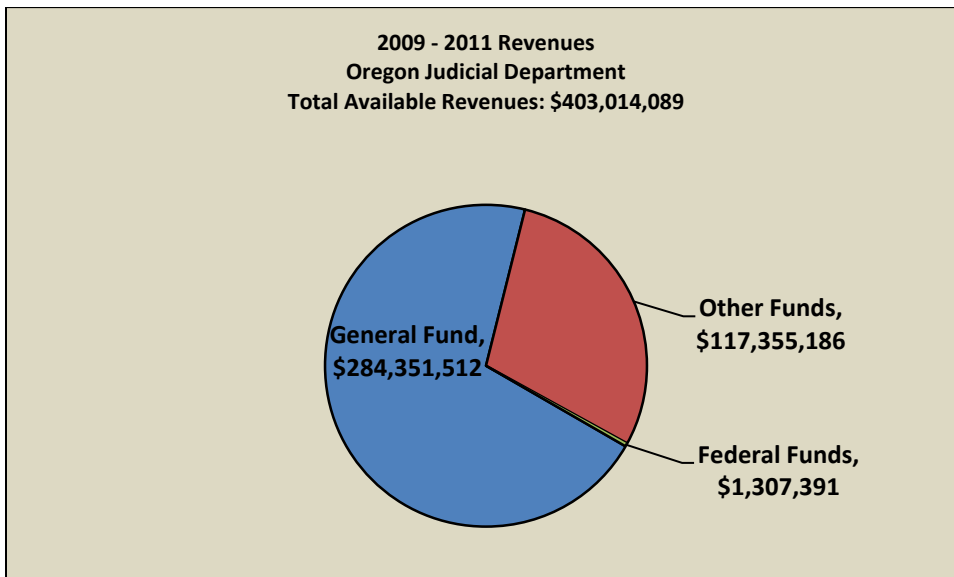

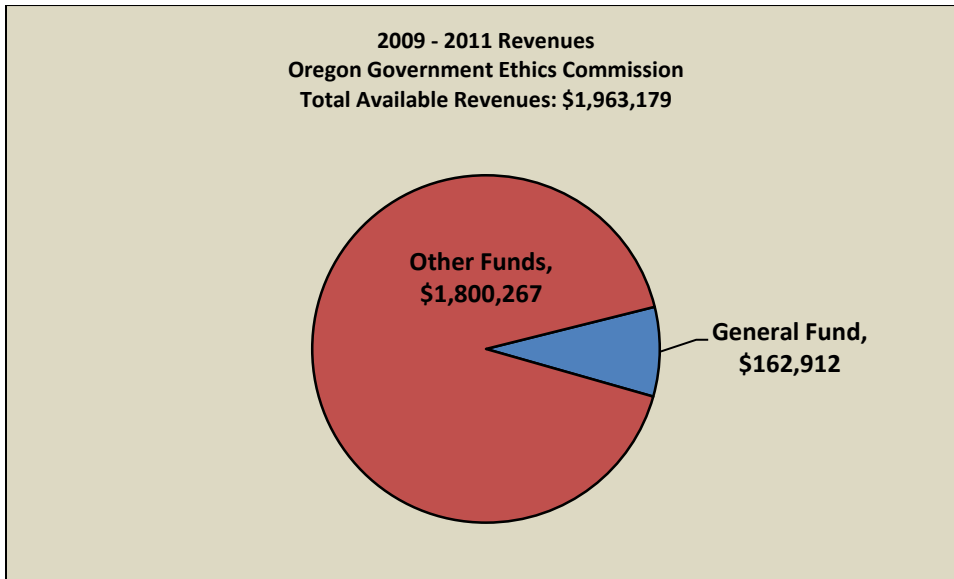

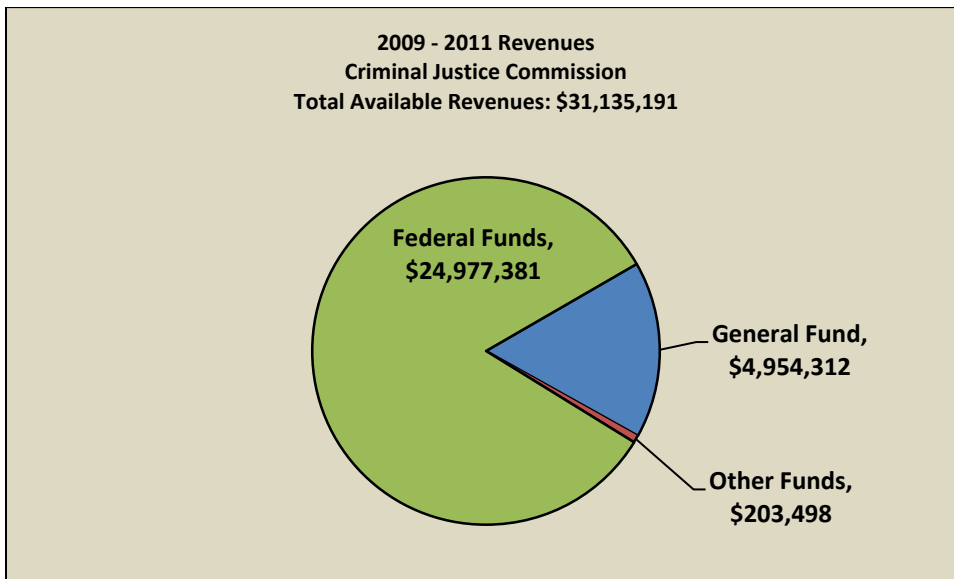

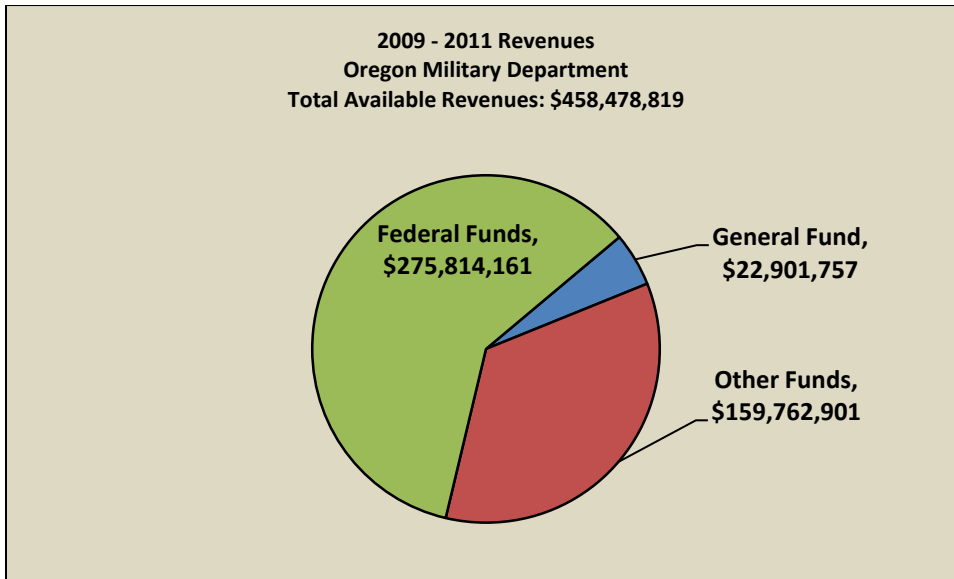


**21300 Criminal Justice Commission, Oregon**

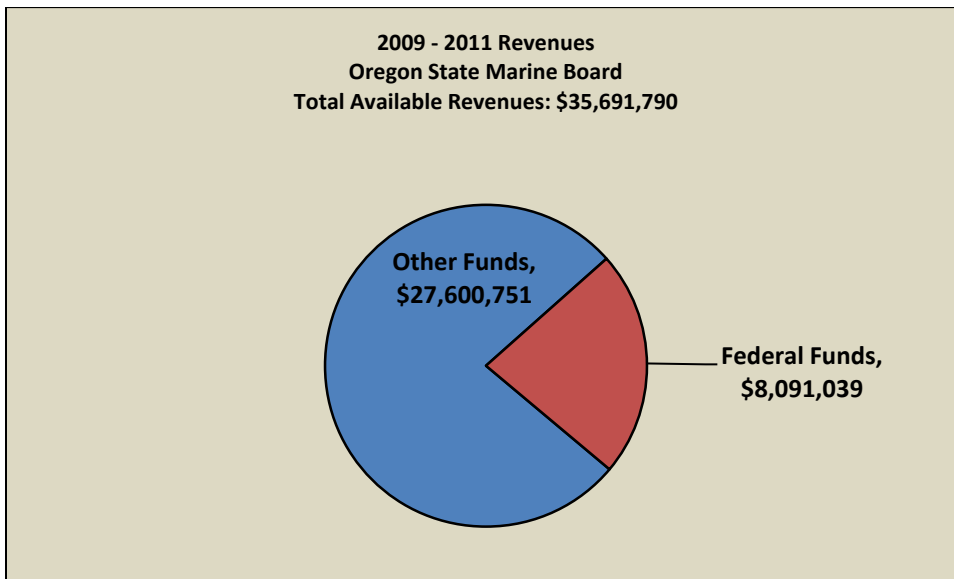

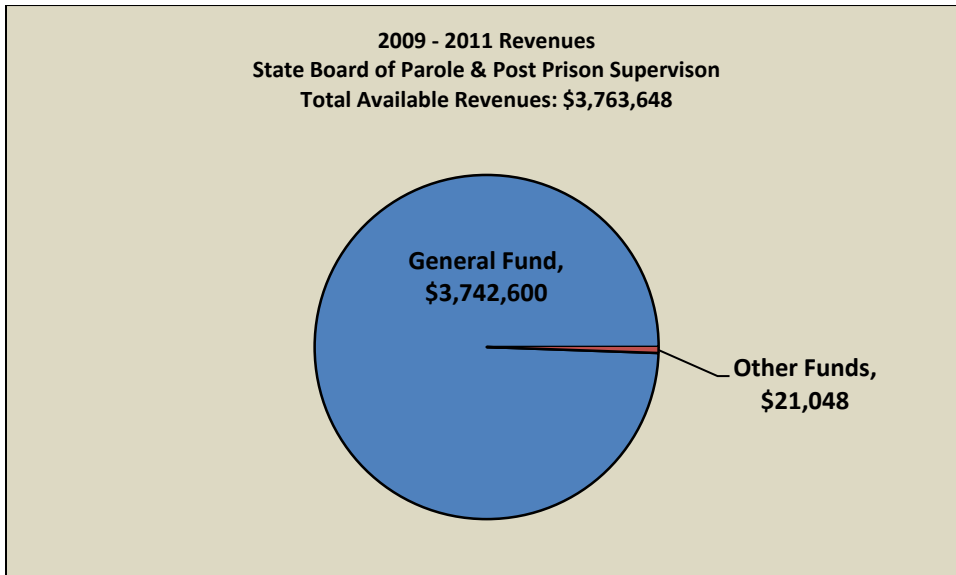

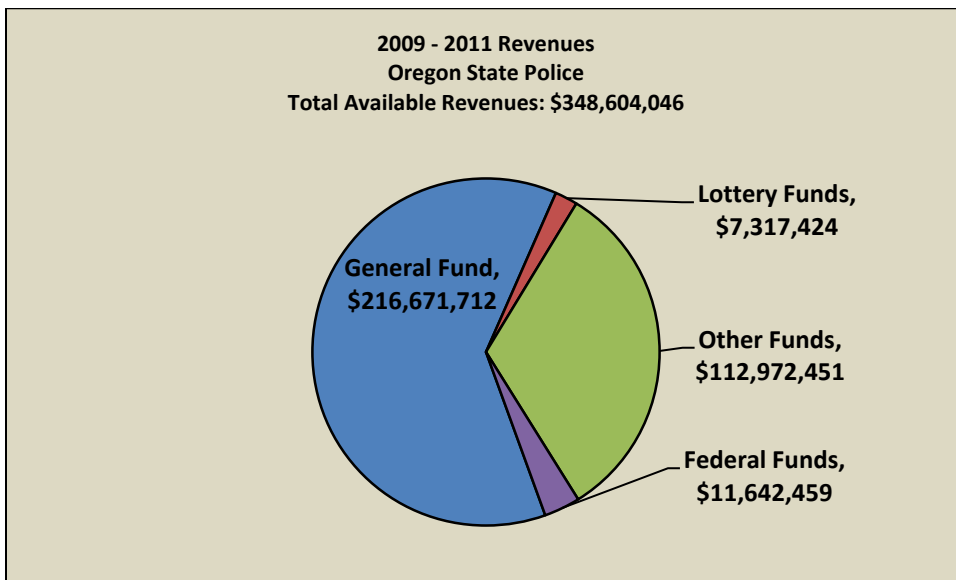

**25500 Parole & Post Prison Supervision, State Board of**

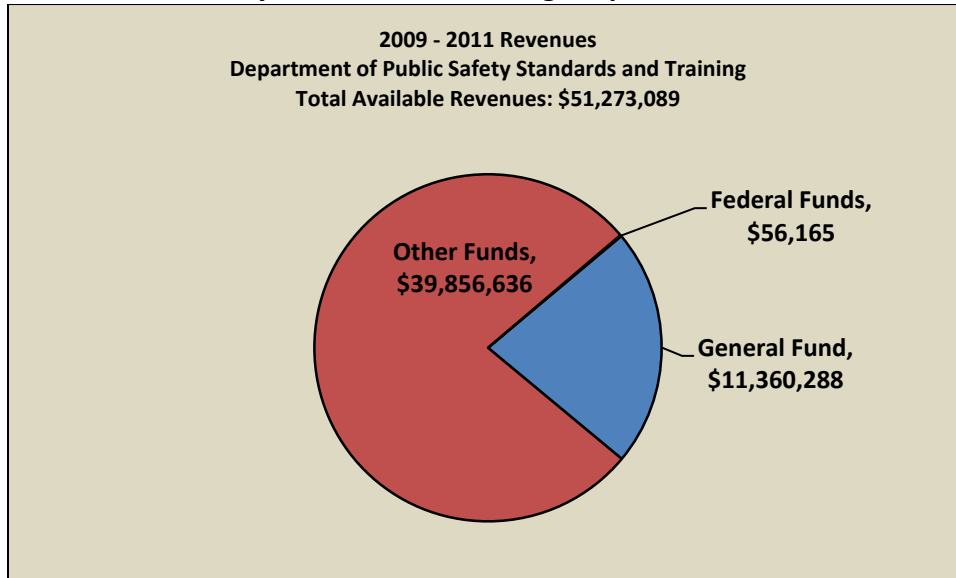

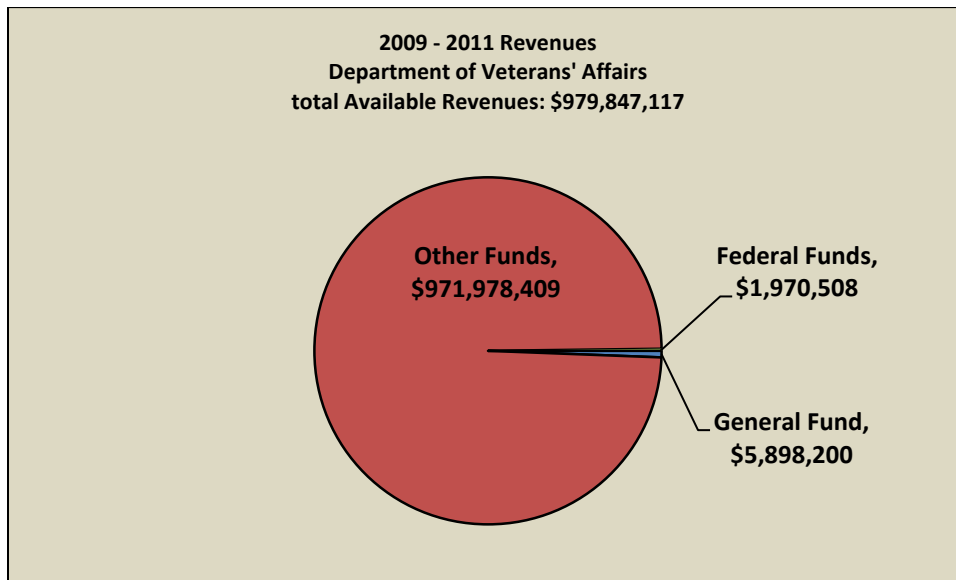

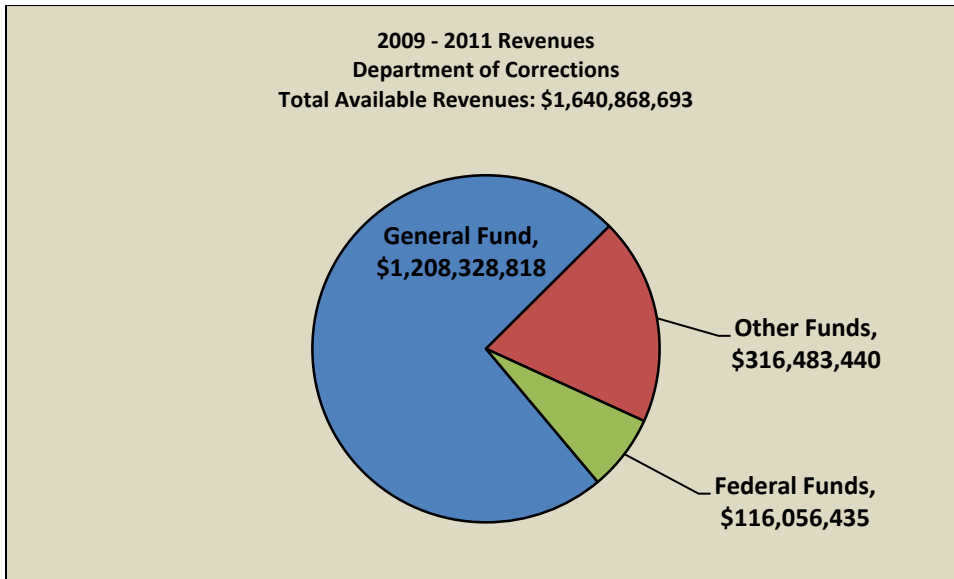

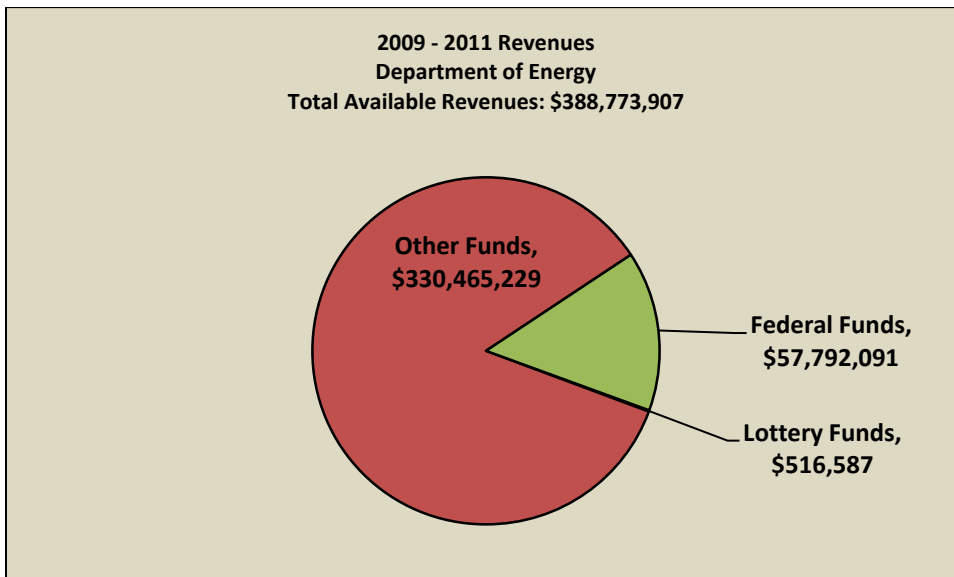

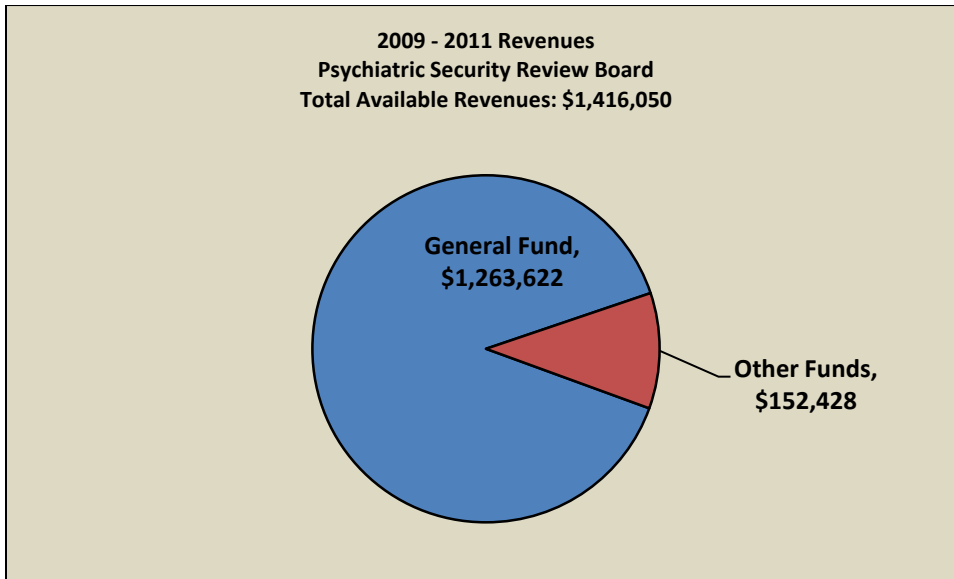


**35000 Columbia River Gorge Commission**

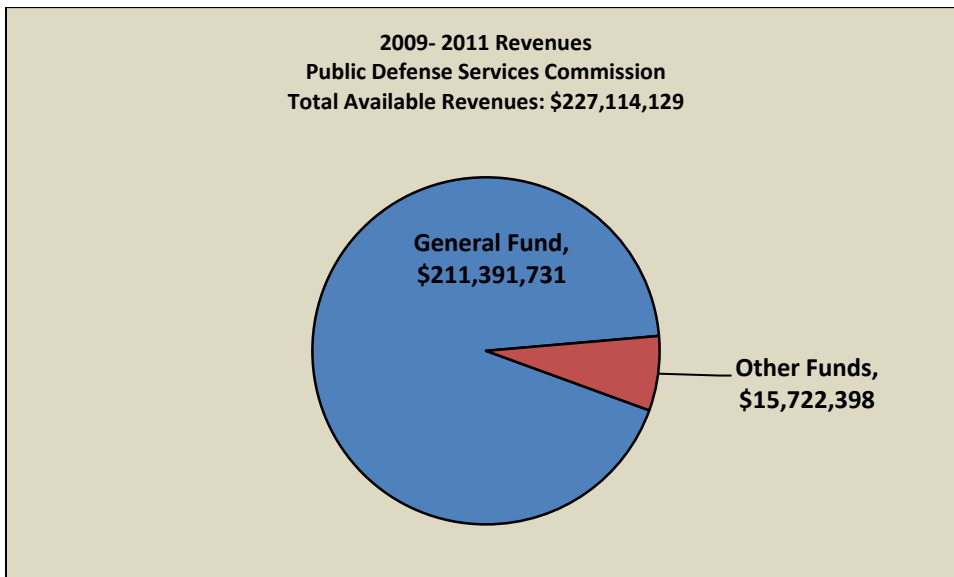

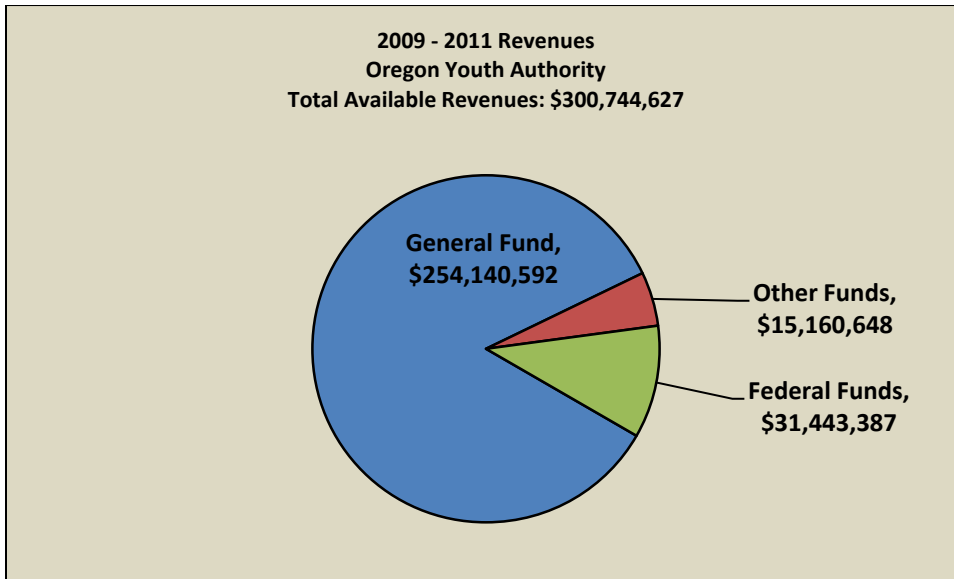

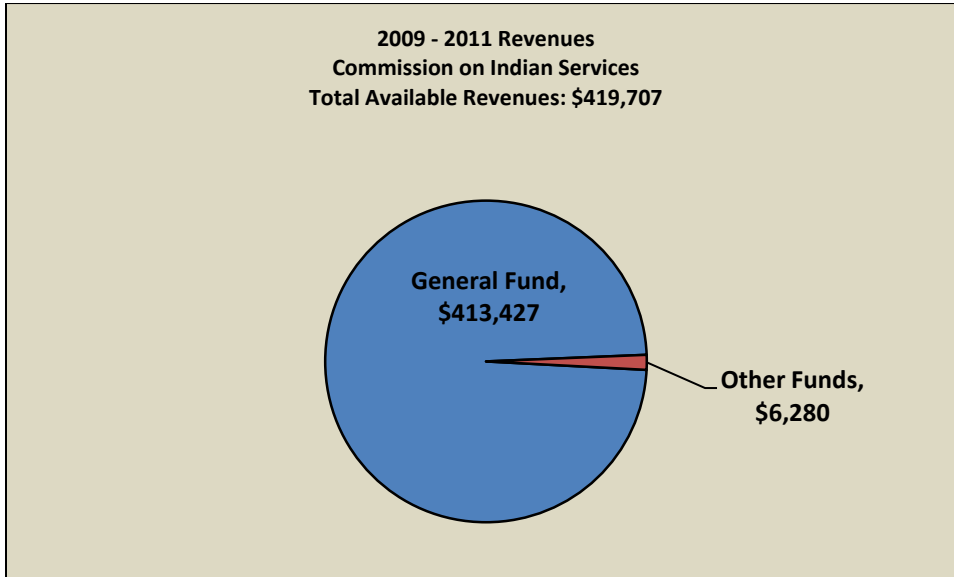

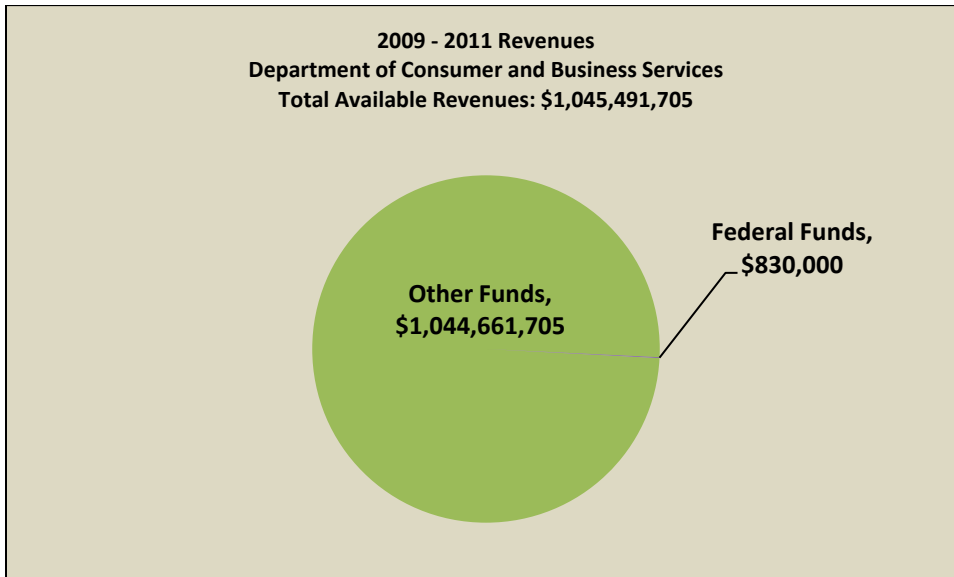

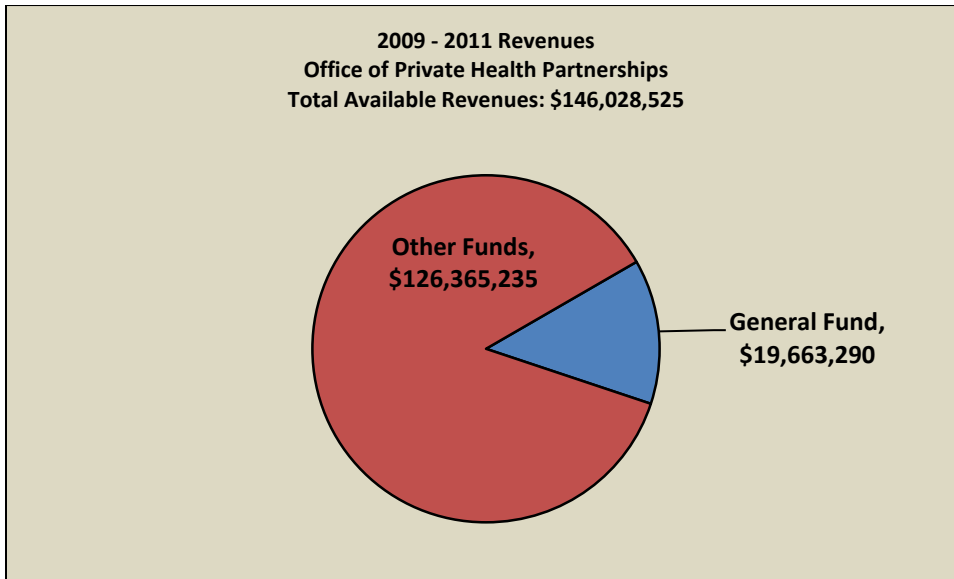

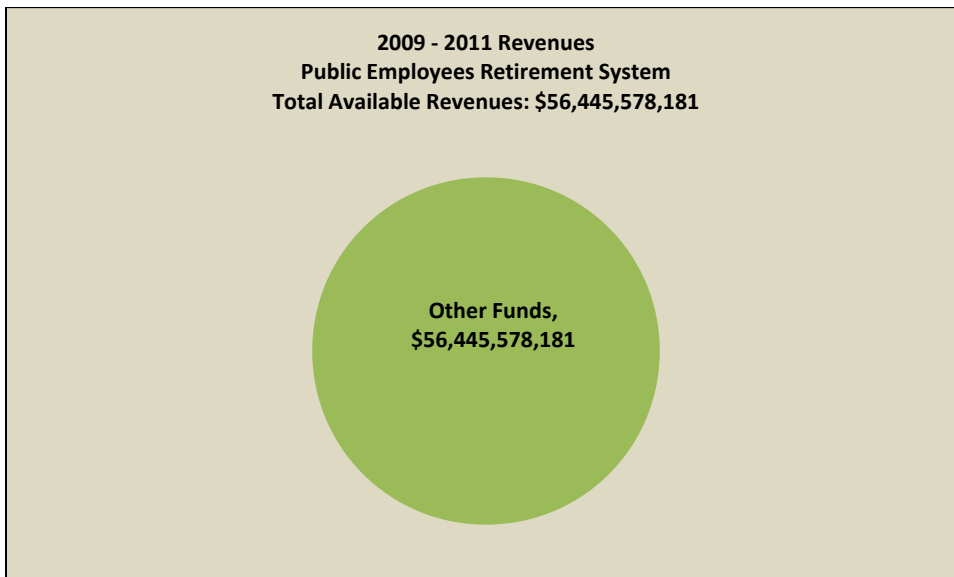

**44200 Office of Private Health Partnerships**

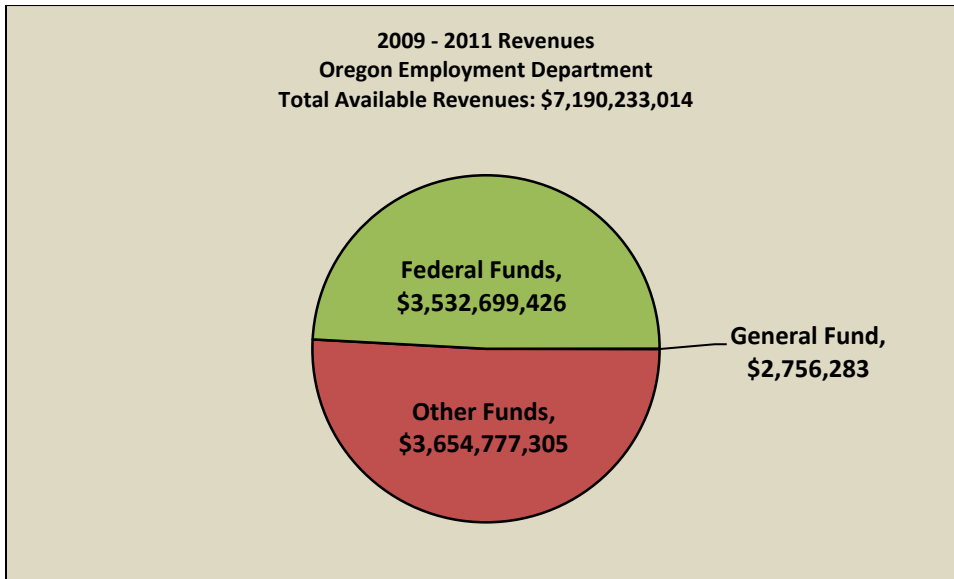


**45900 Public Employees Retirement System, Oregon**

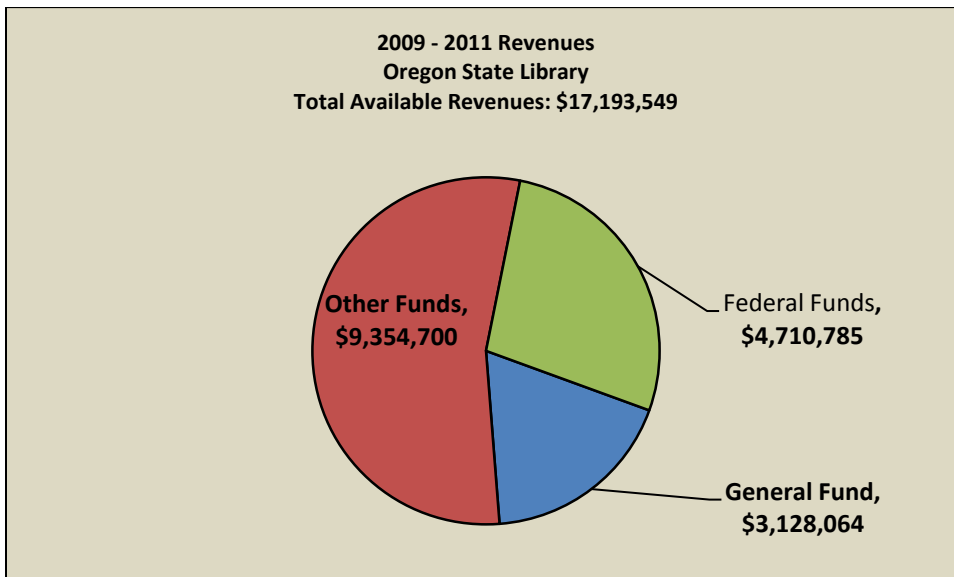

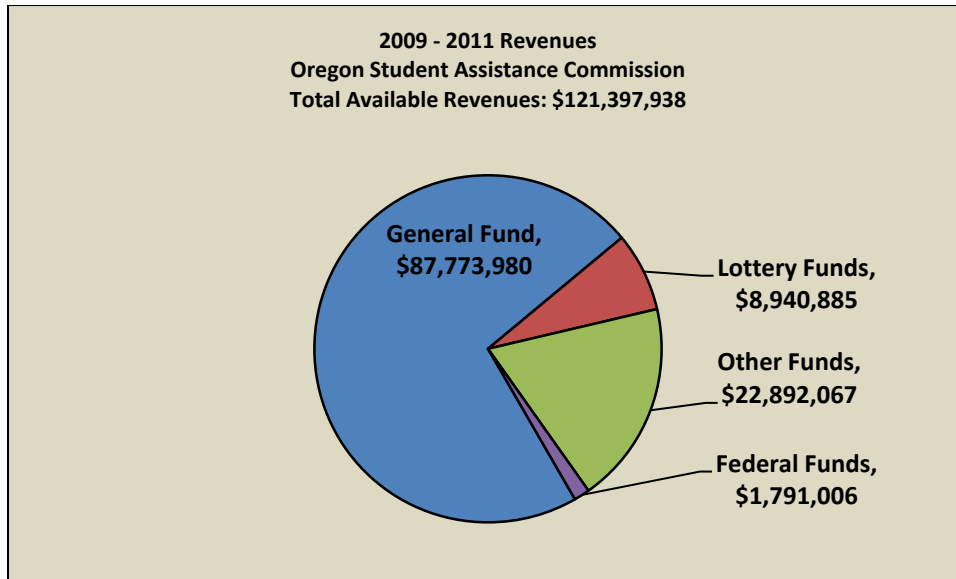

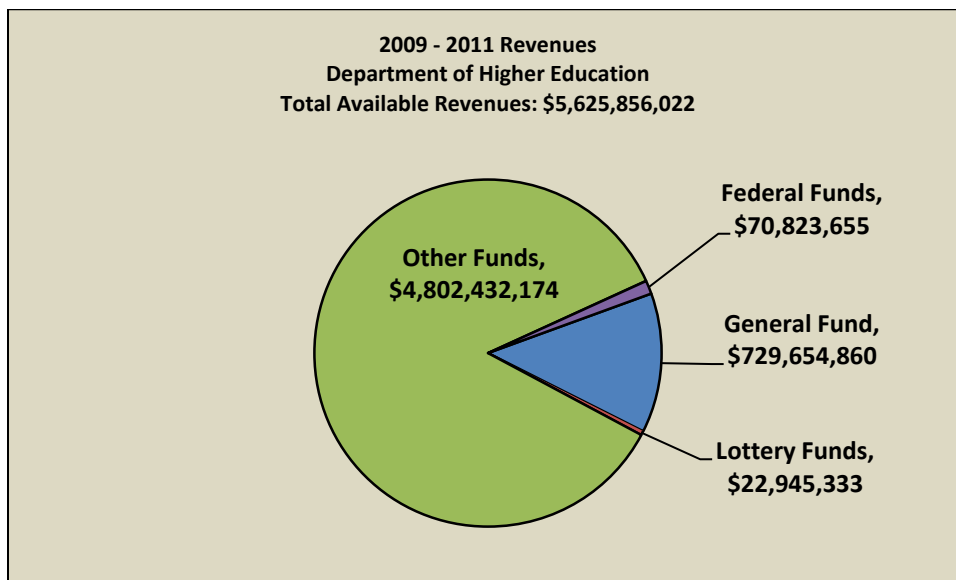

**57500 Student Assistance Commission, Oregon**

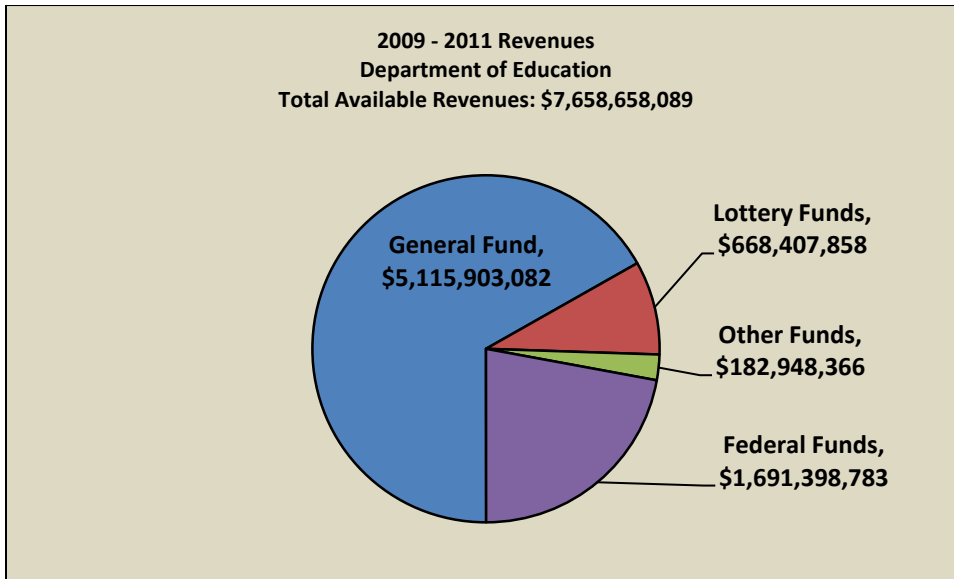


**58000 Higher Education, Dept. of (Oregon University System)**

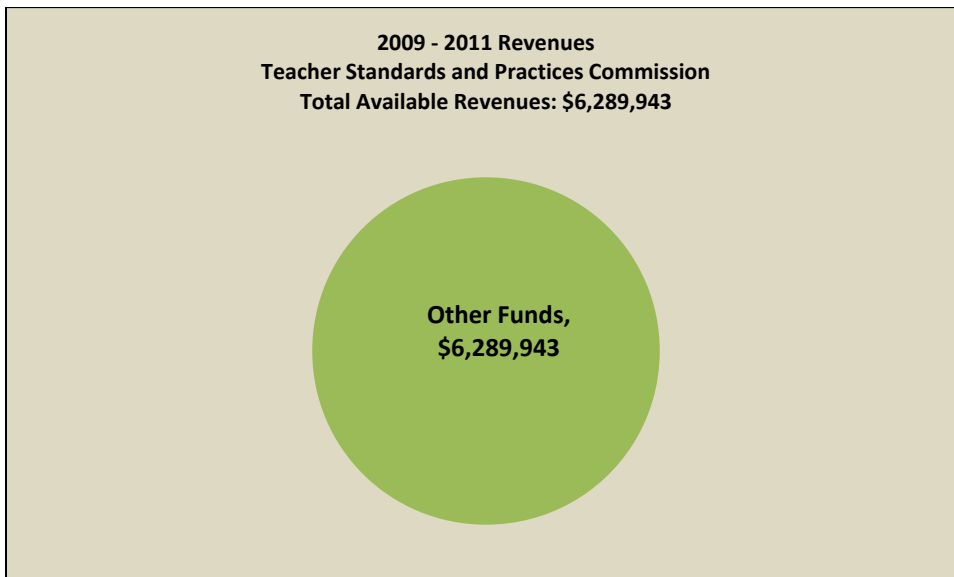

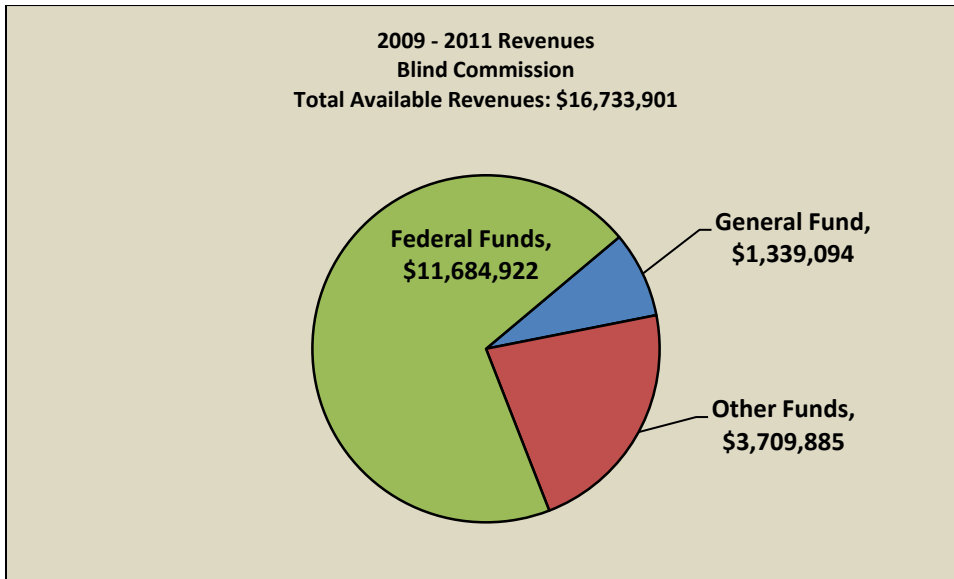


**58400 Teacher Standards & Practices Commission**

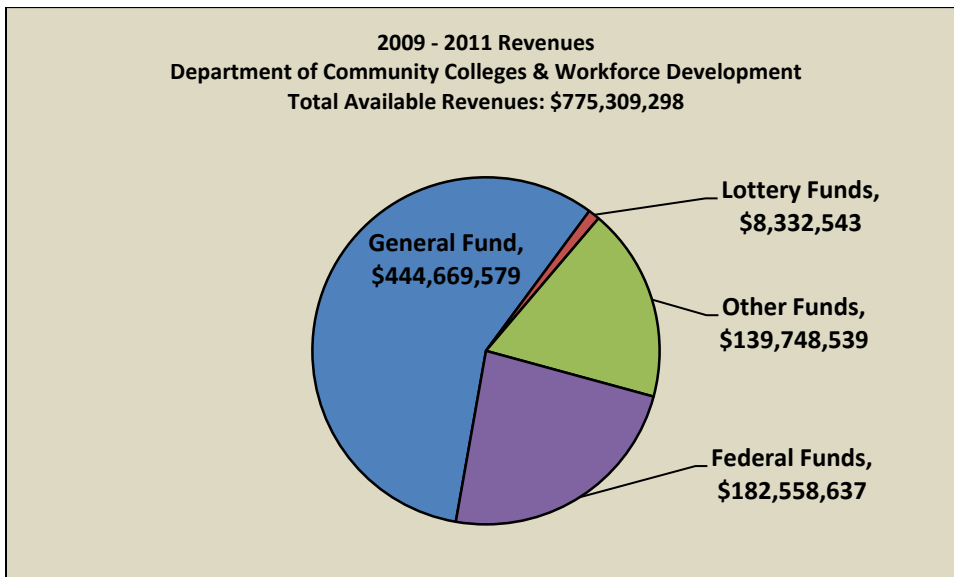

**58500 Blind Commission**

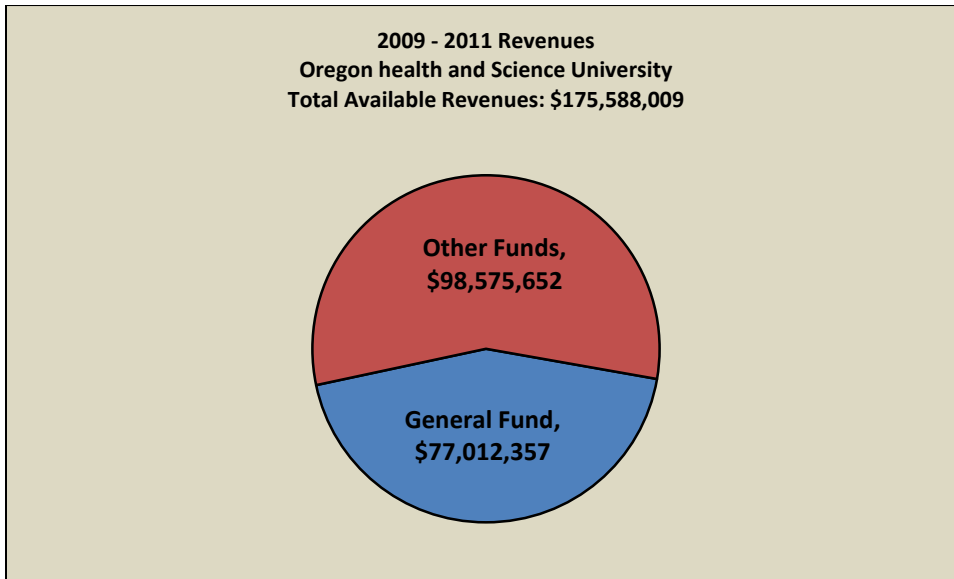

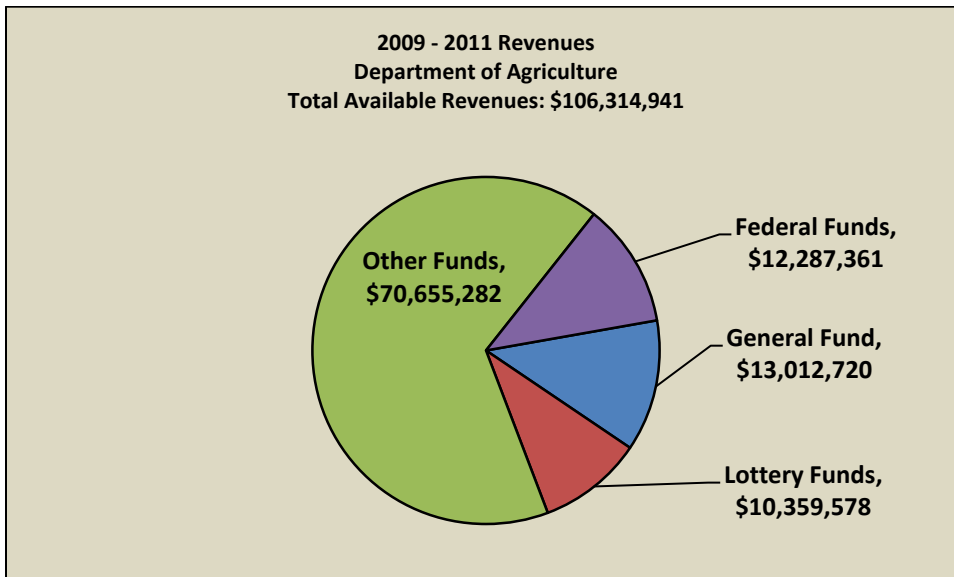

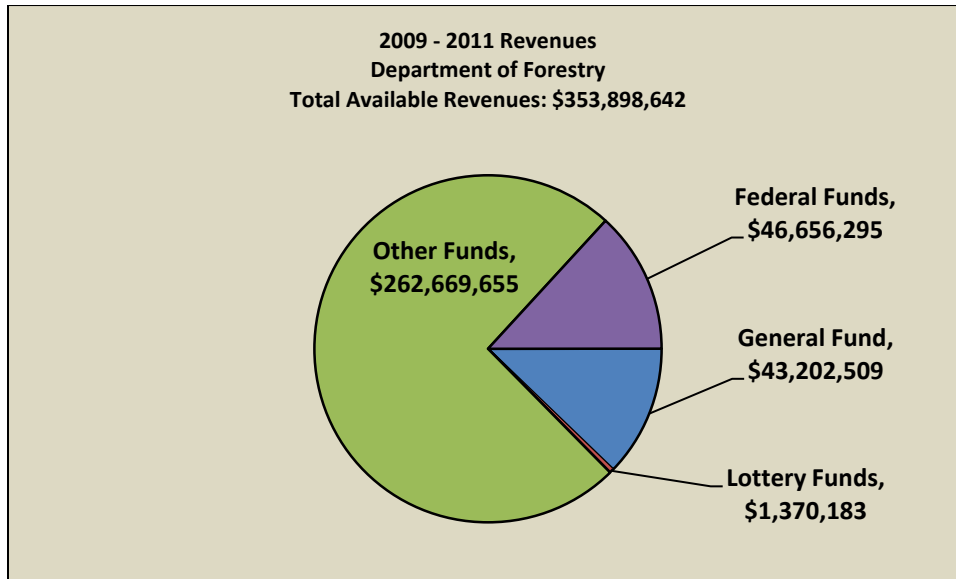

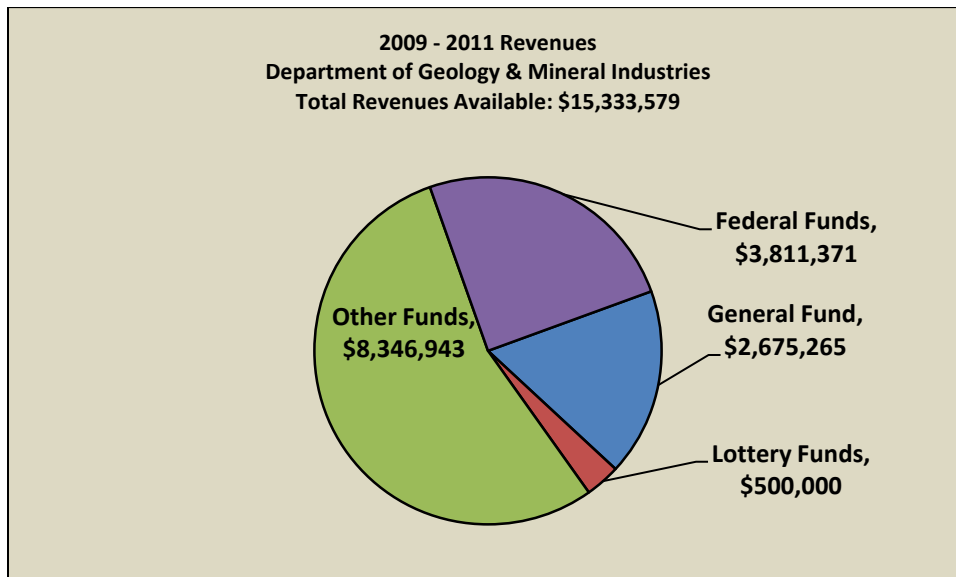

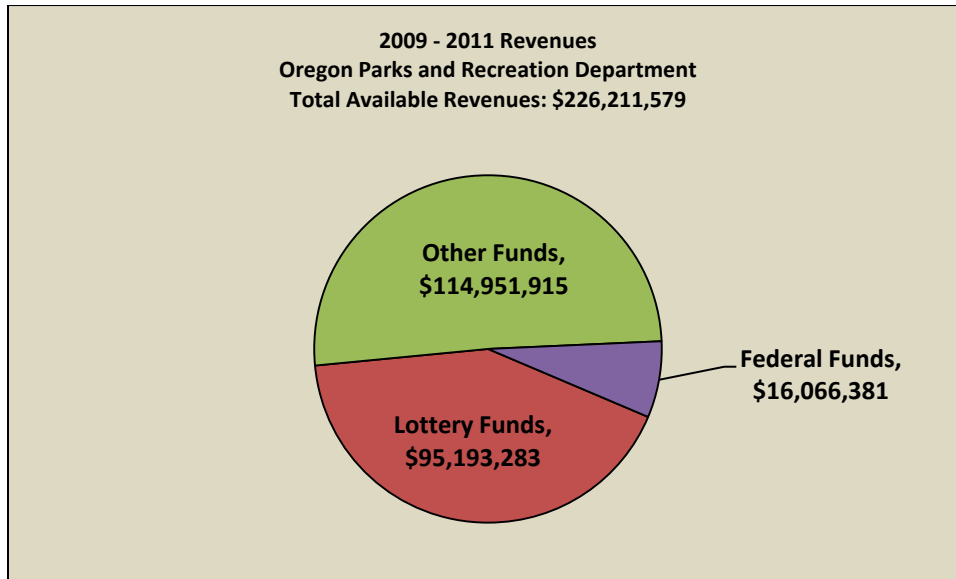

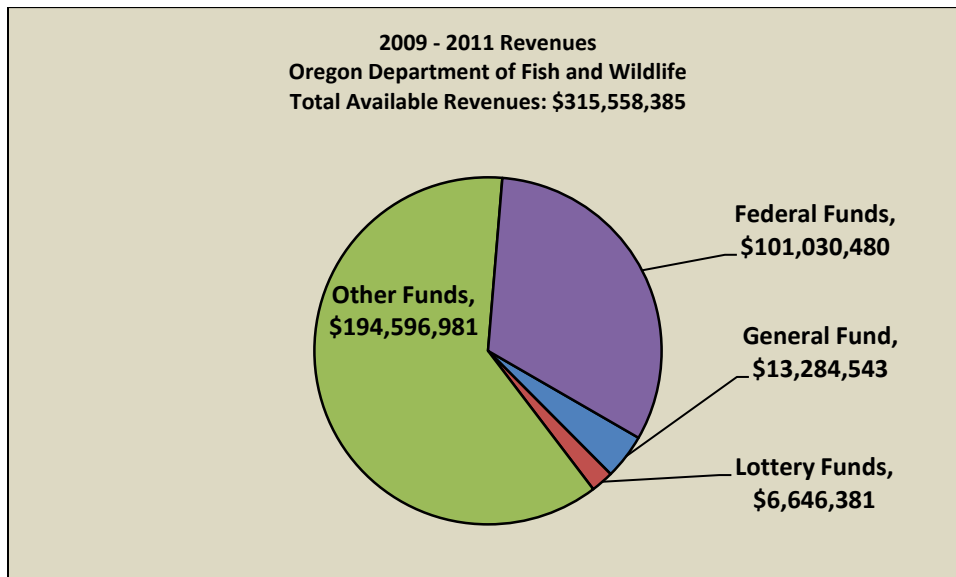

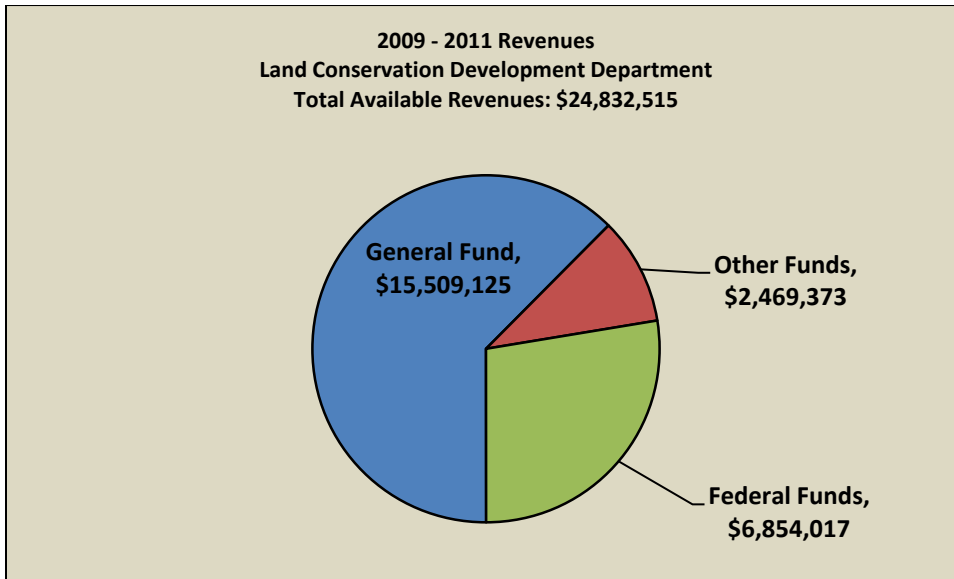

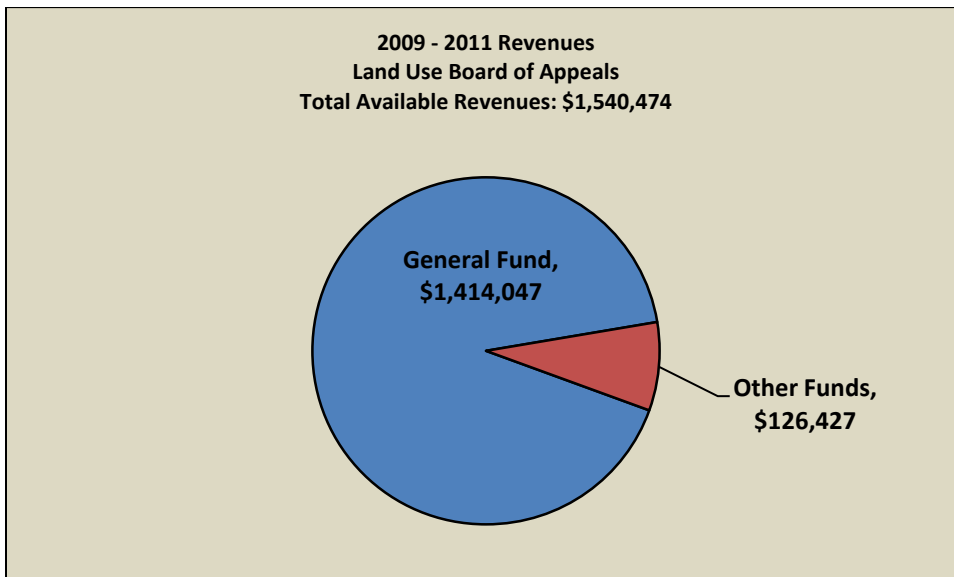

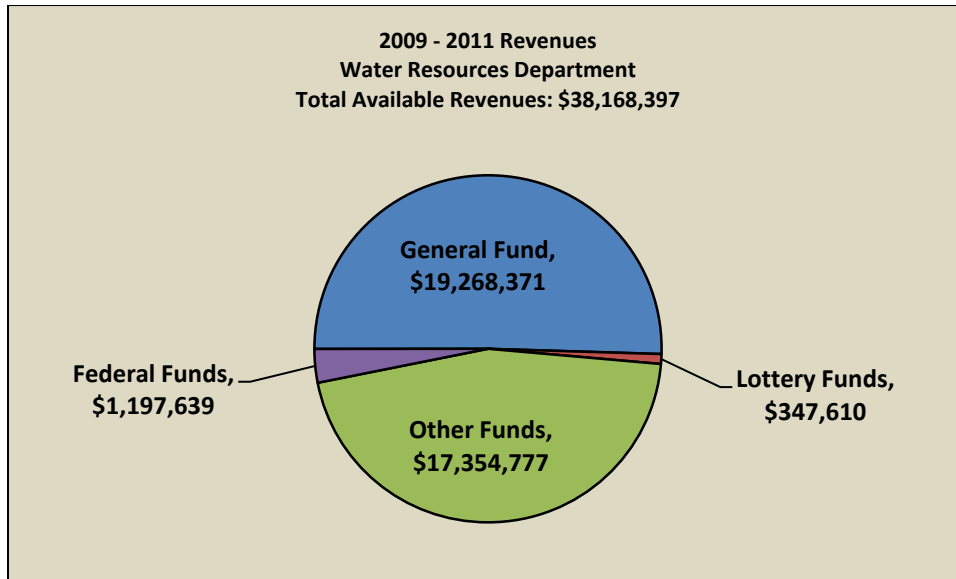

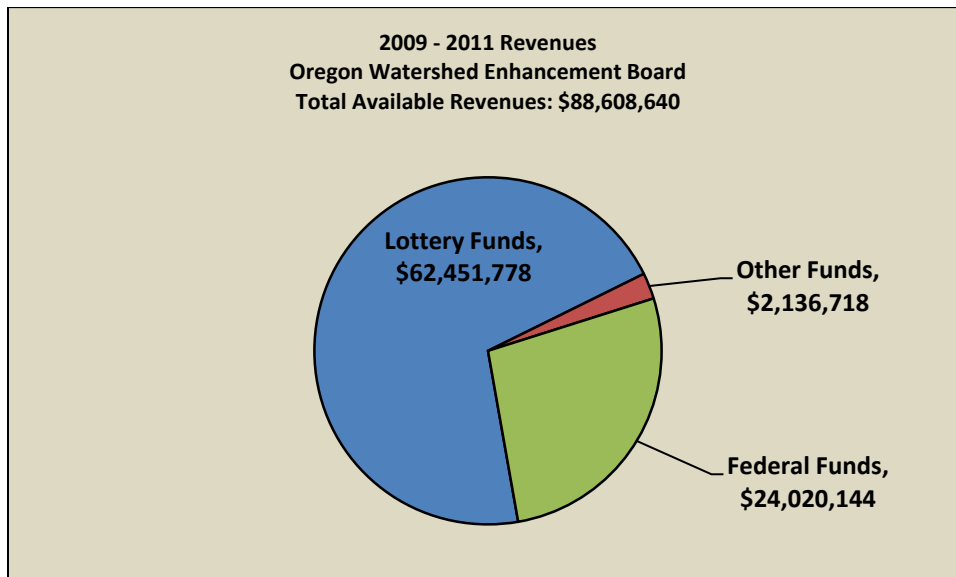

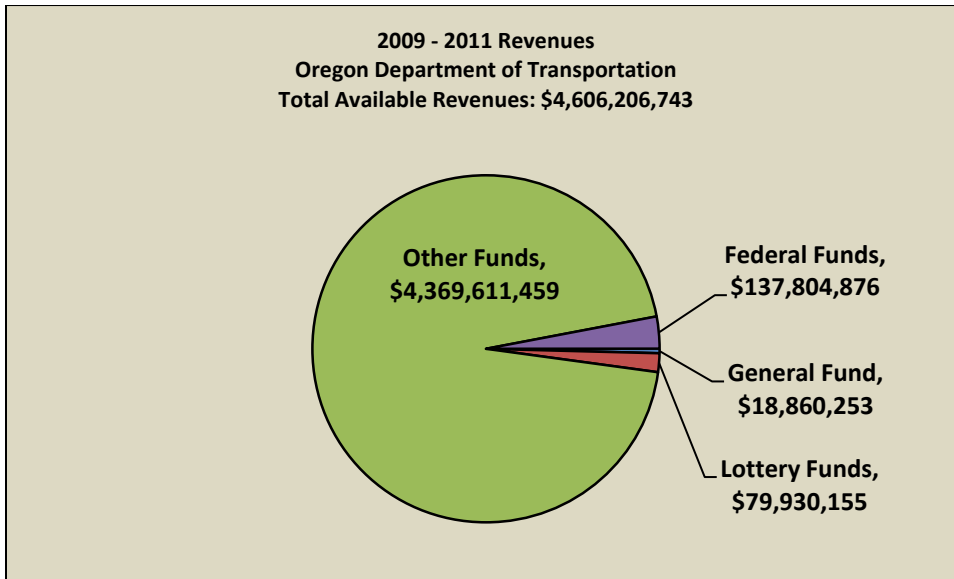


**69100 Watershed Enhancement Board, Oregon**

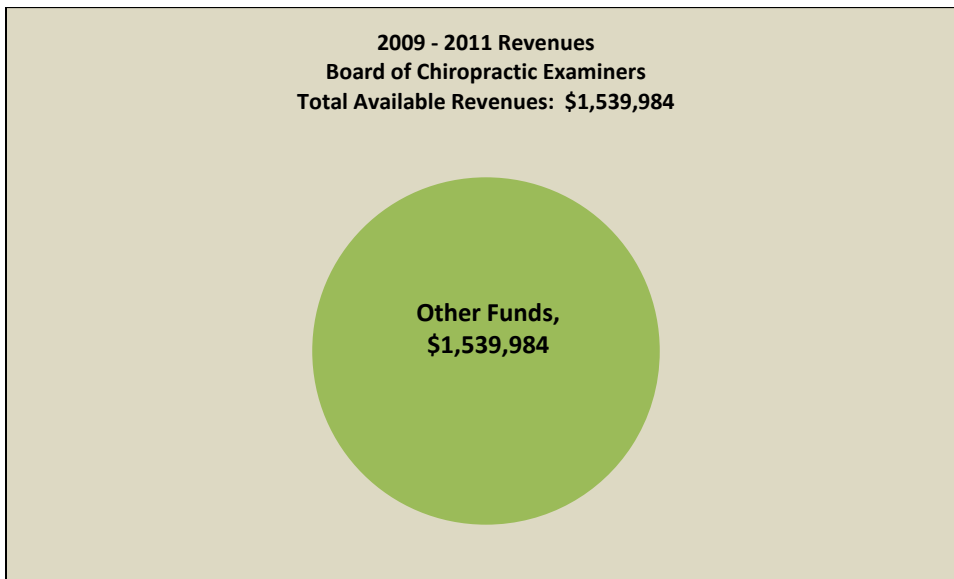

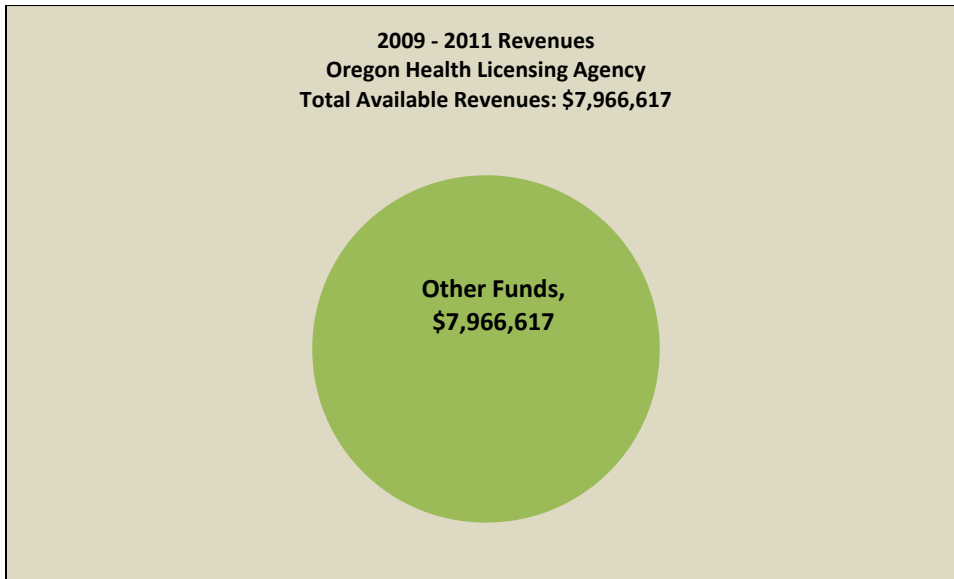

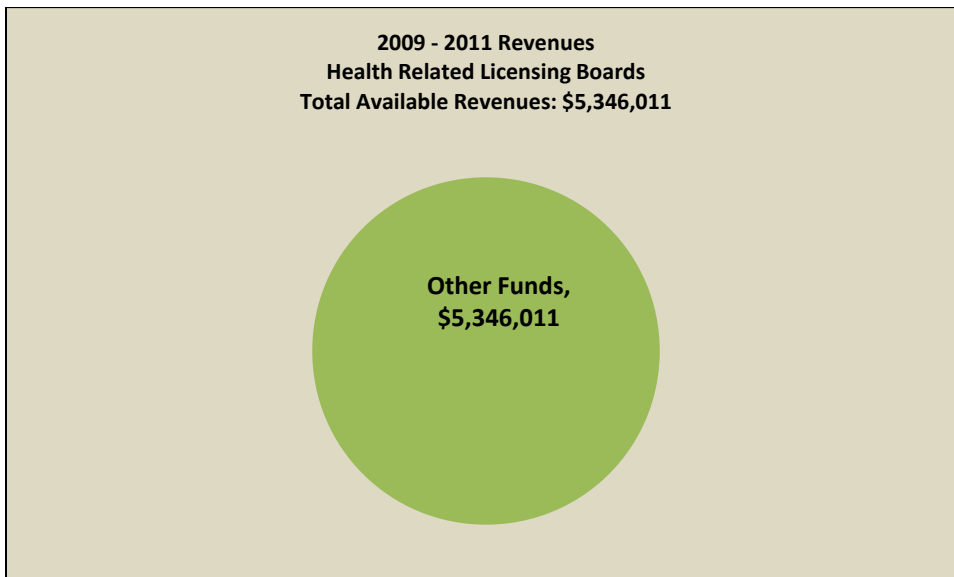

**83100 Oregon Health Licensing Agency**

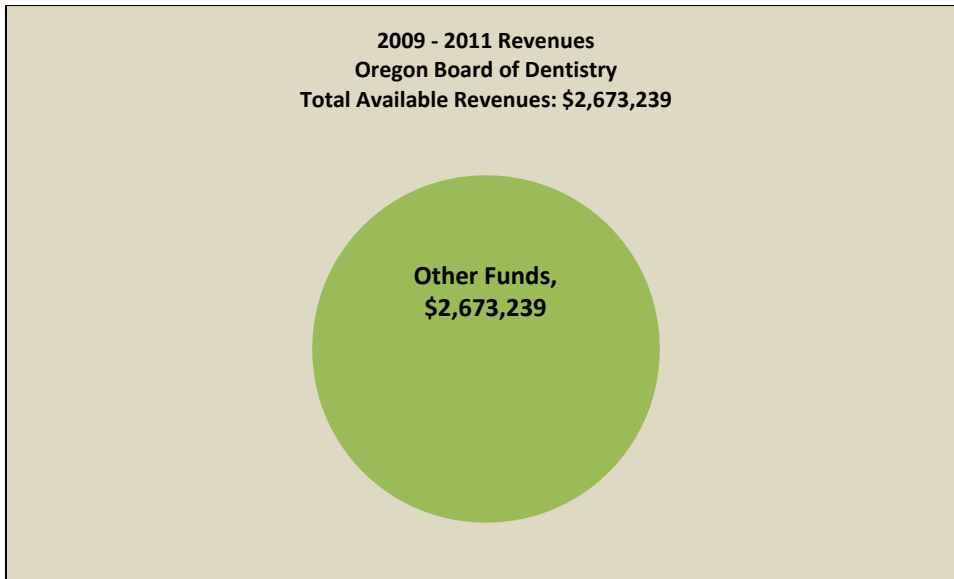


**83300 Health Related Licensing Boards**

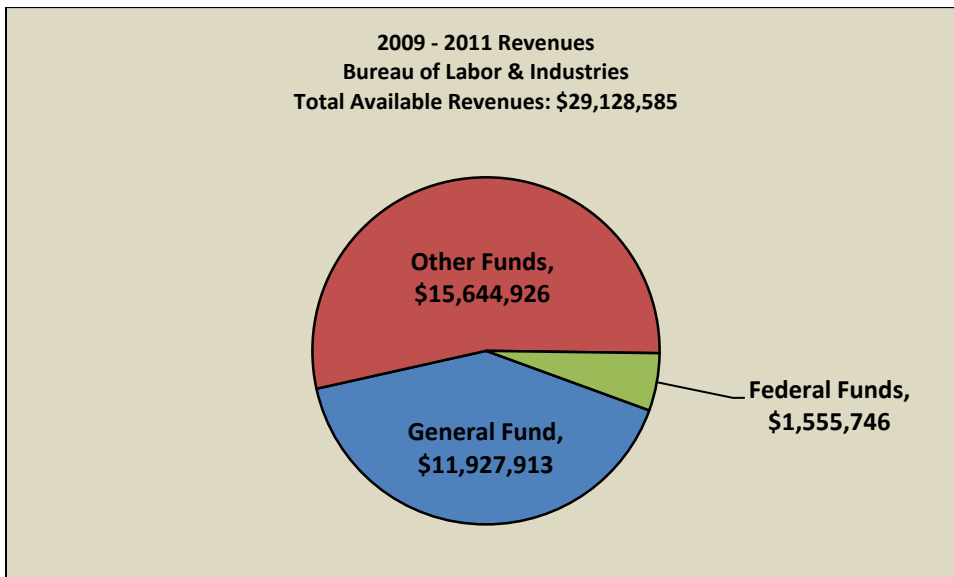

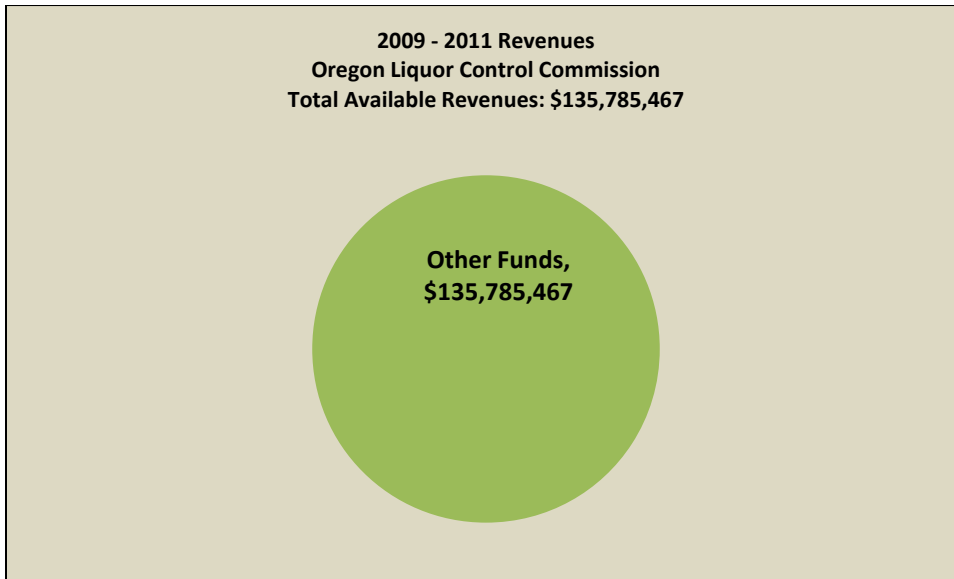

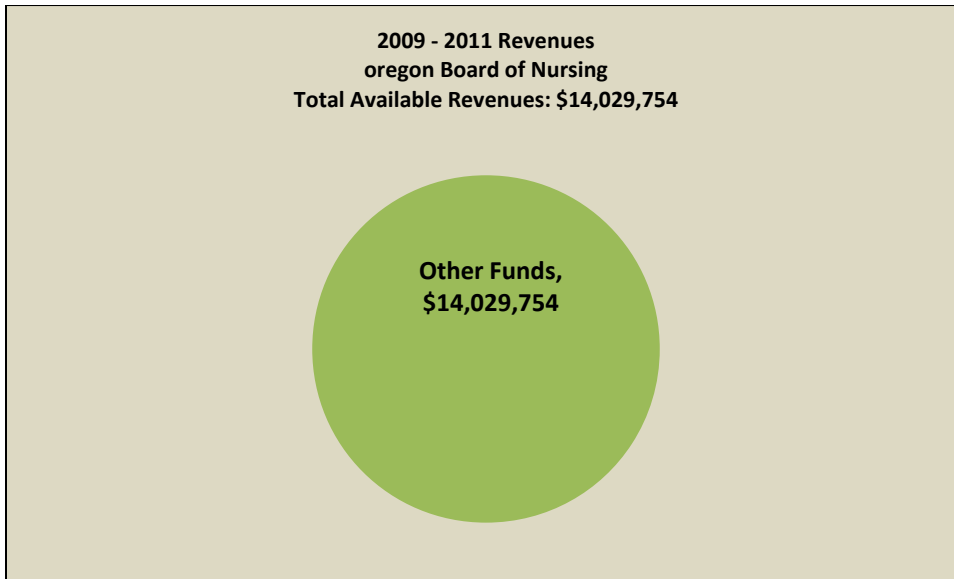

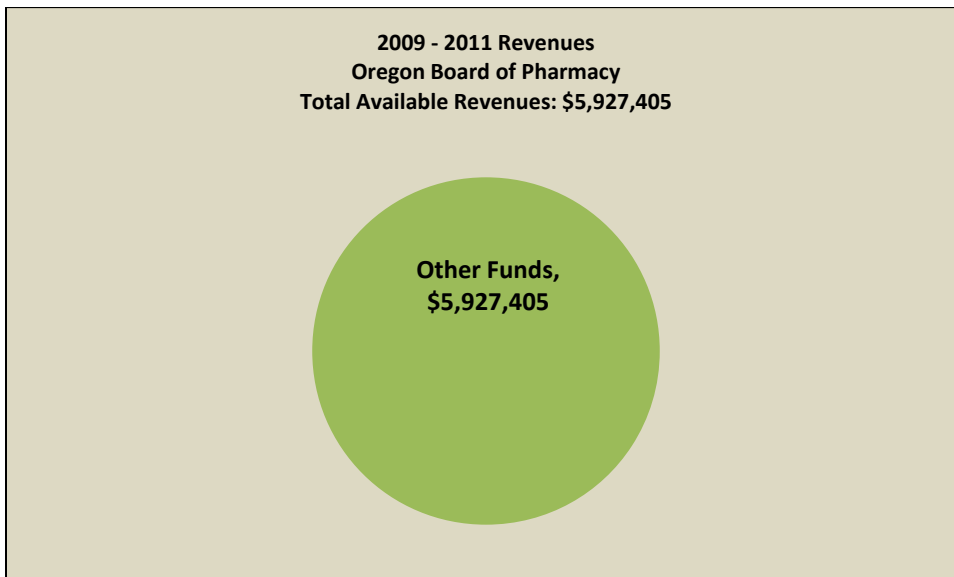

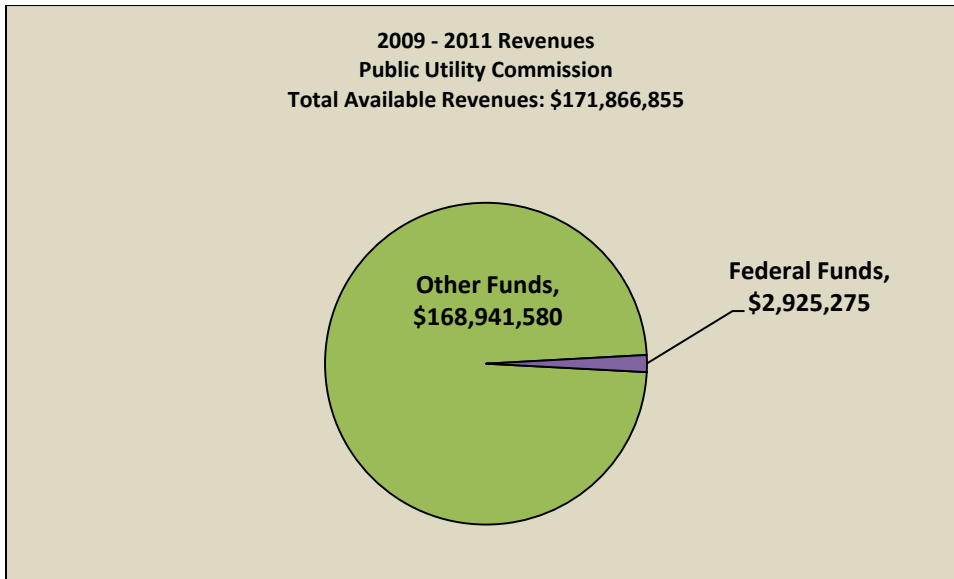

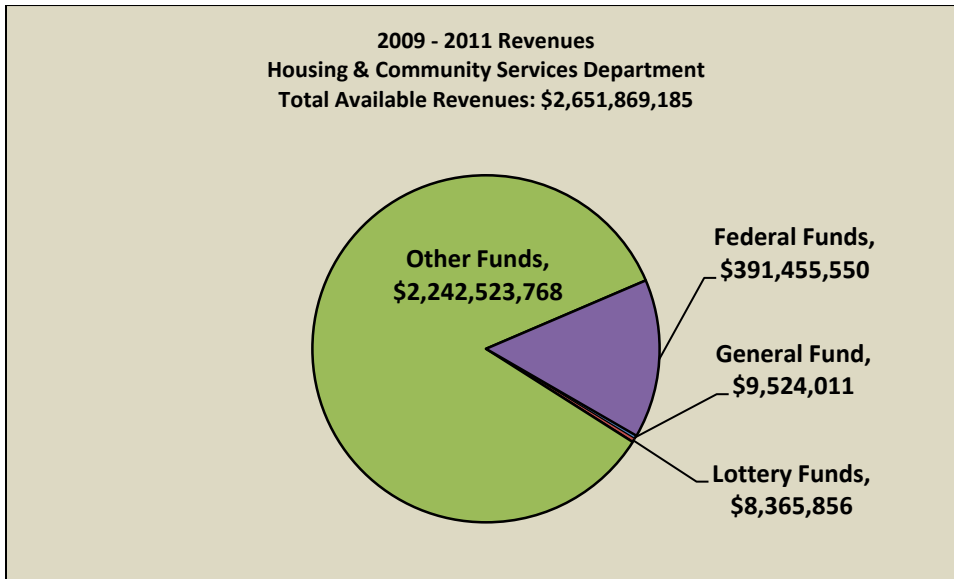
