

# WCB Website - Improvements Made to “Orders” Pages

November 15, 2016

The Board has implemented some improvements to the “Orders” pages of its website. These changes are designed to improve legal research and site performance.

1. Case summary “snippets” have been added. Beginning in early October, the Board has created short summaries on all cases issued. The snippets can be accessed by clicking on the green button to the left of the order. This will give you a brief summary of the case. You can then click on the case name to read the full order. We will continue to create these summaries going forward. Time permitting, we will work on creating summaries for the back catalog of cases.

2. Filter and Search boxes are available on all pages. The “filter” box enables you to look across the data table to isolate specific words or phrases that appear in the table display, including snippets. The “search” box takes you into the full text of the order and will respond to search terms within the body of the orders.

- In the Subject Index tables, we have changed the default to display the three most recent years of cases (2016 to 2014). Previously, the Subject Index was looking across cases going back to 2002, which caused slow loading times. The new default view will enable the pages to load faster. You can still access older cases by selecting previous years.
