2:00 – 2:10 Item 3C Statewide Plug Load Strategy - Update and Discussion

- Reviewed DAS “Plug Load Strategy Work Plan” document
- Reviewed ACEEE “Plug Load Management” memo that was developed specifically for Oregon
- BEEWG agreed that work plan looked good, no concerns at this point, with plans to revisit with Dave/DAS

2:10 – 2:20 Item 3D Energy Efficient Equipment - Update and Discussion

- Discussion that table of products has been re-organized a little BEEWG reviewed at the last meeting, DAS continues to work with ODOE and DEQ to refine table

2:20 – 2:40 Item 4F Improved State Standards for Appliances - Update and Discussion

- Reviewed timeline
- Provided introduction for BEEWG about the appliance standards related legislative concept that ODOE has proposed
- Provided overview of existing data ODOE has gathered to inform study and plan for completing the report
- Discussed potential to conduct a survey to gather stakeholder feedback on the study
- BEEWG thought plan looked good, no specific questions or concerns at this point

2:40 – 3:10 Item 5B Prioritizing Energy Efficiency in Affordable Housing to Reduce Utility Bills - Update

- Review of 7/10 meeting with BPA, ETO
- OHCS provided update that Hatfield Fellow (Alexandra Buylova) is now on board (welcome!) and will be helping to work on this item
- OHCS also expanding a contract with a current consultant to help provide analysis and compilation of this item
- July 30 meeting of Oregon Housing Alliance is coming up, there is interest from the Alliance for BEEWG/agencies to provide an update to this group, as a follow-up to the previous meeting at which BEEWG members present.
- July 30 meeting is a broader group of general Oregon Housing Alliance membership, so it will be a larger audience than the last meeting
- Two most important items to the Housing Alliance are
 - Building codes updates, as related to EO

- Cost analysis tool
- Staff from OHCS, ODOE, and BCD all plan to attend and present at Oregon Housing Alliance meeting on 7/30
- Review of Grid Modernization Laboratory Consortium (GMLC) Affordability Mapping Tool
 - Group thought it contained very interesting information that would fit well within 10 year plan. Mapping based format actually matches with previous discussions of a potential component of the 10 year plan. ODOE to send file to OHCS for further review.
- OHCS/ODOE/PUC to re-convene stakeholder group likely in next 3-4 weeks (3 weeks =August 2, could move to week of August 6), based on schedules. This is currently a tentative meeting.

3:10 – 3:30 Item 5D Evaluation of Energy Resiliency Efforts Discussion

- ODOE and PUC to continue discussions regarding definitions, resources, timeline

3:30 – 3:50 Website Review, Progress Table Review

- Group reviewed progress documentation on website, each agency to provide edits and updates to Blake/ODOE in advance of the August BEEWG meeting
- Website is serving to provide public with a means for easily viewing updates, seems to be working well so far.

3:50 – 4:00 Wrap-up / Next Meeting

- Next meeting is **August 7, 2:00-4:00**
- Second half of August 7 meeting from 3-4 will be a public meeting, and will be opportunity for stakeholders to ask questions and receive updates on items of interest
- Agencies to provide a brief verbal update of progress for each item in the EO, using the existing progress chart (updated) to guide discussion.

Other

- PUC provided brief update on item 5A related to ETO pay-for-performance pilot program.
 - ETO has been performing evaluations on related pilot program to date, and PUC will be able to summarize and provide a brief update to post on BEEWG site to for documentation by the 1/1/2019 deadline.
 - Energy Trust is planning to provide the results of a recent evaluation of their commercial pay-for-performance pilot program at an upcoming Conservation Advisory Council meeting and receive feedback and ideas for improvements from stakeholders
 - Energy Trust is in the early stages of designing a meter based program approach for residential end uses savings
- Item 5C Coordination of Data
 - Interagency scoping meeting in August to be coordinated
- Each agency/agencies that have a near term deliverable or deadline (through 2019) to provide a general timeline and plan for implementation, with intermediate deadlines, for review at next BEEWG meeting.
