1.0 INTRODUCTION

Exhibit Y demonstrates that the application submittal requirements of the Carbon Dioxide Emissions Standard, Oregon Administrative Rule (OAR) 345-021-0010(1)(y), do not apply to the Boardman to Hemingway Transmission Line Project (Project).

2.0 APPLICABLE RULES AND SECOND AMENDED PROJECT ORDER PROVISIONS

2.1 Site Certificate Application Requirements

OAR 345-021-0010(1)(y) provides that Exhibit Y must include the following information regarding carbon dioxide emissions:

If the facility is a base load gas plant, a non-base load power plant, or a nongenerating energy facility that emits carbon dioxide, a statement of the means by which the applicant elects to comply with the applicable carbon dioxide emissions standard under OAR 345-024-0560, 345-024-0600, or 345-024-0630 and information, showing detailed calculations, about the carbon dioxide emissions of the energy facility. The applicant may present the calculations in tabular form. The applicant shall include the following information and calculations:

2.2 Second Amended Project Order Provisions

The Second Amended Project Order provides the following regarding Exhibit Y:

Exhibit Y does not apply, because the proposed facility is not a base load gas plant, a non-base load power plant, or a non-generating energy facility that emits carbon dioxide.

(Second Amended Project Order, Section III(y)).

3.0 ANALYSIS AND CONCLUSION

3.1 Applicability

As set forth in the Second Amended Project Order, the Project does not include a base load gas plant, does not include a non-base load power plant, and will not emit carbon dioxide. Therefore, OAR 345-021-0010(1)(y) is not applicable to the Project, and Exhibit Y does not need to include the carbon dioxide emissions information provide for in that rule.

3.2 Tailoring Rule

The Tailoring Rule and its application to the Project are discussed in Exhibit BB.
